Many people have heard the term "New World Order" in recent years but quite a few are still unsure what it means. the strait after Iran said it would take action if the United States sailed an aircraft carrier through the waterway following an Iranian 10-day military exercise designed to demonstrate its ability to close down the strategic oil passage.

French and Russian Warships Off Syria

The Israeli intelligence asset DEBKAFfile reported on the Jaanuary 9 that the Russian carrier Admiral Kuznetsov anchored at Syria’s Tartus port on the Mediterranean on Sunday and arrived with the destroyer Admiral Chabanenko and frigate Yaroslav Mudry.

“To counter this movement, France consigned an air defense destroyer Forbin to the waters off Tartus,” DEBKAFfile claims.

Reflecting Israel’s propaganda line on Iran and Syria, DEBKAFfile claims that its “military sources report the constant escalation of military tension around Iran and Syria in recent days as not just stemming from the rapid advances Iran is making toward production of a nuclear weapon, but from fears in the West and Israel that Tehran and Damascus are in step over their military plans for the Persian Gulf and Mediterranean sectors.”

Ron Paul: Sanctions First Step Toward War

On Sunday 5th January, presidential candidate Ron Paul said the increasingly severe sanctions imposed on Iran in response to its unsubstantiated nuclear weapons program are steps that will eventually lead to war.

“Sanctions were the first step in our wars against Iraq and Libya, and now more sanctions planned against Syria and Iran are leading down the same destructive path,” he warned.

Iran is “planning to be bombed” and would understandably make the necessary arrangements to counter the threat, even though there is “no evidence whatsoever” that they have enriched weapons grade uranium, Paul noted.

He also pointed out that the United States government directly intervened in Iran’s internal affairs when the CIA overthrew the democratically elected leader Mohammad Mosaddeq and installed the Shah in 1953.

Oil Prices Rising Along with Tensions

Oil prices are beginning to climb as the United States and Iran prepare for war. Brent North Sea crude for delivery in February climbed 14 cents

to \$113.20 a barrel in London on Monday. Continued saber-rattling on both sides have forced oil prices to eight-month highs above the 100 dollars per barrel mark.

In addition to shocking world oil prices, the anticipated attack and Iran after a possible closure of the Strait of Hormuz would dramatically impact the global trade in goods. “If for any reason the strait were closed it would have a huge impact on the economy in the Middle East and would cause a systematic restructuring of flows of goods around the world,” John Manners-Bell, who used to manage European marketing at United Parcel Service Inc., told Bloomberg.

Iranian Missile Base Propaganda

Now that Iran’s Ahmadinejad is visiting Latin America, the discredited rumor that Iran is building intermediate-range missile launch pads at a base on the Paraganá Peninsula in Venezuela has resurfaced. It was initially floated by the German newspaper Die Welt and subsequently boosted by the Jerusalem Post, a documented neocon propaganda operation. The Post posted the story last May.

The story brings to mind the Cuban Missile Crisis in October of 1962.

According to the Die Welt story, the Iranians paid tens of millions in cash for the base that would be used to fire missiles into the United States after Iran is attacked. It was reported that the Revolutionary Guard-controlled engineering group Khatam al-Anbia is helping build the site.

“From Caracas to Miami is about 1,300 miles, maybe a couple hundred more than from the Peninsula – possibly within the range of Iran’s Ashoura medium-range ballistic missile that can cover a distance of over 1,200 miles,” Robert Johnson wrote for Business Insider last week as the story resurfaced on word of Ahmadinejad’s trip.

Business Insider also reported on a paper produced by latlongpacific that includes coordinates for a possible location and “details on the base and missiles that Iran would likely park there, including the Ghadr-100A with a possible range of 3,000 km or about 1,800 miles,” Johnson writes.

“We have no evidence to support this claim and therefore no reason to believe the assertions made in the article are credible,” the State Department said in response to the story.

War in the Middle East now appears imminent as the United States, Britain, the European Union, and Israel put the finishing touches on an embargo on Iran – a de facto declaration of war – and warships steam toward the Persian Gulf.

Consider the following recent developments:

U.S.-Israeli War Game in Persian Gulf

Friday 6th January, the U.S. and Israel announced they plan a massive military exercise in the Persian Gulf in an attempt to confront Iran.

The exercise, dubbed “Austere Challenge 12,” will include the participation of thousands of U.S. and Israeli soldiers and will test multiple air defense systems against incoming missiles and rockets.

On January 2, during its last military exercise, Iran tested its Qader missile, a long-range sea-to-shore missile, and the surface-to-surface Nour missile. The Nour is an “advanced radar-evading, target-seeking, guided and controlled missile and can easily find its target and destroy it,” IRNA reported, quoting 2nd Adm. Seyed Mahmoud Musavi.

Iran Announces New War Game

Rear Admiral Ali Fadavi, naval commander for the Islamic Revolutionary Guards Corps, said on Friday 6th January that Iran will conduct a second military exercise in the Persian Gulf in February. He said the drill would be “different compared to previous exercises held by the IRGC” but provided no additional details.

Iran also launched a military maneuver near its border with Afghanistan on Saturday. Mohammad Pakpour, commander of the Revolutionary Guards’ ground forces, said the “Martyrs of Unity” exercises are “aimed at boosting security along the Iranian borders,” Fars reported.

British Warships Sent

On January 4, the British Royal Navy annoucned it is sending its most advanced warship to the Persian Gulf. The HMS Daring is a Type 45 destroyer that has the world’s most sophisticated naval radar.

Earlier in the week, British Defense Secretary Philip Hammond warned Iran against blocking

Dangers Of X-ray Airport Scanners

Fear has been used to diminish our freedoms and our privacy and used as a basis to wage wars. This should be obvious to everyone, and those who argue that we need the full body scanners to be safe, I direct you to Ben Franklin's quote:

"They, who can give up essential liberty to obtain a little temporary safety, deserve neither liberty nor safety." - Benjamin Franklin.

We have to take off our shoes, belts, give up our nail clippers, endure two hour waits and even invasive body frisking just to get on a plane. Now we are being forced to have full-body x-rays that show us naked. This new step too far, raises a number of questions:

- Are x-ray scanners safe or necessary?
- Is it legal to photograph children naked?
- Should being irradiated be compulsory?



A number of top US scientists believe the new scanners might increase the risk of cancer and DNA mutations. Four professors from the University of California at San Francisco, lead by Dr. John Sedat, wrote a letter to president OBAMA'S science & technology adviser, John Holdren, warning of the potential serious health risks of airport backscatter scanners. As outlined below:

“Our colleagues at UCSF, dermatologists and cancer experts, raise specific important concerns:

- A) The large population of older travelers, >65 years of age, is particularly at risk from the mutagenic effects of the X-rays based on the known biology of melanocyte aging.
- B) A fraction of the female population is especially sensitive to mutagenesis-provoking radiation leading to breast cancer. Notably, because these women, who have defects in DNA repair mechanisms, are particularly prone to cancer, X-ray mammograms are not performed on them. The dose to breast tissue beneath the skin represents a similar risk.
- C) Blood (white blood cells) perfusing the skin is also at risk.
- D) The population of immuno-compromised individuals — HIV and cancer patients are likely to be at risk for cancer induction by the high skin dose.
- E) The risk of radiation emission to children and adolescents does not appear to have been fully evaluated.
- F) The policy towards pregnant women needs to be defined once the theoretical risks to the fetus are determined.
- G) Because of the proximity of the testicles to the skin, this tissue is at risk for sperm mutagenesis.
- H) Have the effects of the radiation on the cornea and thymus been determined?"

We are being asked to take the risk of sperm mutation, skin cancer and breast cancer just to get on a plane. If we don't stop this approach now the

government may start putting these in train and bus stations.

BODY scanners being trialled at a German airport ahead of a planned nationwide roll-out were so inaccurate that the whole scheme has been scrapped, a government official has announced.

The so-called backscatter scanners had an error rate of 54% during their year-long trial at Hamburg Airport, *The Local* reported in September 2011.

The controversial screening devices are similar to the "naked scanners" already in the US at several major airports.

But the German models proved unusable, returning false results triggered by folds in clothing and even by perspiration.

Israel, the most security conscious nation on earth has refused to install these scanners. They claim them to be ineffective compared to profiling and other conventional methods. Rafi Sela, International Security Consultant based in Israel told the NY Times, Nov. 23, 2010: “The problem with the Transportation Security Administration is that it is both the regulator and the operator of airport security. In other words, it is required to regulate itself, which cannot work.

"The decision to use body scanners is one result of this flawed approach. The fact is, such scanners do not provide more protection and they are invasive.

"Israel has a security approach that focuses on threats and vulnerabilities, not body scanners."

The problem is these scanners can't find items which have a low density, such as powder, many liquids or thin plastics. They can't detect any object having the same or lower density than clothing.

They can't detect explosives in the form of a fine powder like that used in the attempted bombing of Flight 253. Neither the backscatter x-ray nor Microwave millimetre-wave scanners could have detected the "Panty Bomber's" explosive in the airport.

They can't detect a stick of C4 hidden in a body cavity, an illegal drug concealment method with a long history of use in the US.

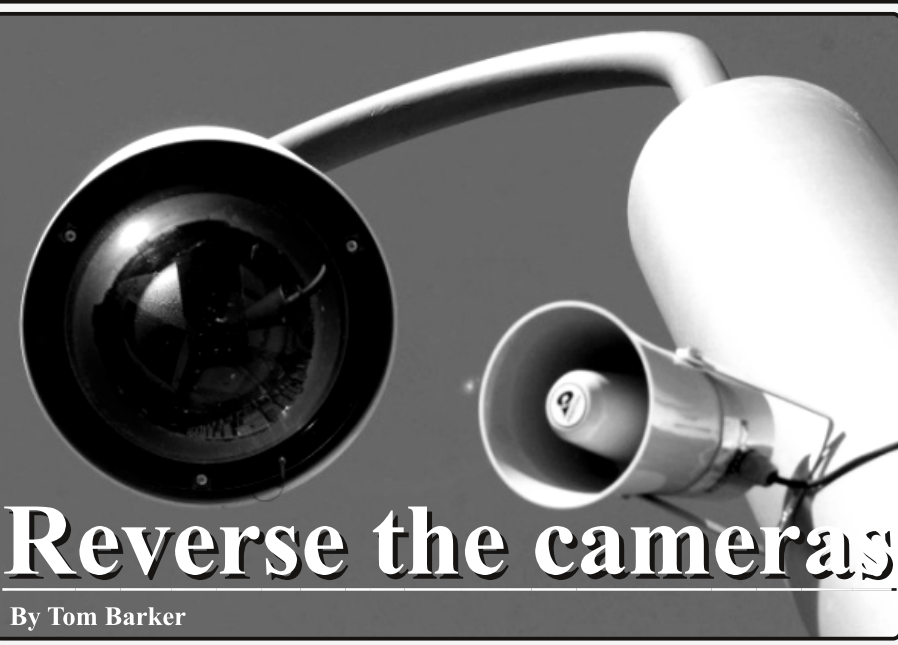
Full body scanners, costing up to \$200K installed, are less able to detect explosives than an explosives sniffing dog, and no better than well trained security agents using a standard pat-down at finding weapons.

Furthermore, it breaches Child Protection and Child Pornography laws. The scans may be viewed by airport personnel and stored. Who can say that the scans won't get leaked just as government officials have done by accident in the past? Have background checks been done on all airport staff considering the child protection issues?

There was a recent case of two Muslim women refusing to be viewed naked at Manchester airport being denied their flight who are now considering suing. More recently Dr. Aguirre who refused to be x-rayed at Manchester after stating his concerns about the radiation causing cancer, was also denied his flight and was escorted out of the airport by police officers, like a common criminal. Dr. Aguirre was forced to fly out of Liverpool airport which doesn't use the controversial scanners.

The US has an "opt-out" policy, giving those worried about the risks the chance to be frisked instead. So why have the UK instituted a compulsory policy? I have read that these X-ray scanners are going to be installed in Dublin Airport. Questions of safety, effectiveness, the legality and the decision to make them compulsory should be raised immediately!

Bring this serious issue to your politicians, citizen groups, friends and family and church. Let us not have government scare tactics force us into allowing a further erosion of our human rights to privacy and bodily integrity. How many terrorists and would-be terrorists have been caught by the increased airport security checks? None! Full Body Scanners are neither necessary nor are they able to prevent terrorist attacks. Even the security experts admit this. So why do we have them. Apart from the fact that as long as civilians are "manning" them, they are illegal searches. (Civilians are NOT permitted in law to carry out strip searches of any kind and even less so under threats. This is an illegal practice).



Reverse the cameras

“Why should I mind being recorded? I have done nothing wrong; so I have nothing to hide”. This is one clichéd response to the question of surveillance. As the street cameras proliferate and technology is rolled out which tracks everywhere you go, logs everything you buy and records what you write and say; isn’t it time to examine the value of this

Privacy and freedom: Most of us don't do anything illegal in the bathroom, but we lock the door and demand privacy. Most of us don't want our bedroom activities recorded. This isn't because we are breaking any laws. At times we just do things that we don't want others to watch and that others shouldn't want to see. Many people don't like being watched while they work; even by those they know. When someone at a family gathering points a camera at us, many of us feel suddenly self-conscious and inhibited. Extraverts are also affected; they immediately begin to play to the camera.

Creativity requires privacy. Not many composers, writers or artists would tolerate people watching the experiments and mistakes involved in their personal creative process. We also require privacy to resolve disagreements. A quiet word with people can solve problems that cannot be subtly addressed in a public forum. If we need to discuss grievances with colleagues in our workplace, we do not want management to eavesdrop. The same applies to our government. Only under a tyranny, are the people not allowed to assemble, criticise the government and plan how to improve things.

Prisoners are deprived of the basic human need for privacy. They are denied access to any solitary, personal time. Hostages and slaves are not allowed to talk in private, in case they conspire to escape. Privacy is a necessary to co-ordinate the defence of our freedoms from potential oppressors. That is why every dictator, establishes a network of spies. The Stasi of East Germany, set up a system where everyone, even family members, reported on each other, and files were amassed on every citizen. In America, Homeland Security announcements, command people to spy on one another. These days, most communication is done electronically; so it can be monitored and filed without us being aware that the envelope has been steamed open.

“I don't mind sacrificing some privacy because cameras keep us safe.” This is the other stock response. It reveals extreme ignorance and naivety. We are paying for the rollout of an incredible system of high-tech surveillance. The potential for abuse is enormous. How can we be absolutely certain that this technology is now, and always will be in the hands of benign organisations that we can trust?

We need our personal information to be kept secure. The recent Irish census gathered information about when we leave for work. Imagine how valuable that data would be to burglars. Government records containing personal information routinely go missing, when CDs and laptops are lost and stolen. Once the monitoring system is fitted, others can access it. The recent phone hacking scandal is the tip of the iceberg. Medical records, bank details, emails, internet activity - none of your sensitive information is safe from hackers or rogue agencies. There are internet sites which allow you to see live streams from “private” security cameras. Google recently announced it's new “privacy policy”; which basically points out that you no longer have any.

So how much protection does the end of privacy afford? According to numerous studies conducted in England, the most heavily surveilled state in the world, cameras have no significant impact on crime rates! If this sounds like an incredulous statement, please refer to links under CASE AGAINST tab, at www.no-cctv.org.uk.

“But what about the terrorists?” they scream. Cameras cannot protect us from attack, but surely

they can provide key information after the event. CCTV should have provided irrefutable evidence about the perpetrators of all the recent terrorist attacks. But from the Oklahoma City bombing, through 9/11, to the London 7/7 attacks – no revealing footage of the terrorists, was ever published. The pentagon, being the heart of the biggest and most technologically advanced military in the world surely has a security camera or two. Yet the only images that we have seen of its 9/11 attack are stills taken from a nearby garage camera! In OKC all the cameras on the route taken by the truck bomb were “having the tapes changed” at the precise time that it passed by. The thousands of cameras on London's streets and in the transport systems almost entirely failed to record any damning images of the tragic events of 7/7. When a person dies in police custody, the cameras are invariably malfunctioning at the time. And so the protection argument collapses under the crushing weight of suspicious dysfunction.

People behave differently when they know they are being watched. Relentless surveillance is supposed to create a chilling effect in which everyone minds their behaviour because they assume they are being watched. This is the 200-year-old principle of the Penopticon prison. But what are the side effects? George Orwell's novel, 1984 explores these issues. The management of fear, is the primary control system of every oppressor. Another factor that is not commonly discussed, is the reverse subtext. I remember infamous judges presiding over rape hearings who made statements like, “you brought this upon yourself by wearing revealing clothing”. The warnings given to Women: not to be out alone at night, are also delivering a message to potential rapists. The message is clear: under specific circumstances, men are expected to attack women. This has profound implications for a population accustomed to constant surveillance. If they ever encounter a situation in which they are not being watched, what dreadful behaviour will they believe is expected of them?

The implication of total surveillance is that we are all potential threats. We are guilty until proven innocent. We are not supposed to object to this insult, or rail against the inconsistency of our “officials” and “authorities” demanding total secrecy. Cameras are not allowed in courtrooms. We cannot video military installations. Videoing police is often stopped and is becoming illegal in many places. Official secrets and Classified documents are justified by governments on the basis of “national security”. The EU Commissars, meet behind closed doors. We are not allowed to hear how they arrive at Directives, which effect us all. And yet, government agencies can eavesdrop on our inconsequential conversations whenever they see fit. The big question here is who watches the watchers?

Some of our fears are irrational. Certain dangers are exaggerated while others are ignored. The Jaws movie, made millions of people too nervous to enjoy the sea; and yet the same people use cars every day despite the it being statistically, the most dangerous thing we do. Our perceptions of threats are inconsistent and can be manipulated. Democide: murder by government has been an historical reality. In the last century alone, it is estimated that governments have killed at least 250 million civilians. George Washington reputedly said that “Government is not reason, it is not eloquence - it is force. Like fire it is a dangerous servant and a fearful master; never for a moment should it be left to irresponsible action.”

Overuse Of Facebook/Twitter Leads To Brain Damage

Constant use of Facebook and Twitter can lead to *Internet Addiction Disorder* and can damage one's brain.

This is the conclusion of Baroness Greenfield, Professor of Synaptic Pharmacology at Lincoln College, Oxford. Professor Greenfield's specialty is physiology of the brain and has done much research on Parkinson's disease and Alzheimer's disease.

Professor Greenfield says that overuse of these social networking sites can 're-wire' the brain of habitual users and lead to 'short attention spans' and 'a childlike desire for constant feedback on their lives'. Many of those who use these sites, she says, have become egomaniacs and attention seekers.

Greenfield is concerned that social networking sites have a detrimental effect on the development of children. In an interview with *New Scientist* in August 2011, she cited a study published in PloS ONE in June to back up her own findings.

The study found that atrophy of the brain correlated significantly with the duration of Internet Addiction Disorder (IAD). The PloS ONE study pointed to similarities between structural changes in the brain caused by IAD and those caused by drug abuse and suggested that the mechanism for both may be similar. The study concluded that these structural changes "probably contributed to chronic dysfunction in subjects with IAD."

So how does this "chronic dysfunction" manifest itself?

This new generation of Facebook/Twitter users are obsessed with themselves and suffer from an identity crisis. They act like juvenile attention seekers who continuously call out to a parent, "Look at me! Look what I'm doing!"

The Baroness, a former director of the Royal Institution of Great Britain, said that she is concerned by the banality and triviality of so much that goes out on Twitter. She finds it incredible that someone would be interested in what someone else has had for breakfast.

"It's almost as if they're in some kind of identity crisis. In a sense it's keeping the brain in a sort of time warp."

The eminent researcher suggested that some Facebook users feel a need to become celebrities in their own minds, superstars who think they are followed and admired by others every day. They do things that are 'Facebook worthy' because the only way they can define themselves is by 'people knowing about them'.

"It's almost as if people are living in a world that's not a real world, but a world where what counts is what people think of you or . . . can click on you," she said.

Greenfield warns that social networking sites are adversely impacting children's brains, resulting in selfish and attention deficient young people. As they become young adults their brains are becoming infantilized, leaving them with poor verbal and inter-communication skills. They have short attention spans, an inability to empathise, and

cannot maintain eye contact with people with whom they are conversing.

This erosion of identity can cause them to lose their sense of reality; they are unsure of where they themselves finish and the outside world begins.

Confusion, crime, fear and poverty are also favourite weapons of repression which is now being ruthlessly deployed.

During past world wars, the people co-operated most effectively when they saw that they shared common objectives. To facilitate that sense of unity and self-discipline people need to establish clear goals and plans. The *esprit de corps* and comradeship that follows taking action together dispels ingrained apathy. We must work on this and develop our natural human propensity to adapt and optimise. Tools for reorganisation need to be evolved.

Violent revolution is counter-productive. The temptation to destroy the old in order to make way for the new is obscenely destructive. In France, Russia, Spain, China, Cambodia, etc., revolution was followed by mass extermination. In the trauma and confusion that follows violence a more brutal version of the same system emerges. Whether through nostalgia, habit, lack of creativity or covert usurpation, governments of oppression are invariably re-constituted, and the opportunity for meaningful change is lost.

The alternative is a creative revolution. This requires us to work hard to better organise ourselves. We need to collaborate on the development of new systems for civilisation. Design, test, refine, practise, and expand them. Once we get them running effectively there will be no need to destroy the old system. It will become superfluous, obsolete and deprived of our energies,

it will retire. By focussing on our end objectives we avoid being misdirected, compromised and confused. The task is enormous, but there are so many great thinkers and the Internet can facilitate better collaboration than ever before.

There follows the first draft of a tool which may prove useful in this process.

Suggested Procedure of Rational Decision Making for Coherent Action

Stage 1 - Where are we and what have we got?

Trivium – Grammar.

Before we can begin to look for ways forward, we need to become clear about where we are starting from as well as where we want to get to. This stage includes gathering accurate information about our challenges and resources. Before assembling a kit, it helps to inspect all the parts. A team works best when everyone is aware of the skills of each individual. There is no point in plotting a course from Japan to Hawaii if we are actually starting from Panama! It's a no-brainer to keep trying to repay vast expanding debts that can never be repaid.

Stage 2 - Where do we want to be?

Trivium – Logic

When you're dealing with a Genie, you must be very careful about what you wish for! It is essential to find the heart of the intention and precisely define it. Vague notions such as “economic growth” and “sustainable development” are so ambiguous that they can be used to justify almost anything. Avoid errors from concatenated purpose. E.g. “I need a job so that I can get money to pay for my transport to work”. Such chains or reason often lead to absurd errors and inefficiencies.

Objectives should be expressed in positive terms. E.g. Striving to put an end to starvation will have profoundly different results than working towards an adequate, dependable food supply. Attempting to fix problems can lead to treating symptoms and the establishment of organisations with a vested interest in sustaining the problem. E.g. Big pharma profits from the treatment and management of disease and is therefore against prevention and cure.

Stage 3 - How will we measure progress?

It is crucial to agree how progress towards our

objectives is to be measured. Honest measurement provides the feedback necessary to test our actions and alter them. The time frame for progress assessment is also agreed, as well as a date for overall review. The education industry assesses its own effectiveness in its own terms; whether it helps children become effective adults or not is never measured. If the modern vaccination regime protects health, this should be evident in any comparison with the non-vaccinated population.

Stage 4 - What shall we do and how shall we do it?

Brainstorming with contributions from people with a wide diversity of experience and knowledge is most effective. E.g., to facilitate crossing a river we should consider the appropriateness of a boat, a ford, a swing, a balloon, a tunnel, etc., as well as considering a type of bridge. Research should be carried out into how similar objectives have been addressed.

Risks need to be assessed. E.g., if CERN could possibly generate a black hole or other disaster, this must be rationally counted against the objectives it promises to achieve. Total costing is vital to avoid committing to unsustainable expenditure. E.g., while nuclear power continues to produce waste that requires careful containment for millions of years, it remains prohibitively expensive. Irrational solutions are eliminated by applying logic.

Stage 5 - Let's do it

Trivium – Rhetoric

Where possible, several of the best solutions should be executed. This is better than implementing only one standard and allows for local variations. Diverse systems are more flexible and robust and also provide greater opportunities for learning. Unused ideas should be kept in mind in case they become more appropriate under different circumstances.

Stage 6 - Regular progress assessments

These are carried out according to the measurements agreed in Stage 3. The results should be analysed in context of uncontrolled factors such as the weather. The process then repeats from Stage 4 until the date is reached for a periodic review from the beginning.

This system can be refined, improved and linked with systems of direct democracy until it becomes a replacement for traditional government and professional politicians. Its use should provide defence against the present system in which:

1. Our perceived situation is a carefully orchestrated delusion.
2. The vague, subjective notion of “for the common good” justifies spurious government objectives.
3. No system of accountability or performance measurement is agreed.
4. No discussion of alternate solutions is tolerated.
5. Corruption distorts all collective action to further the ends of a few.
6. Dishonest and misleading measurement and statistics prevent assessment of performance.

Irrational decision-making has spawned the institutions and conventions that the Elite are using to dominate us. We have fundamentally flawed systems: an economy that depends on ever increasing consumption, a military industrial complex that demands constant wars, and governmental structures which guarantee endemic corruption and promote sociopaths to the top. We are only allowed useless tools such as party politics which is little more than a pantomime. It was designed to distract the masses and absorb the energies of those who seek change.

The impending disasters that we now face are the inevitable symptoms of incoherent organisation and dysfunctional design. We need to restate what the purpose of society is, and proclaim what civilisation actually means, and so rediscover our sense of direction.

Most common people just want health, peace, stability and a dependable living. We know how to achieve these basic things, and yet we are being prevented. Together we will establish effective, alternate ways of organising which will render the present system obsolete. We will withdraw our support for the murderous kleptocrats and peacefully retire them.

Transmitting Smart Meters Pose A Serious Threat To Public Health

It has come to our attention that over 6,000 homes in Ireland have already been fitted with Smart Meters. Of even more concern is the fact that, the plan is to have EVERY home in Ireland fitted with one!

This is of great concern because the exposure to microwave and radiowave radiation from these meters is involuntary and continuous. The meters that are being used most often, transmit continuously, every few seconds. This is picked up by a receiver and logged by the utility. You are exposed to the transmissions from all the meters within transmitting range. The meters often have a range of over 2 miles. Thus, the exposure is continuous and the "safety" standards the meters comply with are irrelevant to the situation.

Some transmitting meters transmit at less frequent intervals, however, they still seem to be causing health problems. This could be due to the still elevated levels of radiowaves and microwaves in the neighbourhood because of all the neighbours transmitters. Remember, many, many meters are transmitting at these intervals. (One person with a meter transmitting hourly, reports waking at the time it transmits.)

The transmitting meters can also put high frequencies directly on home and building wiring. This can happen deliberately through signaling to electrical loads or inadvertently through poor engineering. Poorly engineered meters can cause electrical pollution by putting the transmitted signal directly on home wiring or by the way they draw power. Many illnesses have been made worse by this.

The un-safeness of the "safety" standards for the continuously transmitting smart meters is apparent from the reports of health problems ranging from headaches to poor sleep to heart palpitations that begin after their installation. Transmitted microwave and radiofrequency radiation also have the potential for causing serious long-term health consequences, even for those who do not notice overt symptoms. Radiowave and microwave radiation are not just a problem for people, they are causing serious problems for animals of all types and plant life as well. If you do not have a transmitting smart meter and do not want one for health reasons, in addition to contacting your local council, utility companies, the H.S.E., local T.Ds and Government in writing, please do the following:

- Spread the word about the public health threat posed by transmitting smart meters. Link to <http://www.electricalpollution.com/smartmeters.html> on your Facebook or MySpace page, if you have one, notify your friends online via email, or write a Letter to the Editor of your local paper - it is likely to be published.
- Install a permanent sign on/near your meter(s) asking that no transmitting meter be installed. (Temporary signs seem to easily get "lost" or "blow away".)
- The fact that in spite of the hype, transmitting meters are not helping to save energy should help in obtaining an opt-out program. See this press release from the Connecticut Attorney General stating that they have asked that the Department of Public Utility Control terminate the Connecticut smart meter program on those grounds after a pilot study showed that there were no energy savings http://www.ct.gov/ag/lib/ag/press_releases/2011/020811clpmeter.s.pdf. Ask your attorney general to do the same. Please also pass this on to environmental groups and others pushing this program



on the basis of energy savings.

• It is far more energy efficient to transmit data over fiberoptic cables, or even copper wires than to transmit it wirelessly, according to a Swiss study wireless transmission takes 3 times as much energy. It is essential that those pushing transmitting meters see this information. <http://www.lowtechmagazine.com/2009/06/embodied-energy-of-digital-technology.html#more>

Those of you who have been diagnosed with a disability that is related to your exposure to radiofrequency radiation or are disabled by radiofrequency sickness may have additional options for places to turn to.

‘Quietus’ in Holland - Mobile Death Squads

Have you read ‘the Children of Men’ by PD James? This dystopian novel, quite outside James’ usual crime genre, tells the story of a demographically challenged world. The story is concentrated in an England of 2021 which is under the governance of a Warden. This brave new society features euthanasia by the state. This is called ‘Quietus’. Nice euphemism. ‘Quietus’ is ritual killing carried out on the elderly, whether or not they want it. In the novel, the protagonist has a conversation with a professor whose wife has dementia. The professor lies that his wife (who doesn’t speak) has been talking a lot about the quietus. The protagonist subsequently stumbles upon a seashore ritual in which he sees sedated white-robed elderly people, including the professor’s wife, being pushed out to sea in boats accompanied by floating candles and beautiful music. Shocked, he witnesses their mass drownings. It is an image that lingers with the reader.

Shortly before Christmas, the Telegraph reported that Dutch Health Minister, Edith Schippers, was contemplating plans to introduce mobile medical units to kill Dutch people in their homes. The Minister advised that mobile units "for patients who meet the criteria for euthanasia but whose doctors are unwilling to carry it out" were candidates. The Minister wrote that "If the patient thinks it desirable, the doctor can refer him or her to a mobile team or clinic". Minister Schippers suggested that "extra expertise" could be enlisted in cases involving mental health problems or an inability to consent to euthanasia because of dementia.

Euthanasia has been legal in Holland since 2001 in cases where patients are suffering unbearable pain due to illness with no hope of recovery. It is available in most Dutch hospices. In 2010, Right To Die NL (NVVE) proposed a clinic to provide for euthanasia on a wider basis, to include people with chronic psychiatric problems, with Alzheimer's or dementia and people who feel

they have "completed" their life.

The present regime does not go far enough for euthanasia proponents. A position paper published by the Dutch Physicians Association (KNMG) says unbearable and lasting suffering should not be the only criteria physicians consider when a patient requests euthanasia. New guidelines will consider factors such as income or a patient’s social life.

Dutch euthanasia is usually carried out by administering a coma-inducing sedative, followed by a drug to stop breathing and cause death. Patients who wish to be euthanised must convince two doctors they are making an informed choice in the face of unbearable suffering. The Dutch government has said repeatedly that euthanasia is only administered at the explicit request of the patient.

These are empty assurances. Lord David Alton wrote recently that ‘1,000 of the 4,000 euthanasia deaths in Holland each year are now done without the patient's consent.’ According to the UK Daily Mail, the pro-euthanasia lobby complained that “80 per cent of people with dementia or mental illnesses were being ‘missed’ by the country’s euthanasia laws”. They say that mobile units are necessary because some GPs have refused to administer lethal drugs to their patients. But doctors may refuse to kill patients for good medical reasons. Perhaps the patient has untreated depression or there is evidence of coercion or duress. Is it likely that the mobile units would seek the doctor’s advice and defer to his opinion and treatment plan for the patient? Hardly.

It is not surprising that thousands of frightened, elderly people in Holland carry anti-euthanasia cards.

The Dutch medical profession has an ignominious record when it comes to respect for life. Apart altogether from its liberal abortion laws, Dutch doctors kill scores of babies after birth each year and justify this infanticide on the inherently discriminatory basis that they can decide that a life is of such low quality that it ought not be lived. (In this regard, see ‘Killing babies compassionately’, which deals with this issue as a continuation of the philosophy expressed in Permission to Destroy Life Unworthy of Life (Die Freigabe der Vernichtung lebensunwerten Leben) by Binding and Hoche in 1920.

Elder abuse is a serious problem in our society. Age Action Ireland reported that 92% of alleged abusers investigated in 2007 were family members. Much of this abuse involves financial abuse. Lord Alton believes that financial abuse of our elderly will increase if euthanasia is introduced. If the choice is between expensive palliative care and an inexpensive injection or drink, Lord Alton asks ‘Would we honestly see relatives seeing granny living on and exhausting the inheritance? Won't health ministers, counting their pennies in a recession, be tempted to go for the cheaper option? A Bill allowing assisted suicide will carry the seeds of its own extension. If we allow it for some why deny it to others? So how long before the Dutch mobile killing units arrive in a street near you?’

Baroness Warnock, she who shaped the laws that have led to the destruction of millions of human embryos, has proposed a "duty to die". She has said "I think that's the way the future will go, putting it rather brutally, you'd be licensing people to put others down."

I don’t suppose we’ll call them ‘terminators’. They’ll think of something more reassuring.

Constitution of Ireland and the Fundamental Rights of the Irish People.

Submission by Mothers Alliance Ireland to the Working Group on Ireland's Third Periodic Report to the UN Committee on Economic, Social and Cultural Rights
Date: 10th November, 2011

The Constitution of Ireland embodies as a central feature a system of fundamental rights chosen by the Irish people for themselves which cannot be altered save with the express consent of the people in referendum, which rights are made superior to all legislative and executive acts, public and private. Without the consent of the people in referendum, no government, consultation process, working group, or other national or international body, etc., can change or interfere with the people's fundamental rights as enshrined in the Constitution of Ireland. The Constitution of Ireland is the oldest continuous republican constitutional document in the EU (*Michael McDowell SC*). At its heart, it is based on the day to day fact, as opposed to mere theory, of popular constitutional sovereignty, i.e. the people, under God, are sovereign.

Mothers Alliance Ireland calls on the Working Group on Ireland's Third Periodic Report to the UN Committee on Economic, Social and Cultural Rights to **IMPRESS** these rights on the UN Committee. Unless the Irish Working Group and the UN Committee accepts these truths as a starting point for the purposes of the Report, then this entire exercise is a complete waste of our time, of the time of the Working Group and, more importantly in these recessionary times, of the Irish taxpayers' money.

The FAMILY:

The Constitution of Ireland recognises the Family based on Marriage as the foundation stone of society. It accepts the Family founded on Marriage as *"the natural, primary and fundamental unit group of Society, and as a moral institution possessing inalienable and imprescriptible rights, antecedent and superior to all positive law"* (Art. 41). Even when the Irish people in referendum agreed that the Courts may grant a divorce, they did so in the misguided, though sincere belief, that it would better secure the Family founded on Marriage. The fact remains that, even with divorce, the Constitution of Ireland still obliges the State to protect the Family founded on Marriage as the necessary basis of social order and as indispensable to the welfare of the Nation and the State. **That the State is obliged to do this is still the will of the people and cannot be dispensed with, diminished or overturned by any national or international body, working group, consultation process, etc., without the fully informed consent of the people expressed in a referendum.**

The Supreme Court judgement in the *Crotty case* clearly affirms that the State, (and that includes all NGOs, working groups, etc., set up by the State) being the servant of the people and aware of its duty and limits set out in the Constitution is **PROHIBITED** from provisionally agreeing to terms of any Treaty with a foreign body that **COULD** jeopardise the exercise **WITHIN IRELAND** of the rights of the people acknowledged in the Constitution that the State has the duty to observe.

The *Crotty judgement* affirmed that the Government, in its negotiations with foreign bodies, is mandated to **IMPRESS** upon them that certain terms of agreement **ARE NOT PERMITTED UNDER THE CONSTITUTION OF IRELAND, AND SO ARE NOT ELIGIBLE FOR COMPROMISE WITHIN A TREATY.**

Dignity of all Women:

The Constitution of Ireland, unlike any other constitution in the world, recognises the extraordinary dignity and value to society of all women, including wives and mothers who work at home. It states clearly in Article. 41.2.1 and in Article 41.2.2 that the contribution of wives and mothers-at-home to society is such that without this contribution, the common good cannot be achieved. This acknowledgement in no way lessens the Constitutional recognition of the equal value and dignity of women, including wives or mothers, who work outside the home. (Article 45.2). The Constitution of Ireland is fully inclusive of all women. It obliges the State to value all women, whether they choose to work within or without the home.

Unfortunately, international treaties do not, apparently, comprehend the fully inclusive nature of the Constitution of Ireland in regard to women's rights. One such Treaty is the so-called UN Convention on the Elimination of all forms of Discrimination against Women (CEDAW). This document is highly discriminatory against wives and mothers who choose to work full time in the family home caring for the Family. CEDAW negatively discriminates against wives and mothers in the home and is repugnant to the Constitution of Ireland. The National Women's Council of Ireland, the NGO that promotes the CEDAW philosophy in Ireland, is also an exclusive body. This body does not fully represent the views of all Irish women. Many individual women and women's groups – like Mothers At Home – are excluded from membership because they do



not subscribe to the ethos and values of the NWCI. Yet the Irish Government continues to treat NWCI as the umbrella organisation for women's groups and makes significant funding available to NWCI (€540,000 in 2010). NWCI has consistently promoted the policies contained in the Report of the Irish Commission on the Status of Women which demeaned wives and mothers in the home and devalued their contribution to the Common Good – to the economic, social and cultural life of Ireland. In demeaning the work of women as full-time homemakers, this flawed Report also demeaned and de-valued the work of husbands and fathers and posed a major threat to the personal development and the physical, emotional and mental health of children, born and unborn.

The Family:

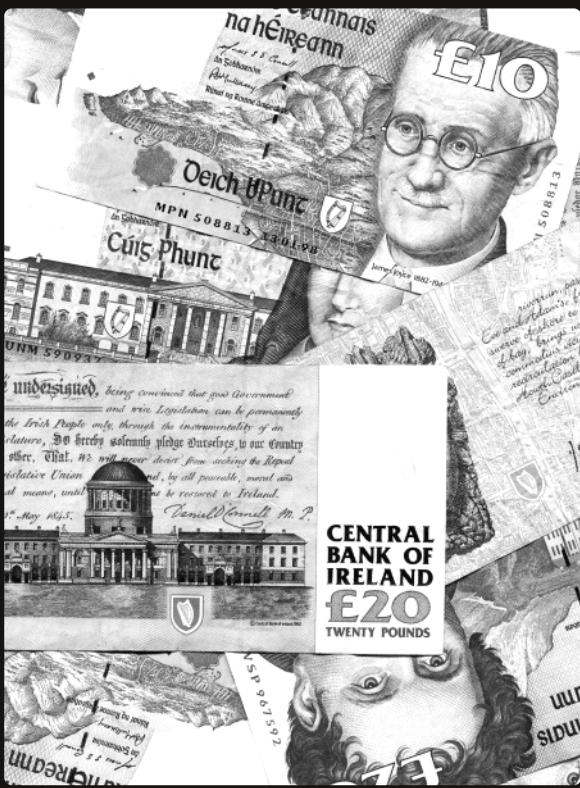
From an economic, social and cultural aspect, the NWCI and CEDAW policy of negative discrimination against women and men has proven to be disastrous. It has led to the destruction of the social foundation stone, the Marriage based Family, creating instability at the **very centre** of the social order – instability in relationships between men, women and children. With instability at the centre, order cannot be sustained. To put it bluntly, when the **centre cannot hold**, the entire system collapses, economic, social and cultural, and sustainability cannot be achieved.

There will never be stability, either economic, social or cultural, unless and until there is a large degree of stability at the **very core** of the social order – the Family founded on lifelong Marriage between one man and one woman. This basic fundamental truth is enshrined in the Constitution of Ireland. The architects of the Constitution of Ireland, in their wisdom, recognised that if the **centre** is strong and stable, society will be strong and stable, and capable of withstanding individual idiosyncrasies. *The Marriage-based Family must be upheld in law and policy if stability and sustainability is to be assured in any society.*

MAI demands that Ireland's Third Periodic Report to the UN Committee on Economic, Social and Cultural Rights, fully respects the Crotty judgement, which affirmed that the Government, in its negotiations with foreign bodies, is mandated to IMPRESS upon them that certain terms of agreement ARE NOT PERMITTED UNDER THE CONSTITUTION OF IRELAND, AND SO ARE NOT ELIGIBLE FOR COMPROMISE (an agreement or settlement of a dispute that is reached by each side making concessions) WITHIN A TREATY.

Is “Global Warming” a Conspiracy?

Most conspiracy theories are born of an entirely healthy distrust on the part of the governed in their governors. Dictators are distrusted by all but their fawning coterie of hangers-on and journalists (who have long tended to be the lickspittles of power). Elected governments are usually distrusted by at least that half of the electorate that voted for someone else or did not vote at all.

The trouble with conspiracy theories, though, is that every so often one of them turns out to be a true conspiracy – literally, a “breathing-together” of malevolent evil-doers in a position to gain status, power and wealth for themselves at the expense of the rest of us by unlawful means.

As if the Climategate emails of two years ago were not enough, we now have Climategate 2.0 – a second and larger batch of 5000 selected emails between climate scientists released by a thief or a whistle-blower (depending on your point of view) at the University of East Anglia.

The first thing that will strike you if you read these emails is the sheer nastiness of the scientists writing them. These are profoundly unpleasant people who should really be locked up so that they cannot pollute the atmosphere of academe with their venom.

The emails reveal a systematic tampering with data, a prolonged concealment of the fact that scientific results presented as genuine were in fact based on inadequate and poorly-archived data, a persistent refusal on the part of those holding the scrappy data to reveal it to scientists who had suspected something was amiss, a conspiracy of silence on the numerous fundamental defects in the “official” position that “global warming” is a real problem (while privately acknowledging and discussing these defects), and several campaigns to delay or prevent publication of results that did not fit the party line, to exclude sceptical scientific results and papers from consideration by the UN’s climate panel, or to remove journal editors who might otherwise allow heretical science to be printed, or even to suppress journals altogether.

This was – and is – a conspiracy. In fact, it is a conspiracy of the governors against the governed. We may deduce this from the fact that the various official “enquiries” into the lamentable – and, in many respects, criminal – behaviour of the Climategate emailers were elaborate whitewashes.

Perhaps the most absurd of these whited-sepulchre enquiries was the “science panel” under Lord Oxburgh, who had – but did not sufficiently or timeously disclose – a monstrous conflict of interest that should have disqualified him. The science panel’s remarkably skimpy report said little more than that the science panel did not consider itself a panel to review the science, and that it would not do so.

Then the University of East Anglia – now an international standing joke in academic circles – went around saying that the enquiries had found the “science” behind the official “global-warming” storyline that the university has so sedulously peddled to be robust. In fact, matters had been carefully arranged so that not one of the enquiries looked at the science at all.

This joke university’s own joke enquiry, under a joke bureaucrat, Sir Muir Russell, did not even let me testify, even though I am mentioned several times in the emails and clearly had locus standi to be heard. I was one of the first to ask to be interviewed, but I received no reply, even though I sent the request directly to Sir Muir Russell, who certainly received it. When I wrote again asking why I had had no response, I was told that it was now too late for further evidence to be considered.

By shoddy artifices of this kind, these pretend enquiries pretended to exonerate the mad, bad scientists who went on trying to tell us that “global warming” is a problem even as Britain struggled through the second-coldest winter since instrumental temperature records were first kept in central England in 1659.

However, several of us who have been visiting the Durban lunatic asylum where the inmates have been planning to enshrine an International Climate Court and the Rights of Mother Earth and \$1.6 trillion a year of payments from the West to the rest via the UN in an international treaty, have decided how we are going to deal – and deal firmly – with what is in truth a scientific fraud containing conspiratorial elements.

We are going to prosecute the fraudsters.

Work is well under way on identifying half a dozen plain scientific frauds, such as the “hockey-stick” graph that falsely purported to abolish the mediaeval warm period, and another bogus graph

Besides, the latest batch of emails disclose a further slew of offences against the Freedom of Information Act, and this time they will be reported to the Commissioner very promptly, so that he cannot twice get away with saying there is a six-month time-bar on prosecutions for offences under the Act.

We are already working with national and State prosecutors to ensure that the fraudsters are at least interviewed by the police, who will then report to the prosecutors on whether they consider the facts indicate that, on the face of things, a fraud has been committed. We have been making it plain to the authorities that if they do not prosecute, and if they do not give us good and acceptable reasons why they will not prosecute, we will.

One of the many problems with conspiracy theories is that the conspiracies may be suspected but are extremely difficult to prove. The healthy, non-paranoid approach that works best, where it appears that there may have been a conspiracy, is to take all possible steps to ensure that, if there is a conspiracy, it will fail.

Once the police begin interviewing the first of our suspected fraudsters, the rest will gallop for cover,

the entire “global warming” process will be even more completely discredited than it already is, and the conspiracy – to the extent that there is one – will be brought to an end because the conspirators will no longer feel free to be fraudulent.

The Great Carbon Credit Deception

In an era of economic growth, the dynamics of competition, innovation, and entrepreneurial investment were important elements of the game. In a non-growth era, the game will be based on entirely different dynamics. The mechanisms of production will become relatively static. Instead of corporations competing to innovate, we'll have production bureaucracies. They'll be semi-state, semi-private cartels, concerned about budgets and quotas rather than growth, somewhat along the lines of the Soviet model.

We can already see steps being taken to shift the corporate model towards the bureaucratic model, through increased government intervention in economic affairs. In the US for example, with the Wall Street bailouts, the forced restructuring of General Motors, the call for centralised regulation of banking and industry, and the mandating of health insurance coverage, the government is saying that the market is to be superseded by government directives. Not that we should bemoan the demise of exploitive capitalism, but before celebrating we need to understand what it is being replaced with.

In the era of capitalism and growth, the focus of the game was on the production side of the economy. The game was aimed at controlling the means of growth: access to capital. In an era of non-growth, the focus of the game will be on the consumption side of the economy. The game will be aimed at controlling the necessities of life: access to food and energy. Carbon limits and carbon trading provide the mechanisms that will enable the banksters to micromanage the necessities of life on a global scale.

As regards financial budgets, the IMF is doing the micromanaging, using the leverage of debt. For carbon budgets, it will be the IPCC (Intergovernmental Panel on Climate Change) that will do the micromanaging, using the excuse of global warming. How this will work is explained by the *Herald Sun*, 10 July 2011, discussing Australia's new carbon legislation:

"An emissions trading scheme is where the

government sets a cap on the total amount of pollution [CO2] that can be released each year. Businesses compete for permits and can trade permits, within that cap. The price can vary but the amount of pollution is fixed. Each year the Government could lower the cap – meaning Australia's emissions will fall."

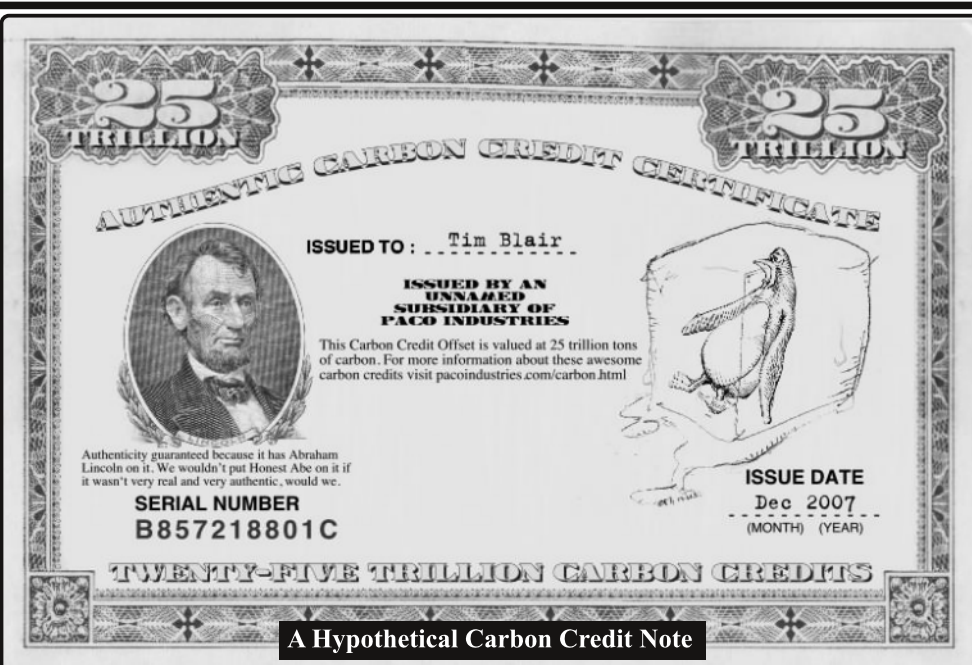
In terms of propaganda, this carbon-credit regime is being sold as a solution to global warming and peak oil. The propaganda campaign has been very successful, and the whole environmental movement has been captured by it. In Copenhagen, demonstrators confronted the police, carrying signs in support of carbon taxes and carbon credits. But in fact the carbon regime has nothing to do with climate or with sustainability. It is all about micromanaging every aspect of our

lives, as well as every aspect of the economy.

If the folks who are running things actually cared about sustainability, they'd be investing in efficient mass transit, and they'd be shifting agriculture from petroleum-intensive, water-intensive methods to sustainable methods. Instead they are mandating

biofuels and selling us electric cars, which are no more sustainable than standard cars.

As the new global regime is consolidated, the IPCC will dole out a mandatory annual carbon cap to each nation. Each government will then budget out its allocation in some way, as Australia is doing. With smart meters, energy use can be micromanaged all the way down to the number of minutes people spend in showers, or at what temperature people choose to do their laundry.

Whether these kinds of measures will significantly reduce CO2 levels is open to considerable doubt. Creating a tree plantation in the third world can be 'traded' for continued emissions, even if a rain forest is cut down to make room for the plantation – and this overall transaction actually increases global CO2 levels. And there will surely be special cases, such as favoured industries, or government and military applications, where exceptions to the cap will be permitted. And in general, enforcement of industrial regulations tends to be notoriously lax.

Although reduction of CO2 levels may be in doubt, there is one thing that is not in doubt: carbon caps will limit access to the necessities of life and will greatly increase the cost of those necessities. Every industry that burns fossil fuels will have an additional cost added: the cost of obtaining carbon permits – by being the highest bidder. Those costs, plus profit margins, will be passed on to the consumer. Fossil alternatives, such as wind power and biofuels, will be only marginally lower in price:

it is IPCC-imposed fossil fuel scarcity that will set the price in each market segment, as we already see with world grain prices. All of this will encourage speculative investment in futures markets, which will increase prices still further – and this is already happening with global food prices.

With food prices linked to energy prices, and agriculture land being converted from food production to fuel production, the result can only be a massive increase in third world starvation. Depopulation has long been a stated goal in elite circles, and the Rockefeller dynasty has frequently been involved in eugenics projects of various kinds over the past century. Genocide through imposed poverty is already a model being pursued successfully in Africa and biofuels are systematically expanding that program.

Ireland is in financial ruin. Our national debt is projected to be up to €371,000,000,000 which is €92,750 per person, or €371,000 for a family of four.

and ingenuity of our ancestors. Everything from the skill of writing, to the wheel, to the micro-processor is part of this Social Credit.

The Social Credit has been usurped by private trading companies called banks. A bank loan is in effect, the credit belonging to the nation, obtained for free by a bank, and then sold at a profit to the nation.

The public is compelled to pay exorbitant interest for the use of their own credit. Either, individually via Mortgages or collectively as taxation. (Most of the tax you pay does not go to build schools or roads, it goes to pay interest to banks).

Now to deal with the objections:

1. **Q.** Ireland cannot do this due to our membership of the Euro

A. Wrong. The Island of Guernsey has been doing just what I propose for over 200 years. Their Guernsey pounds circulate in parity to Sterling pounds on the island. Both are accepted. Guernsey has a high standard of living and low taxes.

2. **Q.** Introducing Social Credit currency would create chaos

A. Wrong. We are already in chaos. The Euro may even collapse. How Edmund de Rothschild Managed to Let 179 Governments Pay Him for Grasping Up to 30% of the Earth

Woe to him that ... establisheth a city by iniquity!... that the people shall labor in the very fire, and the people shall weary themselves for very vanity (Habakkuk 2:12-13)

Global Environment Facility. What is the GEF?

The Global Environment Facility (GEF) unites 179 member governments, in partnership with international institutions, NGOs, and the private sector, to address global environmental issues.

Established in 1991, the GEF is today the largest funder of projects to improve the global environment. The GEF has allocated \$8.8 billion, supplemented by more than \$38.7 billion in co-financing, for more than 2,400 projects in more than 165 developing countries.

The GEF partnership includes 10 agencies: 1. The UN Development Programme (David Rothschild consultant/Nigeria); 2. The UN Environment Programme (UNEP); 3. The World Bank; 4. The UN Food and Agriculture Organization (A Rockefeller-partner organisation); 5. The UN Industrial Development Organization; 6. The African Development Bank; 7. The Asian Development Bank; 8. The European Bank for Reconstruction and Development; 9. The Inter-American Development Bank (David Rothschild consultant); and, 10. The International Fund for Agricultural Development.

The Telegraph 2. Jan 2010: NM Rothschild is poised to earn tens of millions of pounds ... [by] further strengthening the close bond between the Rothschild family and Russian billionaire Oleg Deripaska, the bank advising (Deripaska's firm) Rusal. Deripaska (an intimate friend of Nathan Rothschild's) was able to tap the World Bank's International Finance Corporation and the European Bank for Reconstruction and Development (GEF) for a loan of \$150m, to his Basic Element vehicle in 2006. *Wikipedia:* 'Deripaska is one of 16 global business leaders who drafted CEO Climate Policy Recommendations to G8 Leaders, a document outlining international business community's proposals to effectively tackle global warming'.

History

The Global Environment Facility was established in October 1991 as a \$1 billion pilot programme in the World Bank system to assist in the protection of the global environment and to promote environmental sustainable development. The United Nations Development Programme (David Rothschild Service Manager), the United Nations Environment Program (Maurice Strong) , and the World Bank were the three initial partners implementing GEF projects.

In 1992, at the Rio Earth Summit, the GEF was restructured and moved out of the World Bank system to become a permanent, separate institution. The decision to make the GEF an independent organization enhanced the involvement of developing countries in the decision-making process and in implementation of the projects. Since 1994, however, the World Bank has served as the Trustee of the GEF Trust Fund and provided administrative services.

As part of the restructuring, the GEF was entrusted to become the financial mechanism for both the UN Convention on Biological Diversity and the UN Framework Convention on Climate Change. The GEF started funding projects that enable the Russian Federation and nations in Eastern Europe and Central Asia to phase out their use of ozone-destroying chemicals.

Comment: Imagine what collateral Russia has in Siberia for Rothschild to take over as forfeited security!!

Big buyers are China, Daewoo, South Korea, Saudi Arabia – in particular in Africa, this leaving the Africans with even less food at their disposal. There have been riots against it in Madagascar and Kenya.

10 June 2010: In the spring of 2008 spiking grain prices caused food shortages and rioting in dozens of countries before falling some 50% by December.

“Be More Aggressive In Repossessing Properties!” Rothschilds’ Irish Mouthpiece Tells Banks

Patrick Honohan, Governor of the Central Bank of Ireland, a Rothschild controlled vehicle, feels that the banks are not repossessing properties fast enough in Ireland. His use of the word “repossessing” is an interesting one. Did the banks ever own or possess these properties in the first place?

Honohan also slams debt forgiveness as “unaffordable”. Unaffordable to whom? Unaffordable to the private banks who created the original credit from the “borrower’s” signed promise to pay, without investing or risking a single cent of their own?

Conor Pope of the Irish Times reports:

“Banks will have to be more aggressive in repossessing properties in the buy-to let sector, the Governor of the Central Bank Patrick Honohan warned tonight while ruling out a widespread debt forgiveness programme as unaffordable.”

And RTE News says:

“Central Bank Governor Patrick Honohan has urged banks to move more quickly to repossess investment properties whose owners are struggling to repay debt.” .

Honohan's sentiments are echoed by Pat Farrell, CEO of the Irish Banking Federation, another

group friendly to the Rothschilds' financial interests.

Farrell, responding to Honohan's comments that banks need to be more aggressive in repossessing properties, is dismayed by the fact that:

“A ‘legal vacuum’ is preventing banks from promptly repossessing homes owned by individuals who have fallen into mortgage arrears...and was an impediment to repossessing homes from people who took mortgages before December 1st, 2009.” (Spoken like a truly rapacious predator.).

All this only goes to show how prescient Professor Carroll Quigley proved to be when he wrote in *Tragedy And Hope* (1966) that the purpose of central banks was:

“to create a world system of financial control in private hands able to dominate the political system of each country and the economy of the world as a whole. This system was to be controlled in a feudalist fashion by the central banks of the world acting in concert, by secret agreements arrived at in frequent meetings and conferences. The apex of the system was to be the Bank for International Settlements in Basel, Switzerland, a private bank owned and controlled by the world's central banks which were themselves private corporations.

“Each central bank....sought to dominate its government by its ability to control Treasury loans, to manipulate foreign exchanges, to influence the levels of economic activity in the country, and to influence cooperative politicians

by subsequent economic rewards in the business world.”

The Irish Central Bank is ostensibly owned by the Irish Government but, in reality, the real power behind it and all central banks is a small handful of international bankster families.

Obama Finally Signs *National Defence Authorisation Act* into Law... Martial Law!

December 31st 2011, Obama signs draconian FY 2012 National Defense Authorization Act provisions. Justification given is national security and war on terror hokum.

Henceforth, anyone anywhere, including US citizens, may be indefinitely held without charge or trial, based solely on suspicions, spurious allegations or none at all.

No reasonable proof is needed, just suspicions that those detained pose threats. Henceforth, indefinite detentions can follow mere membership (past or present) or support for suspect organizations.

Presidents now have unchecked dictatorial powers to arrest, interrogate and indefinitely detain law-abiding citizens if accused of potentially posing a threat.

Constitutional, statute and international laws won't apply. Martial law will replace them if so ordered.

As a result, US military personnel anywhere in the world may arrest US citizens and others, throw them in military dungeons, and hold them indefinitely outside constitutionally mandated civil protections, including habeas rights, due process, and other judicial procedures.

In other words, presidents may order anyone arrested and imprisoned for life without charge or trial. Tyranny arrived in America. Abuse of power replaced rule of law protections.

Even someone erroneously arrested and cleared of wrongdoing could be held indefinitely without charge, given non-civil trials, none at all, or, for foreign nationals, sent abroad to torture prison hellholes.

Civil Libertarian Responses

On December 14, an ACLU press release headlined, "White House Backs Away from Defense Bill Veto Threat," saying:

Obama "support(s) passage of the (FY2012) National Defense Authorization Act (NDAA), which contains harmful provisions (to) authorize the US military to pick up and imprison without charge or trial civilians, including American citizens, anywhere in the world."

Responding, ACLU Washington Legislative Office director Laura Murphy said:

"The president should more carefully consider the consequences of allowing this bill to become law. If (he) signs this bill, it will damage both his legacy and America's reputation for upholding the rule of law."

The last time Congress authorized indefinite detentions for uncharged US citizens without trial was in 1950 over Harry Truman's veto.

The Emergency Detention Act provision of the Internal Security Act authorized incarceration for those considered likely to commit espionage or sabotage.

It was never used, then repealed by the 1971 Non-Detention Act, stating:

"No citizen shall be imprisoned or otherwise detained by the United States except pursuant to an Act of Congress."

At issue was never again subjecting US citizens to lawless internment the way Japanese Americans were in 1942. At the time, loyal citizens were forced into War Relocation Camps lawlessly.

Murphy faintly hoped Obama would emulate Truman. However, Senate bill sponsor Carl Levin said he insisted on subjecting US citizens to the same draconian treatment as foreign nationals. The original Senate bill excluded them. At his request, they were added.

ACLU deputy legal director Jameel Jaffer called NDAA "an awful bill...." He and other civil libertarians are outraged by its passage. Jaffer added:

This bill will "make permanent as an American law this fixture of worldwide indefinite detention without charge or trial. (It's) a bill that would further militarize counterterrorism policy."

It's "a bill that will make it harder to close Guantanamo. It has all the problems that we identified earlier, and it is really quite astonishing and disappointing that (Obama) is withdrawing his veto threat."

All along, of course, it was disingenuous and hollow. As explained above, he insists on subjecting uncharged US citizens to the same draconian treatment as foreign nationals.

On December 14, the Center for Constitutional Rights (CCR) said:



Obama "made a choice with chilling consequences today when he announced he would not veto the NDAA despite the lack of change to provisions of the bill that make it even more difficult to shut down the prison at Guantanamo and make indefinite military detention(s) without trial a permanent feature of the US legal system."

Throughout his tenure, Obama exceeded the worst of George Bush. Besides trashing rule of law principles and other democratic values, waging multiple imperial wars, sanctioning torture, wrecking America's economy, and turning a blind eye to growing human need, he's taking a major step toward institutionalizing tyranny by supporting the "indefinite detention of citizens and non-citizens alike without charge or trial...."

On December 15, Bill of Rights Day, the Senate passed NDAA following House passage on December 14. On December 16, Obama will sign it into law, in defiance of Bill of Rights protections he'll further abrogate with his signature.

As a result, December 15 may become known as a day of infamy when tyranny replaced constitutional law.

Henceforth, no one anywhere will be safe, and there's no place to hide.

Major Media Scoundrels for Tyranny

Notably, US media scoundrels largely ignored the bill for months. On December 14, ahead of its enactment, The New York Times misreported its significance by failing to explain how US citizens are affected. Instead, it discussed inconsequential language changes and quoted a White House statement, saying:

"As a result of (House/Senate conference committee changes), we have concluded that the language does not challenge or constrain the president's ability to collect intelligence, incapacitate dangerous terrorists, and protect the American people, and the president's senior advisors will not recommend a veto."

A same day Washington Post (WP) article also ignored the bill's draconian provisions. It quoted the same White House statement, and falsely claimed civilian authorities, not America's military, will be authorized to make arrests on US soil.

A December 13 WP editorial also misreported, claiming US citizens won't be subjected to military detention. In addition, like The Times and its own December 14 article, it discussed (ahead of passage) inconsequential changes while omitting explanation of constitutionally destructive draconian provisions.

Of course, no one ever accused America's major media of being long on truth and full disclosure. In serving wealth and power, they fail on all counts by inverting truth and avoiding what journalists are supposed to do - their job.

Readers, viewers and listeners have a choice. Growing numbers exercising it by walking away.

They're tuning out and making credible choices for real news and analysis more needed today perhaps than ever, given America's draconian direction.

Hopefully eventually they all will before it's too late to matter.

A Final Comment

On December 14, Nader.org headlined, "Congressional Tyranny, White House Surrender," saying:

The FY 2012 NDAA "will finish off some critical American rights under our Constitution." Two retired four-star marine generals (Charles Krulak and Joseph Hoar) urged an Obama veto, saying:

"One provision would authorize the military to indefinitely detain without charge people suspected of involvement with terrorism, including United States citizens apprehended on American soil. Due process would be a thing of the past..."

"A second provision would mandate military custody for most terrorism suspects. It would force on the military responsibilities it hasn't sought....for domestic law enforcement...."

"A third provision would further extend a ban on transfers from Guantanamo, ensuring that this morally and financially expensive symbol of detainee abuse will remain open well into the future."

Other military, security, and former government officials also expressed opposition.

This law will deny US citizens due process and judicial fairness. It will let military forces become law enforcers. It will make America a police state. It will abolish constitutional freedoms besides others already lost.

This "arbitrary, open-ended dictatorial White House mandate was never subjected to even a House or Senate Committee hearing....It was rammed through by the House and Senate Armed Services Committees without the Judiciary and Intelligence Committees invoking their concurrent jurisdiction for public hearings."

As president, Obama's done the impossible. He's governed worse than his fiercest critics feared, worse than Bush on domestic and foreign policies.

This law further destroys American freedom. Obama's support and moral cowardice assures it.

Washington's longstanding policy is regime change in Iran and Syria. At issue is replacing independent regimes with client ones and securing unchallenged control of valued Middle East resources.

On February 4, Russia and China vetoed a largely one-sided anti-Assad resolution. A previous article called him more victim than villain. Yet he's falsely blamed for months of externally generated violence.

In fact, he confronted a Western-backed armed insurgency replicating the Libya model. By so doing he acted responsibly against a heavily armed insurrection.

Imagine a similar scenario in America. Local police, National Guard forces, and Pentagon troops would confront it violently. Combined, they'd way exceed Assad's response.

Mass killing would follow. Western media scoundrels would approve. In contrast, the New York Times calls Syria's self-defense state-sponsored "butchery."

Its position substitutes disinformation for truth and full disclosure. They're scrupulously avoided to misinform, misrepresent and betray readers. It's longstanding major media policy. The Times featured it longer than others.

Since violence erupted last March, Syria was blamed for Western-backed insurgents against him. It's part of Washington's "New Middle East" project to control North Africa, the Middle East and Central Asia to Russia and China's borders.

For over a decade, regime change plans targeted Iraq, Afghanistan, Lebanon, Iran, Somalia, Sudan, Libya, Syria, and other countries outside the region.

Replicating Libya's model is Washington's template for future NATO aggression. Whether it's employed fully in Syria remains to be seen.

So far, heavily armed insurgents entered from regional countries. Anti-government violence followed. Trapped between warring sides, civilian casualties mount. No end of conflict approaches. In fact, the worst is yet to come.

On February 5, Israel's Mossad-connected DEBKA/file said Russia put "Rapid Reaction Force (aka Spetsnaz) units in Black Sea bases on (alert) to set out for Syria to defend Damascus."

Russia's determined to avoid another Libyan-style intervention. In response, Obama said Washington, key NATO partners, and Gulf allies will (in DEBKA/file's words) "redouble their efforts to unseat Bashar Assad."

On February 4, an official White House statement said:

"Assad must halt his campaign of killing and crimes against his own people now. He must step aside and allow a democratic transition to proceed immediately."

Fact check

Since WW II, no combination of nations caused more slaughter, destruction, and human misery globally than America. Moreover, Washington won't tolerate democracy at home or abroad.

"Assad has no right to lead Syria, and has lost all legitimacy with his people and the international community. The international community must work to protect the Syrian people from this abhorrent brutality."

Fact check

International law prohibits interfering in the internal affairs of other nations, including determining the legitimacy of their leaders. Moreover, Syria's "abhorrent brutality" is entirely Western-backed. It was absent until Washington, key NATO partners, and rogue regional despots intervened, notably Saudi Arabia, and of course, Israel's very much involved.

"We must work with the Syrian people toward building a brighter future for Syria...The suffering citizens of Syria must know: we are with you, and the Assad regime must come to an end."

Fact check

Long-suffering Afghans, Iraqis, Libyans, Somalis, Bahrainis, Yemenis, Palestinians, and many others elsewhere understand the horrors when America intervenes. So do Syrians. They abhor Washington led meddling in their internal affairs and want no part of it.

In fact, a mid-December Qatar Foundation-funded YouGov Siraj poll found 55% of Syrians back Assad. It contradicts Western discourse of majority opposition. Except for the London Guardian, the findings were unreported in the West.

On February 4, Global Research editor Michel Chossudovsky explained "armed opposition groups" operating in Syria. They include the Western-backed Syria Free Army (FSA) "involved in criminal and terrorist acts."

They're killing civilians and security forces. They're reigning terror blamed on Assad. They're destroying state assets, including fuel pipelines, trains and vehicles carrying fuel, as well as buildings and other targets.

Their ranks include elements similar to Libyan insurgents, including "Al Qaeda affiliated" militants, "Muslim Brotherhood" members, and "Salafists. Turkey, Israel and Saudi Arabia" support them. So do other Gulf Cooperation Council (GCC) States and Jordan.

Largely the same countries behind the Syria draft resolution backed Resolution 1973 against Libya. Once passed, war followed straightaway.

They include sponsor Morocco and co-sponsors:

Washington, Britain, France and Germany (the so-called NATO Quad - the key four) plus Portugal and Turkey;

all six GCC states, including Saudi Arabia, Kuwait, Qatar, Oman, UAE, and Bahrain plus Jordan and Libya;

Colombia; and

Togo - its UN envoy Kodjo Menan holds the rotating SC presidency during February.

Russia and China stood firm against them. Washington's UN envoy Susan Rice accused both countries of holding the Security Council "hostage." Responding, Russia's UN ambassador Vitaly Churkin said:

The Security Council decision "should be exactly such because some influential members of the international community, including those sitting at this table, from the very beginning of the crisis in Syria undermined the opportunity of political settlement calling for change of the regime and setting the opposition against the power without shunning provocation and forcing for armed means of fighting."

He added that the draft resolution didn't reflect "reality in Syria," nor did "co-authors" adopt Russia's amendments to "distance" themselves "from (culpable) extremist groups" behind the insurrection.

On February 7, Russian President Dmitry Medvedev, Foreign Minister Sergei Lavrov, and Foreign Intelligence Service chief Mikhail Fradkov will meet Assad in Damascus.

On February 5, a Foreign Ministry statement said:

"Russia, including in interaction with other countries, is firmly set to seek the quickest stabilization of the situation in Syria along the paths of the quickest implementation of longstanding democratic transformations."

Moscow also urged Arab League foreign ministers to continue their monitoring mission and report accurately on what they find. Russia and China stand firm against another "Libyan scenario."

Washington and key NATO partners plan intervention with or without Security Council cover. Doing so violates fundamental international law that prohibits interfering in other countries' internal affairs, except in self-defense if attacked.

Syria threatens no one. Neither does Iran. Yet both are targeted for regime change. Plans are longstanding. With or without UN support, they're coming.

Expect the worst in 2012, preceded perhaps by false flag cover blamed on Assad. The strategy's used as needed. It's an America tradition to enlist public support for war.

Electoral politics may influence timing, especially in a close presidential race. According to the latest February 4 Rasmussen poll findings, "Romney now ties Obama 45/45." Moreover, "uncommitted voters (12% of its sample) have a distinctly sour take on the President," though months remain until November.

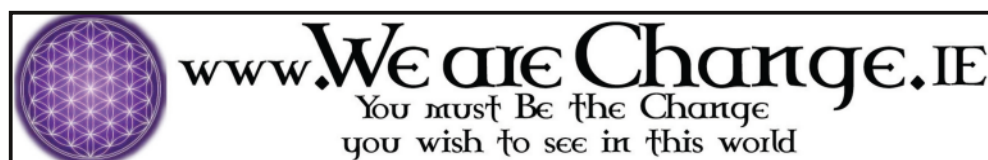

THE GREAT CHASTISEMENT

Catholic Prophecies of an Impending New World Order

On July 13th, 1917 near the little village of Fatima in Portugal the Blessed Virgin Mary, the Queen of Prophets, announced to the three children whom she had chosen as her messengers, that “mankind would be given a time of peace” if people did what Our Lady asked. Simultaneously, and hardly surprisingly given the global nature of child murder, the world has seen an unprecedented explosion of immorality and amorality, a consequence, directly and indirectly, of the near universal breakdown of family life and the *seeming* freefall of a Catholic Church that wanted to “update itself,” and thus came to mirror the pagan and atheistic world that surrounded it. To informed Catholics – sadly, a minority – none of this comes as a surprise, for we have been warned time and time again down the long centuries that this, and much worse was coming to a family, a country and a parish church near you.

FURTHER AUTHENTICATED PROPHECIES

September 1846, La Salette, France, The Blessed Virgin Mary appears to two children and gives the following message:

“God will strike in an unprecedented way. Woe to the inhabitants of the earth! God will exhaust his wrath upon them and no one will be able to escape so many afflictions together.....God will allow the old serpent [this is a reference to Satan –ed.] to cause divisions among those who reign in every society and in every family. Physical and moral agonies will be suffered. God will abandon mankind to itself and send punishments which will follow one after another. Mankind must expect to be ruled with an iron rod and to drink from the chalice of the wrath of God.....Lucifer together with a large number of demons will be unloosed from hell, they will put an end to faith little by little, the true faith of the Lord having been forgotten (does this sound familiar to the poor confused Catholics of today?).they will abolish civil rights, all order and all justice will be trampled under foot....All governments will have one and the same plan, which will be to abolish and do away with every religious principal. To make way for materialism, atheism, spiritualism and vice of all kind

.....France, Italy, Spain and England will be at war. Blood will flow in the streets, Frenchman will fight Frenchman, and Italian will fight Italian. A general war will follow [she is referring not to World War II but World War III!] which will be appalling.....At the first blow of His thundering sword, the mountains and all nature will tremble in terror, for the disorder and crimes of men have pierced the vault of the heavens. Paris will burn, Marseilles will be engulfed. Several cities will be shaken down and swallowed up by earthquakes. People will believe all is lost. Nothing will be seen but murder. Nothing will be heard but the clash of arms and Blasphemy. *Three quarters of the world’s population will perish.*”

There are hundreds of prophecies from Saints and religious down the Christian centuries, pointing to these events from Europe and beyond. Let us look at five particular events, each in their own way highlighting the almost inevitable explosion of the Third World War and the intrinsic Chastisement that this signifies.

1.The whole world will be involved in this Third World War. A unique feature is the internal disintegration of the Western democracies, the eruption of civil wars in Europe, and an invasion of Europe by extra-European enemies.

St Columba (6th century): “Listen, listen to what will happen in the later days of the world! There will be great wars; unjust laws will be enacted.....the common people will believe in false ideas.”

Bishop George M.Wittman (19th century): “Secret societies will work great ruin, and they will exercise a great financial power.”

Sister Rosa Asdenti Di Taggia (19th century): “A lawless democratic spirit of disorder shall reign supreme, and there will be a general overthrow.”

Countess Francesca de Billiante (20th century): “I see yellow warriors and red warriors marching against Europe. Europe will be completely covered with a yellow fog that will kill the cattle in the fields. The nations which have rebelled against the laws of Christ will perish by fire. Europe then will be too large for those who survive.”

St Anthony of the Desert (4th century): “Men will surrender to the spirit of the age. the false maxims of irreligion and licence which are confounding all sound principles and spreading everywhere such darkness as to obscure both faith and reason.....Once again the madmen seem to gain the upper hand! They laugh God to scorn. Now, the churches are closed; the pastors run away; the Holy Sacrifice ceases. Woe to thee corrupt city! The wicked try to destroy everything; their books and their doctrines are swamping the world.”

2)The church is persecuted; the Pope flees Rome and dies in exile. The church is split, leaderless and disorganised. The New World Order is victorious.

St Pius X (20th century): “I saw one of my successors taking to flight over the bodies of his brethren. He will take refuge in disguise somewhere; and will die a cruel death. The present wickedness is only the beginning of the sorrows which must take place before the end of the world.”

St Anna-Katarina Emmerick (19th century): “I saw a secret sect relentlessly undermining the great church.”

St John of the Cleft Rock (4th century): “At that time, the Pope with his cardinals will have to flee Rome in tragic circumstances to a place where they will be unknown. The Pope will die a cruel death in his exile. The sufferings of the church will be much greater than at any previous time in her history.”

Nicholas of Fluh (15th century): “The church will be punished because the majority of her members, high and low will become so perverted. The church will sink deeper and deeper until she will at last seem to be extinguished, and the succession of Peter and the other Apostles to have expired. But, after this, she will be victoriously exalted in the sight of all doubters.”

Venerable Bartholomew Holzhauser (17th century): “Religion shall be persecuted, and priests massacred. Churches shall be closed, but only for a short time. The Holy Father shall be obliged to leave Rome.”

Jeanne le Royer, Sister of the Nativity (19th century): “I saw a great power rise up against the Church. 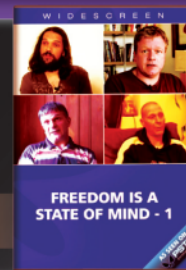

The Permanent Instruction of the *Alta Vendita*

A *Masonic* Blueprint for the Subversion of the Catholic Church



The *Permanent Instruction of the Alta Vendita* is a secret document written in the early 19th century that mapped out a blueprint for the subversion of the Catholic Church. The *Alta Vendita* was the highest lodge of the *Carbonari*, an Italian secret society with links to Freemasonry and which, along with Freemasonry, was condemned by the Catholic Church.

Fr. E. Cahill, S.J. in his book *Freemasonry and the Anti-Christian Movement* states that the *Alta Vendita* was "commonly supposed to have been at the time the governing centre of European Freemasonry." The *Carbonari* were most active in Italy and

France. In his book, *Athanasius and the Church of Our Time*, Bishop Rudolph Graber quoted a Freemason who declared that "the goal of Freemasonry is no longer the destruction of the Church, but to make use of it by infiltrating it."

In other words, since Freemasonry cannot completely obliterate Christ's Church, it plans not only to eradicate the influence of Catholicism in society but also to use the Church's structure as an instrument of "renewal," "progress" and "enlightenment" to further many of its own principles and goals. An Outline the strategy advanced in *The Permanent Instruction of the Alta Vendita* is astonishing in its audacity and cunning. From the start, the document tells of a process that will take decades to accomplish. Those who drew up the document knew that they would not see its fulfillment. They were inaugurating a work that would be carried on by succeeding generations of the initiated. *The Permanent Instruction* says, "In our ranks the soldier dies and the struggle goes on."

The Instruction called for the dissemination of liberal ideas and axioms throughout society and within the institutions of the Catholic Church so that laity, seminarians, clerics and prelates would, over the years, gradually be imbued with progressive principles. In time, this mind-set would be so pervasive that priests would be ordained, bishops would be consecrated and cardinals would be nominated whose thinking was in step with the modern thought rooted in the French Revolution's *Declaration of the Rights of Man* and other "Principles of 1789" (equality of religions, separation of Church and State, religious pluralism, etc.).

The document details an alleged Masonic plan to infiltrate the Catholic Church and spread liberal ideas within it and diabolical strategy to destroy the Church. It also tells how they do not desire a Masonic Pope, but rather a Pope infected with their ideas. Eventually, a Pope would be elected from these ranks who would lead the Church on the path of "enlightenment" and "renewal."

They stated that it was not their aim to place a Freemason on the Chair of Peter. Their goal was to effect an environment that would eventually produce a Pope and a hierarchy won over to the ideas of liberal Catholicism, all the while believing them to be faithful Catholics while unknown to them marching under the banner of Enlightenment, Freemasonry, Ecumenism and Modernism while thinking they are under the banner of the apostolic keys.

These Catholic leaders, then, would no longer oppose the modern ideas of the Revolution (as had been the consistent practice of the Popes from 1789 until 1958—the death of Pope Pius XII—who condemned these liberal principles) but would amalgamate them into the Church. The end result would be a Catholic clergy and laity

In the nineteenth century, Pope Pius IX and Pope Leo XIII both asked for it to be published. It was first published by Jacques Crétineau-Joly in his book *L'Église romaine en face de la Révolution* in 1859. It was popularised in the English Speaking world by Monsignor George F. Dillon in 1885 with his book *The War of Anti-Christ with the Church and Christian Civilization*.

"Our ultimate end is that of Voltaire and of the French Revolution—the final destruction of Catholicism, and even of the Christian idea. The Pope, whoever he is, will never come to the secret societies; it is up to the secret societies to take the first step toward the Church, with the aim of conquering both of them. The task that we are going to undertake is not the work of a day, or of a month, or of a year; it may last several years, perhaps a century.

"We do not intend to win the Popes to our cause, to make them neophytes of our principles, propagators of our ideas. That would be a ridiculous dream; and if events turn out in some way, if Cardinals or prelates, for example, of their own free will or by surprise, should enter into a part of our secrets this is not at all an incentive for desiring their elevation to the See of Peter. That

elevation would ruin us. Ambition alone would have led them to apostasy; the requirements of power would force them to sacrifice us. What we must ask for, what we should look for and wait for, as the Jews wait for the Messiah, is a Pope according to our needs.

"With that we shall march more securely towards the assault on the Church than with the pamphlets of our brethren in France and even the gold of England. Do you want to know the reason for this? It is that with this, in order to shatter the high rock on which God has built His Church, we no longer need Hannibalian vinegar, or need gunpowder, or even need our arms. We have the little finger of the successor of Peter engaged in the ploy, and this little finger is as good, for this crusade, as all the Urban II's and all the Saint Bernard's in Christendom.

"We have no doubt that we will arrive at the supreme end of our efforts. But when? But how? The unknown is not yet revealed. Nevertheless, as nothing should turn us aside from the plan drawn up, and on the contrary everything should tend to this, as if as early as tomorrow success were going to crown the work that is barely sketched, we wish, in this instruction, which will remain secret for the mere initiates, to give the officials in charge of the supreme lodge some advice that they should instil in all the brethren, in the form of instruction or of a memorandum.

"Now, to assure ourselves a Pope of the required dimensions, it is a question first of shaping for this Pope a generation worthy of the reign of which we dream. Leave old people and those of a mature age aside; go to the youth, and if it is possible, even to the children. You will contrive for yourselves, at little cost, a reputation as good Catholics and pure patriots.

"This reputation will put access to our doctrines into the midst of the young clergy, as well as deeply into the monasteries. In a few years, by the force of things, this young clergy will have overrun all the functions; they will form the sovereign's council and they will be called to choose a Pontiff who should reign. And this Pontiff, like most of his contemporaries will be necessarily more or less imbued with the (revolutionary) Italian and humanitarian principles that we are going to begin to put into circulation. It is a small grain of black mustard that we are entrusting to the ground; but the sunshine of justice will develop it up to the highest power, and you will see one day what a rich harvest this small seed will produce.

"In the path that we are laying out for our brethren there are found great obstacles to conquer, difficulties of more than one kind to master. They will triumph over them by experience and by clear-sightedness; but the goal is so splendid that it is important to put all the sails to the wind in order to reach it. Your want to revolutionize Italy; look for the Pope whose portrait we have just drawn. You wish to establish the reign of the chosen ones on the throne of the prostitute of Babylon; let the clergy march under your standard, always believing that they are marching under the banner of the apostolic keys.

"You intend to make the last vestige of tyrants and oppressors disappear; lay your snares (nets) like Simon Bar-Jona; lay them in the sacristies, the seminaries and the monasteries rather than at the bottom of the sea; and if you do not hurry, we promise you a catch more miraculous than his. The fisher of fish became the fisher of men; you will bring friends around the Apostolic Chair. You will have preached a revolution in tiara and cope, marching with the cross and the banner, a revolution that will need to be only a little bit urged on to set fire to the four corners of the world." (End of the quote from the PERMANENT INSTRUCTION OF THE ALTA VENDITA.)

The goal would be to "effect an environment that would eventually produce a Pope and a hierarchy won over to the ideals of liberal Catholicism, all the while believing themselves to be faithful Catholics," but who in reality would promote the fruit of the Enlightenment and the DECLARATION OF THE RIGHTS OF MAN: "equality of religions, separation of Church and State, religious pluralism, etc., 'the creed of Freemasonry'."

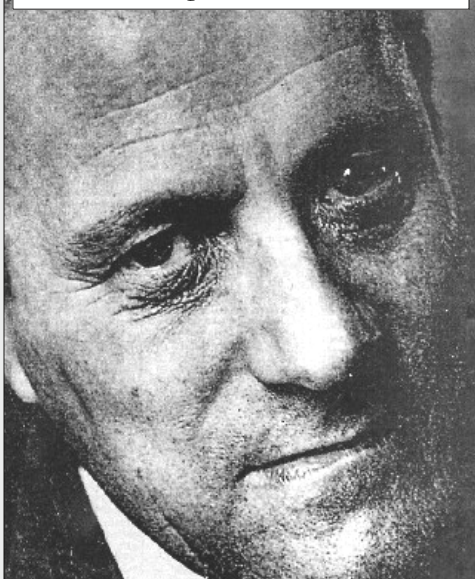
The Greatest Conspiracy Communist Infiltration of The Church

A few months back, during social chit-chat which turned with predictable concern to the modern plague of clerical apostasy, a venerable member of the Society of Jesus recounted various word-of-mouth histories of communist infiltration of the Jesuits. These included two men sent to join the Society in Italy and Spain by their respective national Communist Parties - the former having left to return to the Party in the early 1950s after more than a dozen years of study and actual ordination; the latter leaving the Society before ordination a decade ago.

More disturbing still was the case of a prominent Jesuit seminary rector in Rome who, after being run over and killed, was allegedly found to be a member of the KGB. We pondered briefly all the imponderables of such infiltration as well as the domino effect it might have set in train, like: how many students were deformed by the seminary professor down the years; how many others, clerical and lay, they in turn, as priests, had corrupted; how many other seminaries and orders were similarly infiltrated; and, above all, how many of the infiltrators and their warped protégés had risen to the episcopate.

From Communist to Catholic, Douglas Hyde revealed that the communist leadership issued a worldwide directive about infiltrating the Catholic Church.



In recent years this latter quandary in particular has emerged from the realms of much derided "conspiracy theory" to become a plausible contributory explanation for the otherwise inexplicable levels of corruption, negligence and indifference within Western episcopates. The fact that we will never precisely quantify the degree of infiltration and only rarely identify "plants" beyond all doubt, is no reason to ignore the reality.

Besides, it's not as if we hadn't been warned. Ex-communist and celebrated convert Douglas Hyde revealed long ago that in the 1930s the communist leadership issued a worldwide

directive about infiltrating the Catholic Church. While in the early 1950s, Mrs Bella Dodd was also providing detailed explanations of the communist subversion of the Church. Speaking as a former high ranking official of the American Communist Party, Mrs Dodd said: "In the 1930s we put eleven hundred men into the priesthood in order to destroy the Church from within."

The idea was for these men to be ordained and progress to positions of influence and authority as monsignors and bishops. A dozen years before Vatican II Mrs Dodd stated that: "Right now they are in the highest places in the Church" - where they were working to bring about change in order to weaken the Church's effectiveness against communism. She also said that these changes would be so drastic that "you will not recognise the Catholic Church."

Mrs Dodd, who converted to the Faith at the end of her life, was personally acquainted with this diabolic project since, as a communist agent, part of her brief was to encourage young radicals (not always card-carrying communists) to enter Catholic seminaries. She alone had encouraged nearly 1,000 such youngsters to infiltrate the seminaries and religious orders! One monk who attended a Bella Dodd lecture in the early 1950s recalled:

"I listened to that woman for four hours and she had my hair standing on end. Everything she said has been fulfilled to the letter. You would think she was the world's greatest prophet, but she was no prophet. She was merely exposing the step-by-step battle plan of communist subversion of the Catholic Church. She explained that of all the world's religions, the Catholic Church was the only one feared by the communists, for it was its only effective opponent.

"The whole idea was to destroy, not the institution of the Church, but rather the faith of the people, and even use the institution of the Church, if possible, to destroy the faith through the promotion of a pseudo-religion: something that resembled Catholicism but was not the real thing.

"Once the Faith was destroyed, she explained that there would be a guilt complex introduced into the Church.... to label the 'Church of the past' as being oppressive, authoritarian, full of prejudices, arrogant in claiming to be the sole possessor of truth, and responsible for the divisions of religious bodies throughout the centuries. This would be necessary in order to shame Church leaders into an 'openness to the world,' and to a more flexible attitude toward all religions and philosophies. The communists would then exploit this openness in order to undermine the Church."

This conspiracy has been confirmed time and again by Soviet defectors. Ex-KGB officer Anatoliy Golitsyn, who defected in 1961 and in 1984 forecast with 94% accuracy all the astonishing developments in the communist bloc since that time, confirmed several years ago that this "penetration of the Catholic and other churches" is part of the Party's "general

line [i.e. unchanged policy] in the struggle against religion."

Hundreds of files secreted to the West by former KGB archivist Vassili Mitrokhin and published in 1999 tell a similar tale, about the KGB cultivating the closest possible relationships with 'progressive' Catholics and financing their activities.

One of the leftist organs identified was the small Italian Catholic press agency Adista, which for decades has promoted every imaginable post-conciliar cause or "reform" and whose director was named in The Mitrokhin Archive as a paid KGB agent. Interestingly, just prior to the Mitrokhin exposé it was little Adista that ultra-modernist Cardinal Martini utilised to diffuse his dissident rant at the 1999 European Synod, where, among other things, he called for a "new Council".

What is often lost in all of this, however, is that communism (along with the New Age movement) is simply a chief tool of Freemasonry; its policy of Church infiltration just an extension of the Masonic plan clearly laid out in the Alta Vendita and other bona fide Masonic documents recognised by the Popes. Even experts like Anatoliy Golitsyn have failed to grasp this point.

In The Perestroika Deception (1996), his collection of very accurate analyses and forecasts submitted to the CIA during the period 1985-95, he hints at a controlling force behind Soviet communism but lacks "the facilities to study how it might be operating" under cover of some "front" organisation.

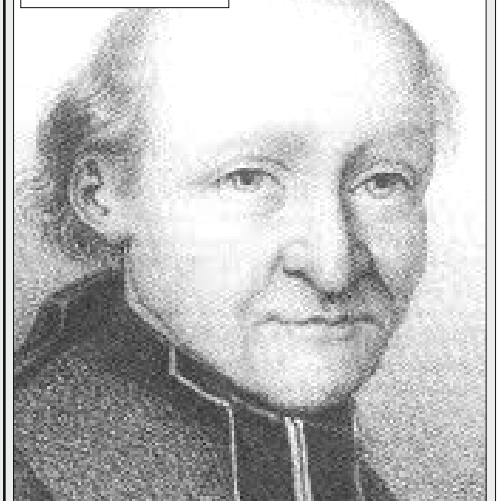
At the same time he complains that despite public plaudits for the accuracy of his forecasts, Western leaders have regularly ignored his

The agent died in the hospital after a car accident. The nurse (Marie Carre) who attended him found the memoirs in his brief case. After she read it, she decided to publish the memoirs for the world to know why the Catholic Church has been undergoing destructive changes to the lament of its faithful. The English translation is published under the title *AA 1025, The Memoirs of an Anti-Apostle* by Editions Saint-Raphael, 31, rue King Ouest, Suite 212, Sherbrooke, Québec, Canada, 1988.

Marie Carre gave him the name Michael. He stated in the memoirs that he was forced by some irresistible urge to write. He intended to destroy the memoirs so nobody could read it. Michael met a French girl whom he named "Raven Hair." They loved each other. He tried to persuade her to support his cause in destroying the Catholic Church. As a devout Catholic, she steadfastly refused to join him.

Despite all sophisticated arguments he had used successfully to mislead even the clergy in the Church. He failed miserably before a seemingly ignorant girl. Her letter to him is a little masterpiece of apologetic theology. Despite her love for him, she was opposing his atheism, defending God and the Church. Yet, she said she would sacrifice her life to save him. She entered the Carmelite Convent to pray to God in his name.

Michael writes: "She was there for my sake, she would have her hair cut for my sake, she would pray for me all her life, she would be behind gratings for my sake; never anymore would she have the least lover's joy for my sake." If he was saved, it would be due to a great grace gained from her sacrifice and atonement for his sins.

Michael was born in 1917, probably from Russian parents fleeing the Revolution. A Polish doctor and his wife found him wandering along the road at the age of three. The couple were devout Catholics but had no child of their own. They adopted him and loved him as their own. In his confession Michael relates that the Polish couple were very good to him, very generous, and full of affection.

When he reached fourteen, his happy life changed. He overheard his parents mentioning that he was



not their son. They were worried about obtaining a passport for him to go with them to Rome and Paris. He had been brought up to believe that they were his real mother and father. The revelation of his real status in the family shocked him and caused instant hatred for his parents. He decided to run away from home and met a friend who introduced him to his uncle who was a high-ranking official in the Russian Secret Police.

Michael had completed 6 years of study and by now was 20 years old. He was called to the office of the uncle, who told him: "I am now going to send you to practise a militant and international atheism. You will have to fight all religions, but principally the Catholic, which is better organized. To do so, you will enter a seminary and become a Roman Catholic priest. To be able to enter a seminary, you will have to return to Poland, reconcile yourself with your adoptive family and present yourself to the bishop."

The uncle added: "A secret agent has no blood in his veins, no heart, loves no one, not even himself. He is the thing of the Party, which will devour him alive and without warning. Keep this well in mind that, wherever you will be, we will watch you and get rid of you at your first imprudence. It is to be well understood that if you are in danger, even without it being your fault, you must not rely upon us. You will be disavowed. Hatred, except the hatred of God, at Lenin's example, does not enter into our services.

"I need that you be accepted by a true bishop of your native country, Poland; but we do not intend to have you pursue your religious studies in that country. No, you will be sent to a country across the Atlantic, but this is confidential and you will simulate surprise when you receive that order. Yes, we are led to fear a European war with that fool who rules Germany. Therefore, it seems wiser to have you study somewhere else. Canada, for example. We have another motive also. It is that European seminaries are much stricter than those of America."

The uncle gave further instructions to Michael: "The ten persons, who will be directly under your orders, will never know you. To reach you, they will have to pass through me. Thus you will never be denounced. We already have in our service numerous priests in all countries where Catholicism is implanted; but you will never know one another. One is a bishop. Maybe you will enter into contact with him. It will depend upon the rank that you reach.

"We have spies everywhere and particularly old ones who follow the press of the whole world. A compendium will be sent to you regularly. We will easily know when your own ideas have made their way into peoples' minds. See, an idea is good when some idiot writer presents it as one of his own. Nobody is more conceited than a writer. We rely much on such writers and we do not have to train them. They work for us without knowing it

there are other holy persons among the Protestants, the Moslems and the Jews, etc. So that all men could enter it (this Universal Church), it could retain a vague idea of a God more or less Creator, more or less Good, according to times. Moreover this God will be useful only in periods of calamity. Then the ancestral fear will fill these temples, but in other times they will be rather empty."

The Uncle thought it over a good while, and then he said to Michael: "I fear that the Catholic clergy will quickly notice the danger and be hostile to your project."

Michael said: "This is what has happened until now. My idea was launched by Non-Catholics and the Catholic Church has always closed its doors to such a program. It is precisely why I want to study the way to make it change its mind. I know that this will not be easy. That we will have to work hard at it, for a period of twenty or even fifty years; but that we should succeed in the end."

The uncle asked: "By what means?"

Michael replied: "By numerous and subtle means. I look at the Catholic Church as if it were a sphere. To destroy it, you must attack it in numerous small points until it loses all resemblance to what it was before. We will have to be very patient. I have many ideas that might seem at first sight to be petty and childish; but I maintain that the entirety of those petty childishnesses will become an invisible weapon of great efficacy."

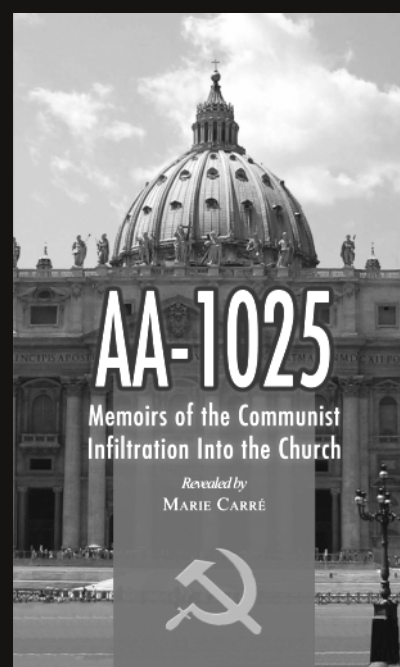
Eight days later, Michael met the uncle's chief whom he described as a monster, a brute with a combination of brutality, coarseness, ruse, sadism, and vulgarity.

The chief told Michael: "From now on, you are on the list of our active secret agents. You will give orders every week. I rely on your zeal. NIL BY MOUTH - THE BAN OF VITAMINS

Before long our access to traditional remedies which have been successfully used to prevent and treat a wide range of ailments for centuries, will be completely blocked, as the European Food Safety Authority (EFSA) has decided to slowly but surely clamped down on herbal medicines.

In April of this year (2011) the EU Traditional Herbal Medicine Products Directive (THMPD) has been implemented and thousands of products that used to be distributed by specialist herbal suppliers will almost be difficult, if not illegal, to sell.

Back in 2009, the European Union (EU) proposals were threatening to eliminate and reduce the effectiveness of many herbal remedies. Actress Jenny Seagrove who had campaigned against the directive said:” The ridiculous thing is that the directive has nothing to do with safety, that is a complete smoke-screen. This is about a bureaucratic attempt to harmonise regulations across the EU.”

It is clear that the arrogant nature of the European Union who seems to dictate the

health of us all is utterly outrageous. Touted as a way of protecting people's health, it is only designed to benefit big drug firms. A vast campaign was done against the ban. More than 300 doctors wrote to the Prime Minister in UK to oppose it, while a million Britons signed a petition against it. Some 20 million Britons take supplements every day. Yet, their voices were not heard once again.



Levels of minerals and vitamins in modern diets are dropping as intensive agriculture and GM foods leeches them from the soil and of course, people eat more processed food. Research shows that not eating enough of them raises the danger of cancer and heart disease. Though some evidence suggest that some alternative medicines may have harmful effect if taken in ridiculously high-doses, there are also some research that suggests certain side-effects of the drug companies' products which are the fourth biggest cause of death in the U.S.

The directive inhibits the sale of vitamins and minerals unless they are on an “approved list”. Compounds like caustic soda, used to clean drains and sodium fluoride, a pest killer are on the permitted list meanwhile sulphur, important for the skin, and boron, valuable for healthy teeth and bones are to be banned. Yet, a recent research has found that the plant Hypericum Perforatum also know as St John's Wort to treat depression had positive effects on patients suffering from depression, as well as fewer side-effects than Prozac or Seroxat. Some supplements are relatively well-researched. Two major epidemiological studies have shown that Vitamin E

supplements, for instance, can reduce the incidence of heart disease by 40% while a substantial body of research have suggested that antioxidant vitamins protect against certain diseases.

A key principle of natural medicine as the Hippocratic requirement “Primum no nocere” or “first, do no harm” seems not to be considered as at the moment, supplements are sold under food laws, which means they have to be as safe as a loaf of bread. Yet, conventional drugs are sold on a costs versus benefits basis. Side-effects are simply an accepted part of the pharmaceutical drugs.

As adults, we are no longer in control of our own health matters as Brussels and its bureaucrats are always there to remind us what to do and when to do it. So much for Hippocrates that once said:” Let food be your medicine” as new EU laws will say that a product must be either one or the other.

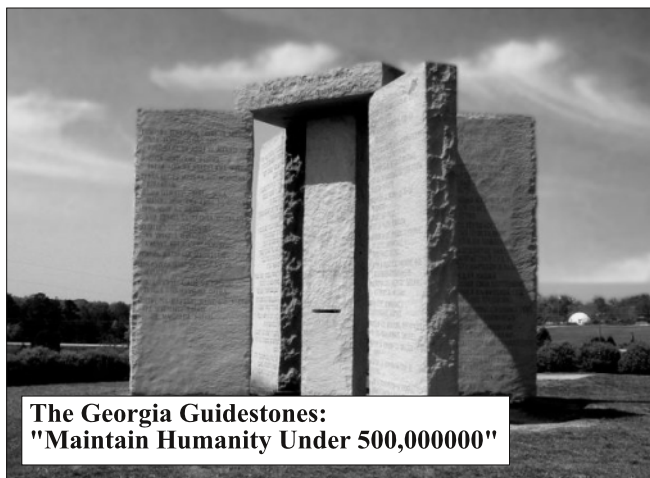

You would be entirely at the mercy of whoever controls the RFID technology, i.e., the government. The RFID microchip would become a singular instrument of control over the life and death of everyone on the planet. Iceland: Ireland’s Role Model For A Real Republic

The Irish Government has plans for a constitutional convention over the coming months, but what will this entail? Rumours abound that references to *Lord, Jesus Christ and God* will be removed, abortion will be legislated and Irish citizens abroad will be able to vote on plebiscites. For some, it is hard to comprehend that whatever happens to the certain small book called *Bunreacht na hEireann* will invariably affect the lives of many people in many different ways. Others share concerns that if such references to *Lord, Jesus Christ and God* are to be removed from the state’s constitution and the state is to remain a representative democracy, would these amendments convene to portray that the state is God?

Will citizens be given a say in lawful matters before they are passed by Ireland’s government or the parliament of the European Union?

This event is certainly an historical opportunity which should be regarded by those 100 members yet to be selected as a vast turning point in the direction of our small country inside this financial tsunami and the political dynamics of every nation with thorough economic independence should also be taken into consideration for this convention.

The following is a report on the past experiences of our small neighbouring country, Iceland, during the current global economic crisis. Ireland has much to learn about Iceland’s recovery, however, this is an ongoing success story continually neglected by the corporate main-stream media.

It all started in December 2009 when the government of Iceland presented a bill to **President Olafur Ragnar Grimsson** and urged him to sign it within 14 days before it faced a vote of the citizens. In accordance with Iceland’s fundamental democratic principles, the President refused to sign the bill, regardless of opposition from the government.

"It is the cornerstone of the constitutional structure of the Republic of Iceland that the people are the supreme judge of the validity of the law" said the President.

Grimsson then scheduled a meeting for the 2nd of January with a movement called *"InDefence"* which had gathered an Initiative [petition] that had quickly collected up to 62,000 signatures calling for a referendum on the bill, before it was enforced. This bill was for a new agreement with Britain and the Netherlands to force Iceland to pay £3.1bn to compensate savers who lost money in an online bank called *"Icesave"* following the collapse of Landsbanki and saddling each Icelander with £11,000 of debt.

Importers couldn’t get trade finance for food. We feel deeply wronged," said **Johannes Skulason** from InDefence. Shelves were bare for weeks in Icelandic shops as the banking system disintegrated.

Einars Már Gudmundsson, a novelist, said "I had never heard of Icesave till this happened...



"We were told that what these banks did abroad was nothing to do with us but when it all went wrong the responsibility fell back on us. Profits were privatised, but losses were nationalised."

He added "We’re told if we reject the terms, we will be the Cuba of the North. But if we accept, we’ll be the Haiti of the North."

On the 6th of March, 2010 the *"Icesave referendum"* was held and resoundingly defeated by 93% of voters who refused to swallow the medicine of austerity.

On the 27th of November 2010, for the first time, in the history of the world, thirty one citizens from this small independent republic were selected under reconciliation for forming a Constitutional Assembly to review and restructure the nations laws through a process called *"direct democracy"* influenced by a social covenant born from the soaring unemployed outside the Althingi Parliament during the Pots and Pans Revolution. This became the result over the cost of living and collapse of the krona, that wreaked political and economic havoc which forced the government to turn to the IMF for a bail-out of £1.3bn in November, 2008. When Iceland’s banks began collapsing in October 2008, the former UK’s P.M. Gordon Brown, declared Britain’s new enemy labelling Iceland as a "terrorist state" seizing the assets, provoking a backlash of feeling and escalating resentment towards the small country of 320,000 Icelanders under the protectorate of Norway.

Iceland’s amended constitution established a new **Direct Democratic process** which fashioned public debates on the foundations and values of their society and the discovery of incompetence and misdeeds inside the private and public sector that were steeped in corruption. The new constitution of Iceland had been drafted from the material of one thousand randomly chosen Icelanders who offered their views through social media which helped encourage further legal proceedings towards an investigation into the *Central Bank, MP Bank, Kaupthing Bank, and Straumur Bank*. These proceedings lead to the arrest of 3 parties, including **Jon Thorsteinn Oddleifsson**, former *Landsbanki* treasury boss. Landsbanki was found to had taken retail deposits from more than 400,000 British and Dutch

customers through the online product *"Icesave"*. Two months later, seven men were arrested by the British Fraud Office in London, including two well know property tycoons, **Robert Tchenguiz** and his brother Vincent, who had been responsible for bringing down three of Iceland’s banks, such as the Kaupthing Bank, owing more than \$50 billion to creditors and local authorities.

The moment the mechanisms of initiative and referenda had become legislation, shortening the gap between citizens and representative government, the Icelanders began the road to certain economic recovery which became the next example proving that Direct Democracy will prevail.

In Switzerland, citizens also have the right to propose almost any constitutional amendment. However such an amendment cannot, of course, violate the international law on human rights. Putting forward such an initiative in Switzerland, citizens need to gather a minimum of 100,000 signatures within 18 months.

Many results show that when people become actively involved in the political decision making process, the call for protesting diminishes and feelings of anger, fear and despair throughout society become eradicated. Therefore such behaviours resonating with the mentality of **helplessness and apathy** are substituted with the senses of **ownership and pride**, thus producing a happier and preferably responsible society with much lower crime rates. Through online technology, higher level of involvement has many potential upsides, including the possibility of improving government efficiency - thereby saving public money.

In Ireland it is becoming common knowledge that the members of the *1922 Constitutional Committee of the Irish Free State Constitution*, previously made provisions for a more direct democracy through Articles 47 and 48 before ratification of the 1937 Constitution. Therefore we must convince those soon to be selected of Ireland’s upcoming Constitutional Convention to reinstate the forgotten citizen’s initiative and make 2012 the birth year of a Real Republic.

A Real Republic is when citizens finally embark on being constitutionally empowered to restructure bureaucracy towards mutually assured prosperity.

Government tree sell-off plans stumped.

The Government’s plans to sell off the state’s forests could hit a brick wall due to the fact that over one million native woodland trees are owned by every family in Ireland.

As part of the Year 2000 People’s Millennium Forests Project, Household Tree Scheme, over 1.2 million native Oak, Ash, Birch, Alder and Scot’s Pine trees -many of which are now semi-mature-were gifted to every family and planted in 16 forests throughout the country. The government later issued ownership certificates with individual plot numbers to every household.

The Certificates and covering letter which were signed by the late Seamus Brennan, who was the then Minister of Environment and Chairman of the Millennium Committee stated:

"It gives us great pleasure to enclose the certificate of authentication of your household’s special tree for the millennium. This certificate gives the location of your native tree and assigned forest. Your tree is one of 1.2 million being planted for households in Ireland..."

Coillte’s The People’s Millennium Forests website is even clearer as to who owns the trees. It states that 16 native Irish woodlands have been designated as: "millennium forests, and are dedicated in perpetuity to the people of Ireland....."

"The project team was asked to do this so that the people of Ireland would know that each household has part-share in the restored woodlands. The message was plain – these native woodlands are for the people of Ireland."

The Woodland League has now raised the prospect of a tidal wave of lawsuits if the government tries to interfere with or sell off the native trees. According to founder Andrew St Ledger:

"Any sell-off could be open to a million lawsuits because every household in Ireland got a tree for the Millennium woodlands planting. People were even issued with certificate of ownership of a tree accompanied by a map with a grid which shows you the plot."

Prominent Dublin based lawyer and solicitor Damian Cassidy concurs and believes that the ultimate ownership of the millennium native woodland trees could be the government’s undoing if they attempt any sell-off:

"The documents which were issued to householders during the Millennium are certificates of ownership and the people who own them must be consulted as to any interference with the trees. Some people might not want their trees cut down," he added.

The Woodlands League which is dedicated to preserving Ireland’s native woodlands and fauna has been robustly campaigning to keep Coillte in public ownership and from falling into the hands of foreign investment fund managers. They are presently running a petition which has over 32,000 signatures:

"These forests are the inheritance of Irish children and managed wisely can help secure Ireland’s social, environmental and economic future. The forests include some of our most valuable native woodlands and wild places and are some of the last refuges of our native flora and fauna. We are urging everyone to go

out and visit their family tree, added Andrew St Ledger.

According to Coillte spokesperson, Tom Byrne, the millennium woodlands project has been deemed a huge success:

"A native tree was planted on behalf of every household in Ireland and a certificate was posted to all homes giving details as to where trees were planted under the Family Tree Scheme. The Millennium trees which are native varieties were planted in old native woodland sites, and the idea was to bring the woodlands back to life. Thirteen sites are on Coillte land, two in Northern Ireland and one in Muckross."

"The trees were planted for the people of Ireland as part of the Millennium celebrations. These forests are managed by Coillte in partnership with Woodlands of Ireland, OPW and Northern Ireland Forest Service."

"Not every tree that was planted would have survived, but this project has been a success and has re-established these old woodlands."

However when asked as to who has legal title to the millennium trees and what would happen in the event

of a sale Coillte refused to comment:

"We would not like to comment on a hypothetical question," added Tom Byrne.

Tarbert based environmental campaigner, Tom Donovan, is part of a growing number of people who has vowed to fight tooth and nail to protect the woodlands and evergreen forests:

"We won’t be taking this lying down we will fight the Government to the bitter end. I and a lot of people are very angry about the sell-off of our native woods. They are an asset of the country, but they are also part of our heritage and history."

"Every household in Ireland was given a tree and what we are encouraging people to do is to get up and get out and walk in the woods."

Coillte owns 1.1 million acres which is the equivalent of 7% percent of the country: 95% percent of the trees on Coillte Estates are non native evergreen conifers and the remainder are broadleaf. Ireland has the lowest forest cover in Europe. However the long-term goal of Coillte is to have 30% percent of the country under forest by 2050.

Surely, no tragedy is more heartrending than suicide; particularly when the person is young. When a person dies slowly of old age or disease, loved ones have time to say farewell. Sudden death is much harder, but worst of all is the aftermath of suicide. The guilt, the shame and the torture of unanswered questions are cruel. The cold statistics show that for every completed suicide, there may be twenty more attempted. Some result in permanent physical damage; all leave indelible, mental scars. Survivors may suffer agonising remorse, isolating stigma and lifelong, psychiatric supervision. Family and friends may have a nagging anxiety: “will they try it again”. What torment could be more acute, than minding a person whom you love, who wants to destroy them self?

Our lives have all been touched by suicide to some degree. It kills many more people than road traffic. With a conservatively estimated 60,000 attempted suicides in Ireland every year, we have a big problem. And yet, it is generally unreported. Instead, the mainstream media orchestrates mass hysteria about, E. coli, and hoax flu pandemics; inciting, obsessive anxiety about fake threats, such as the Iraqi “weapons of mass destruction” to justify the next power grab or invasion. Not only do they fail to address the problem; but such irresponsible, sensational, propaganda, may actually contribute to suicidal thoughts.

What must a person be feeling in order to override every instinct for survival and self-preservation? Some may believe that there is no way to overcome or escape their problems. They may be desperate to end the unbearable mental anguish that they are experiencing. Others may enter such a spiral of self-loathing that they become convinced that it would be better for everyone if they were gone. But all speculation tends to focus on the individual in their darkest moments and may lead us to ignore the environmental factors, which brought them to the brink.

There is a tendency in modern medicine, especially in psychiatry, to blame the individual for their affliction. Claiming that faulty genes, chemical imbalance or unhealthy behaviour are the root causes. The Diagnostic and Statistical Manual of Mental Disorders has narrowed the range of what is considered healthy to such a degree, that serious disorders are now applicable to every one of us! When a person is bereaved or heartbroken, they need to be reassured that they are going through normal human emotions, and that in time, they will feel better so long as they maintain a healthy living environment. But all too often, the medical industry diagnoses them as mentally ill and prescribes drugs.

The cancer epidemic is a parallel disaster. Since the 1950’s, cancer rates have been rapidly increasing. There are over 20 times as many cancers in adults now and at least 200 times as many children afflicted. This is clearly not a genetic change. Nor can we blame a sudden dramatic change in people’s behaviour. We should logically lift the focus and condemnation away from the victims and examine the environmental factors, which are giving rise to the plagues of cancer and suicide that are ravaging our society.

Sudden major changes such as these, must have causes. The presence of new contributing factors and the absence or reduction of inhibiting factors must be examined if we are to learn about prevention. Sadly, the billions spent on cancer research, focuses on treatment and management of the disease; a very lucrative revenue stream for big pharma. Recently, research labs were found to be doing worthless work on samples, which did not even come from human tumours. Some of these institutions are little more than charity funded, PhD factories.

Cause and effect confusion: Everyone has heard stories like the Granddad who smoked 80 a day and lived till he was 95, which are cited as arguments that smoking is healthy. Humans are diverse and show massive variation in sensitivity to environmental hazards. If a 100 people were given a small dose of poison, several would be completely unaffected while the majority would suffer varying degrees of sickness. But a few would die. This confuses things. The dose wasn’t altogether deadly, nor was it harmless. Long delays also obfuscate causes. If the survivors develop health problems 10 or 20 years later, these may not even be attributed to the poison. Similarly, some factors may be significant only in combination with others. Yet more confusion! The acid test is to compare control groups such as the Amish who reportedly have less than 1 in 2000 autistic children whereas it now afflicts as many as 1 in 60 boys in many areas. Perhaps those with higher sensitivity who are first effected, should be thought of as being canaries in the coal mine; because they warn us that our environment has become unhealthy.

If we identify the environmental factors, which contribute to cancer or suicide, we have an opportunity to take preventative measures. The recent increase in suicide must correlate to something or a combination of things, which are relatively new. The following are some of the potential perpetrators.

· **Overload:** Like any other part of our bodies, overloading our minds can cause harm. Extreme emotions, coupled with exhaustion and stress can cause something to snap. But like a broken leg, our brains will heal when given the right support.

· **Sunshine:** We have all noticed that everyone is more cheerful when the sun is shining. Many of us find a winter holiday in the sun fortifying. There is even another “disorder” – SAD, which medicalises this common phenomenon. Sunlight on our skin is know to facilitate the synthesis if vitamin D. Sunlight entering our eyes affects our pineal gland; which in turn impacts on health and well being. But we are told to cover up, wear sunglasses and carcinogenic sun cream. Global Dimming, and Chemtrails may also exacerbate the shortage of sunshine.

· **Drugs:** Many of the drugs prescribed for depression are know to cause suicidal or violent episodes. The drug inserts actually carry warnings to this effect. Can you believe that drugs, which actually cause suicidal thoughts are given to people in a vulnerable state of mind! Why those who manufacturer and prescribe them, are not prosecuted for manslaughter, is a mystery. Most of the SSRI drugs contain fluoride, which is also known to have a marked effect on the pineal gland. The Nazi’s used fluoridated water to keep prisoners passive. Now we see it deployed again, in modern tranquillisers as well as our water.

· **Nutrition and exercise:** We all feel better after a walk in the fresh air. After a good meal, we often enjoy a feeling of well-being. But the reverse is also true. As a person becomes depressed, they may enter a vicious cycle of eating badly and not exercising. Research has shown that treatment for depression that focuses on these issues, is far more effective than the marginal improvements claimed by pharmaceutical manufacturers who seek to “manage” (i.e. maintain) illness rather than cure it.

· **The phrase:** “mad as a hatter” came about because hat making used to require mercury, which progressively destroyed hatters’ minds. In addition to mercury from, vaccines, fillings, tuna fish, and other pollution, aluminium, titanium and other poisonous metals are attacking our brain tissues. Fluoride is not only devastating on it’s own, but it is extremely chemically reactive and forms harmful compounds with other minerals. Some of which hammer the pineal gland others degrade arteries etc.

· **Malnutrition:** Incredulously, malnutrition is probably as ubiquitous as poisoning. Foods are grown on depleted soils. Modern agriculture and food processing reduces the nutritional value of our foods. GMOs make food toxic. The work of Dr. Andrew Wakefield and Dr. Natasha Campbell-McBride among others, has shown that a malfunctioning digestive system leads to a pernicious combination of poisoning and malnutrition which causes Autism, Epilepsy, ADHD, Depression and other symptoms of an assaulted brain.

· **We all know that hormonal changes can have a marked effect on our mood. Puberty, maternity and menopause are the most dramatic examples. So what emotional effects can we expect from the hormone mimickers such as bisphenol A, which contaminate much of our food and drinks?**

· **Electro-magnetic radiation:** This is the invisible energy that is generated for wireless signal transmission. Its power diminishes by the square of our distance from the source; double your separation and quarter your exposure. Powerful sources include radio and TV transmitters but these are usually at a safer distance. Nearby mobile phone towers are a more serious hazard. Modern homes are now buzzing with signals. WiFi and cordless phones pollute our living and sleeping spaces. But closest of all are the mobile handsets that we press against our skulls. Some people have pointed out that the frequencies selected for mobile networks “co-incidentally” are those that do the most damage to our DNA. Harmful fields also surround high voltage electricity cables.

· **Social networking has downgraded the meaning of friendship and redefined socialising. Instead of**

talking to family, friends or neighbours face to face, we turn our backs on them to stare at computer screens; fascinated by updates to the contrived, public personas of our electronic acquaintances. There is a growing body of evidence that the devotion of large portions of free time to these sites is causing social dysfunction and depression.

You can do your own research into each of these individual environmental factors; but bear in mind the multiplying effect of combinations. The innumerable permutations for these toxic cocktails, coupled with variable individual sensitivity, means that the effects of interactions are impossible to predict.

In addition to the external environmental factors, there is the question of modern culture, ideology, morals and morale, which afford the furnishings of our internal mental habitat. Every day, from the moment that the clock radio awakens us, we are swamped with centrally controlled media. Indoctrination starts young. Pre-school children now spend more time watching TV than any other age group. John Taylor Gatto et al, have proved that the so-called education system is deliberately designed to restrict and pervert our development. Schooling constitutes 18,000 hours of induction into our dysfunctional system. It is little wonder that school damages many children.

A culture of death: Although our society isolates most of us from witnessing actual birth and death; we are surrounded by simulated death and are immersed in a culture that reveres killers. Torture is being normalised through films. G. W. Bush proudly announced that he ordered torture and has still not been arrested for this war crime. Soldiers are presented as being the ultimate, heroic patriots while in reality they are simply obedient killers. And we wonder where people could possibly get the notion that death is the answer?

We are being de-moralised. Our basic human instincts and right to life is being undermined. The utilitarian, collectivist culture being instilled by the New World Order into Europe, is as ruthless as an ant or bee colony. The common good is paramount, the individual is nothing, and those who are of no use to the system should do the right thing and accept euthanasia. How can people who have no work and youngsters with no prospects resist accepting the label “useless eater” that this new doctrine decrees?

Mobile euthanasia units are now being deployed in the Netherlands. Doctors there, will soon be given the power to prescribe euthanasia for patients suffering from conditions such as “incurable loneliness”. Medical ethics “experts” are now pushing to extend the acceptable age for medical infanticide way beyond the womb, and even up to the age of three. Bill Gates promotes death panels, promising that we can employ more teachers if we let granny die. The central purpose of society: that of co-operation for mutual survival and prosperity has been overturned. Life is becoming devalued. Depopulation is the politically, expedient, priority demanded by the green fascists.

Hedonistic nihilism is the new morality. How could a person’s conviction of self worth not be challenged by all of this?

An even more sinister aspect of suicide is actual mind control: Death education has become part of the school curriculum in many countries. Prior to the Columbine High massacre of 1999, students were taught to embrace death. One student who after the course attempted suicide, said that they were taught that “death was exciting, an escape and something to look forward to”. Poole High School recently made the news when one mum objected to her daughter being taught about euthanasia and suicide as part of the Medical Ethics unit in Religious Studies. The cluster of young suicides in the locality of Bridgend in South Wales shows a suspicious anomaly. I apologise for having to be explicit; but most girls who commit suicide do not hang themselves as they did in Bridgend.

Brian Gerrish who has helped expose Common Purpose and their use of NLP mind control techniques has studied the tragedies in Bridgend. One trail leads back to a George Sorros funded eugenics programme that has led to such things as young people being told to practise writing suicide notes! The “Nudge” technique is also used to direct people toward self-destruction. Are all of those who take their own lives, responsible for their actions? Or are some of them victims of a wicked plot?

Perhaps what keeps humans healthy isn’t that hard to work out. We evolved in tribes, where we worked, ate, talked, danced and sang together. We were outside most of the time. This must afford a sense of security and confidence that few of us in modern society will ever experience. We don’t know the bonds of co-operation for mutual survival that our ancestors had. We have become the dependants of our employers or the state and so we feel vulnerable, like lost children. Could this be contributing to malaise?

This is the bottom line: The Elite exploit and abuse us mercilessly; but they know that we could shrug them off our backs at any moment. They recognise that the extreme privilege they enjoy, depends on their ability to dominate us. They see themselves as predators; able to prey on us because they possess superior cunning and ruthless determination. But we hopelessly outnumber them, so the last thing they want is a level playing field. “May the best man win” is not their M.O. Winning by being the best is too unreliable. They slant all rules in their favour, withhold information and go to extreme lengths to make us weak, demoralised, disorientated, and incoherent. The common people are the only threat to this cabal of global Elite; therefore we are their enemy and are assaulted, disintegrated and repressed by every conceivable means. Are some of the poor souls who commit suicide our canaries? Should their deaths serve to warn us, that we are all under attack?

The contamination from radioactive waste is a deadly threat to the health and future of mankind. It is vastly more serious than the polluters within the Military Nuclear Complex want us to know. Much of the alarming data on nuclear pollution is disguised or buried completely. A good illustration of serious corporate pollution and duplicity is the Savannah River Site (SRS) in South Carolina.

As a military nuclear site, Savannah River began using heavy water in 1953 to produce plutonium and tritium for the U.S. nuclear weapons programme. Although the last reactor was placed in cold shutdown in 1996, the site contains the largest amount of radioactive waste of any nuclear weapons site in the United States (Makhijani, Boyd 2004).

SRS encompasses an area of 310 square miles of diverse wetlands, once home to some of the greatest wildlife variability in the world. The enormous site has 5 reactor complexes, 230 miles of highway, and 153 scattered dumps for toxic waste and radioactive debris, all hidden behind a veil of forest pine planted by du Pont de Nemours.

The site was created by uprooting whole towns like Ellenton, Barnwell, and others, leading to the forced evacuation of the inhabitants to surrounding areas. However, the politically charged problems of SRS receives little attention in South Carolina because of the depressed economic situation in the area.

For over three decades, undercover production of plutonium and tritium left South Carolina with more high-level radioactive waste than anyplace known on earth. Currently the site is being developed for a facility to produce MOX fuel which is expected to be in production by next year. (MOX, or Mixed oxide fuel, is a nuclear fuel that contains plutonium and uranium.) The clean-up of toxic waste that has been accumulating since 1953 will end up costing U.S. taxpayers an colossal amount of money.

An ongoing Environmental Impact Statement (EIS) was finalized in May, 2002, and is now available online. Until early 1990, the EIS was conducted by Environmental and Chemical Sciences until the company was bought out by Normandeau Environmental, ironically owned by Edward Teller, known as 'the father of the hydrogen bomb'. This EIS may not have come about except for the initial efforts of the Hart family and the Energy Research Foundation who mounted legal challenges against the 'bomb' plant. Joining with the Natural Resources Defense Council, the ERF sued the Department of Energy (DOE) for refusing to do an environmental impact statement.

Soon they were joined by several regional environmental groups like Georgia's Coastal Citizens and, halfway through the proceedings, by the state of South Carolina. These alliances won the lawsuit and significantly delayed the L Reactor start-up (finally commencing in July, 1954). And they also changed the tenor of South Carolina's plutonium processing program, requiring the DOE to conduct an environmental impact statement.

L Reactor closed down in June of 1988 but Ronald Reagan wanted to restart the reactor and produce fissile material for an astonishing 21,000 new

ballistic missiles. To meet the arsenal's new demands for plutonium, the DOE decided to restart the aging L Reactor. But this resulted in a protracted battle between the DOE and environmentalists. After its restart, L Reactor closed down for good in 1991. Aside from L Reactor, the last of the 5 reactors to close down were P Reactor and K Reactor, both closing in August, 1988, and July, 1992, respectively.

The 'old school' nuclear complex at SRS used reservoirs to cool the reactors. Each reactor had its own cooling reservoir which would encompass 1000's of acres. In the case of L-lake it covered 1300 acres with a depth of 64 meters at the dam. The principal ecological issue, apart from the release of radioactive contaminants into the environment, was thermal effluent discharge from the reactors which impacted the wetlands and swamp delta that eventually flowed into the Savannah River.

The Savannah River, an ancient and richly diverse aquatic system, is the main tributary which meanders through Georgia and South Carolina making its way 250 miles before entering the Atlantic. Incredibly, the thermal effluent was often as hot as 1500F at the mouths of Steel Creek, Beaver Dam and 4 mile Creek, before entering into the Savannah River, which was a few kilometers from where the effluent was discharged from the reactors.

This had major implications for aquatic plants and animals, macro invertebrates, macrophytes and the limnology of this ecosystem. Essentially the entire wetland system and swamp Delta was in a state of thermal flux, thus having serious impact on the ecological dynamics of the region and ultimately the Atlantic.

The radioactive mountain of waste stored at the site was first exposed by an unlikely whistle-blower, Bill Lawless. Within a year of quitting his DOE post as project manager of the plant's Burial Ground, where radioactive waste and toxic chemicals are buried or poured into pits, Lawless testified at the trial of protesters who had been arrested for trespassing at the facility's entrance.

Lawless's testimony was the first revelation of the deceptive and unsafe practices that had remained secret since the 1950s. His most famous confession was about the 'cardboard boxes', which concerned radioactive wastes that were so concentrated and dangerous that protocol mandated that they be buried in double-walled tanks; but they were actually buried in plain old cardboard boxes.

DuPont and DOE, according to Lawless, had two sets of data from which they analyzed the rate at which toxic and radioactive wastes travel through the sandy soil into the groundwater. One set of statistics was drawn from the 'public' sampling wells, figures often manipulated by flushing the wells with water

or pumping them out and then drawing a sample. The other was for internal use only. The internal data was either unpublished or buried, often labelled 'draft' and thus protected from public requests under the Freedom of Information Act. The water table was contaminated with tritium and strontium-90.

This was the first deviation from the model way things ought to be, according to DuPont and DOE. DuPont had models for how radioactive elements would move in groundwater, how radiation would disperse over surrounding communities, how safety records should look and how DuPont employees should act. Things that didn't fit the model were not wrong, they just didn't exist.

Radionuclide migration is a continual threat to an ecosystems health. Public records show tritium levels two to three times the drinking water standard, but internal records show levels a thousand times that. Strontium-90 and plutonium, according to models, were not supposed to move. However it's now known that these models were incorrect.

Documents at the University of South Carolina library showed that DuPont was tracking the waste stream and radiation exposure of workers. These records were different from the actual figures publicly released. Once again, DuPont models conflicted with reality. Based on the reams of raw data supplied by DOE, the Environmental Policy Institute analysis showed, among other things, that people in the area were getting radiation doses fifty times what DuPont models said they were getting.

High-level wastes in the fifty-one underground tanks contained more plutonium (about fifty bombs' worth) than recommended. A cloud of radioactivity that DOE alleged drifted over from a Nevada test in March of 1955 was more likely the result of a serious release from the reactor area. Four reactors on the site were known to have gone critical, releasing enormous amounts of radioactivity into the environment. Figures included a leukaemia rate among workers twice the norm.

Also, if the U.S. Geological Survey was correct, and there was a decent, if slim, chance that the Charleston Earthquake of 1886 could repeat itself in Barnwell County, then a rupture of the high-level waste tanks was likely. In that event, more than a billion curies radioisotopes would be released in the southeastern United States, making the fifty million curies Chernobyl accident look positively harmless.

In recent times, former Governor Jim Hodges of South Carolina took a stand against allowing the DOE to increase the storage capacity of radioactive waste at the Barnwell facility (national repository for radioactive waste), adjacent to SRS. At a time when FBI officials were warning of imminent terrorist threats, the DOE was planning the largest shipment of plutonium in history to a facility under the control of the Bush Administration. However, Governor Hodges vowed to keep it out. He sued the Energy Department, ridiculed the federal government in TV commercials, and mobilized state troopers.

"I've certainly made some dramatic gestures," Hodges said. "But disposing nuclear weapons, well, that's a dramatic problem."

Reactor R at Pond B is eerily tucked away between a yellow pine plantation somewhere within the 310 square mile facility. It was always disconcerting to collect samples from this site due to its history. In

1953 Reactor R was the first production reactor to go critical. The reactor became flooded, thus leaving behind a radioactive legacy.

Looking back, I remember technicians flipping coins to see who was to electroshock fish along Pond B shores. The unlucky ones would collect samples at various transects within the lake in an aluminium flat-bottom john boat. On one occasion my team was on the boat. I was always surprised at the diversity of species that were electro shocked from the lake. We would collect the fish, which were then tagged, weighed, and identified.

Occasionally, we would bring the fish to an on-site lab for gonadal and stomach analysis. Officially we were always told that radioactivity within the lakes was bounded in the sediment. Fortunately, more out of curiosity than protocol, I took a Geiger counter, to quell that inner voice, and to my surprise the alarm on the Geiger sounded. We dropped everything and left the lab. Protocol for a radioactive incident on the plant required Department of Health and Environment Control to retrieve the fish.

Officially, 'mum' was the word and no updates on the situation were ever provided. It seemed the official protocol was to cover it up literally and figuratively.

One interesting observation in relation to artificially induced thermal dynamics within a wetland and swamp system was how the heated aquatic system promoted the spawning of fish and invertebrates in the thermal effluent throughout the year, thereby radically increasing local populations. Unfortunately, various fish species often became emaciated and diseased, due to a lack of sufficient food supply and decreased dissolved oxygen levels.

Theoretically, this thermally induced microcosm gives insight as to the critical implications it may foretell about global warming. Upon restarting Reactor L, the initial test went critical. Instantaneously, the entire lake began to boil, killing everything within it - a mass kill of all species of fish and animals. Soon afterwards the Reactor was mothballed as a result of the end of the Cold War.

The nuclear industry had a policy of planned and unplanned releases of radioactive waste into the environment. Today, industrial wastes and residues are packaged and sold to consumers providing the industrialists with huge profits. These toxins are often dumped in drinking water under the guise of a necessity for public health. Fluoride and chlorine are current examples of industrial wastes that poison consumers whilst industrialists avoid landfill charges and a litany of bureaucratic red tape.

Today, how many tonnes of plutonium, strontium and radioactive iodine, etc., have been released into the Pacific by Fukushima? From the first atomic tests, nuclear industrialists have displayed brazen contempt for the environment and for humanity in general. In the case of SRS, DuPont's industrial products have had an overall detrimental impact on one of the most diverse ecosystems on the planet.

These renegade corporations have inflicted everlasting contamination on the world's ecosystems at a huge cost to complex biological life and living systems. For what purpose? For obscene corporate profits! It's now time for industrialists to live up to their responsibilities and take infinitely more care of the environment. Cost analysis proves that by taking an ecologically sustainable approach, profit margins will be greater in the long term.

Do you think these industrialists will voluntarily clean up their act?

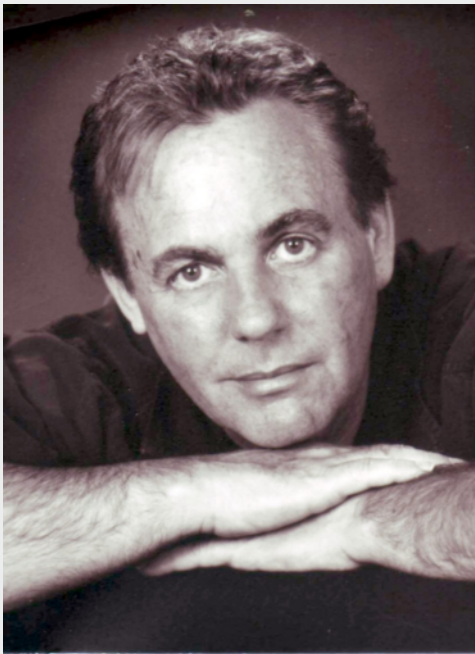

negotiate with the Nazis about the immigration of Jews, and their possessions, to Palestine. As early as May 1933, the first economic treaty was signed, leading to the Ha'avara treaty in that same year (this Treaty was enforced from 1933 until 1941).

The Ha'avara treaty allowed German Jews who wanted to immigrate to Palestine, to transfer their money to special accounts of the Warburg-owned Private Bank in Hamburg. These funds were used in Germany to manufacture agricultural machines, construction materials, pumps, sowing machines and other equipment for the future settlements in Palestine. All these products were transported to the Ha'avara society in Palestine (Tel Aviv). The products were then sold, and the proceeds transferred back to the Jewish immigrants when they arrived in Palestine. On a regular basis the products were also divided among the immigrants themselves, in accordance with their assets with the Private Bank.

The influx of German capital through the trade transactions of the Ha'avara treaty was of great importance to the rebuilding of the country, for the private as well as the public sector. Many new industrial and trade enterprises have been created in Jewish Palestine. Many existing companies that are vitally important to the Israeli economy have also emerged from this. Between 1933 and 1940 the production and size of Jewish settlements doubled. This was only made possible through the loans which were granted within the framework of the Ha'avara treaty."

De Ruiter writes: "If we analyze the roots of Zionism and make amends to the principles of the ideology that lays claim to Palestine, we cross an unwritten line. We have then almost committed a crime, and, before we know it, we appear in court." When De Ruiter says that critics of Zionism, before they know it, "appear in court," he knows whereof he speaks. The French-language edition of *Worldwide Evil and Misery*, part of the *Livre Jaune* series, was legally suppressed under the "race speech" censorship laws in France.

De Ruiter: "The reason the book *Livre Jaune 7* was banned was because of my critique of Zionism. The French edition talked among other things, about the descendants of Judah, the foundation of the State of Israel and criticizes Zionism."

The breadth of material cited in *Worldwide Evil and Misery* is impressive. All men who believe in free thought and free speech will be outraged by the attempted suppression of this book in France.

We are raised, by tradition, to trust our governments, and convinced that they care about us. This, however, is a big mistake. Below the surface of official politics lies a complicated social and intellectual process that is taking place. 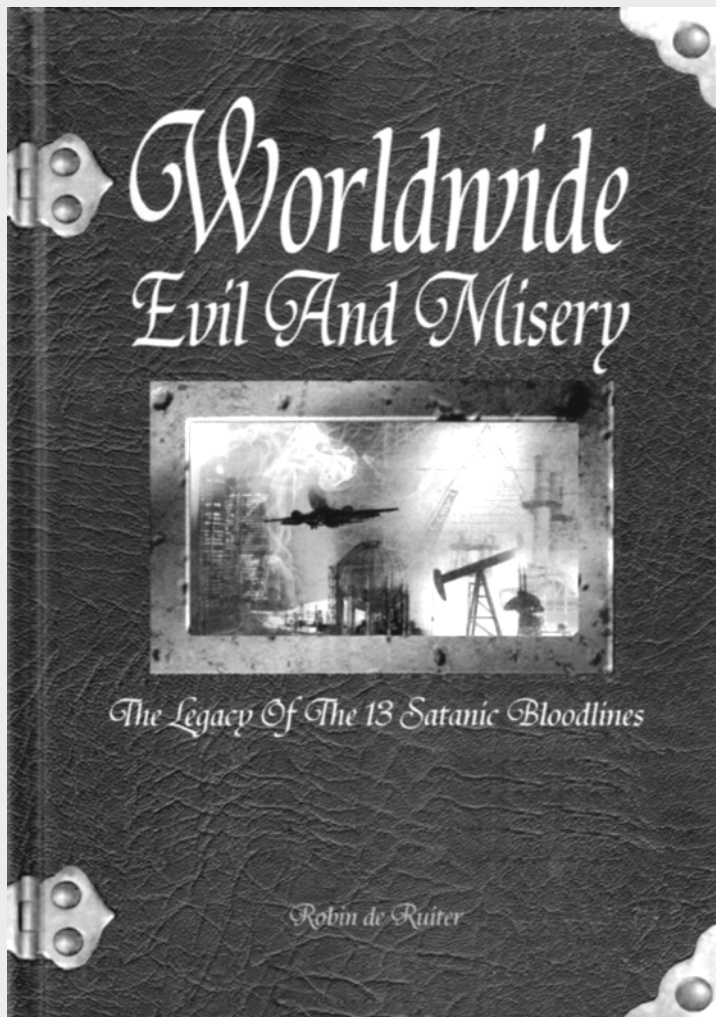

Computer “viruses” are small programs which copy themselves and try to spread to other computers. Vaccination programmes, scheduled booster shots and compulsive tetanus injections, allow them to put products directly into

our bodies, bypassing our natural defences. The media pressitutes are always eager to hype the latest pandemic scare to a population infatuated with medicine and hospital dramas. Such witting, or unwitting agents of the sickness industry immediately drop the story as soon as evidence begins to emerge that the pathogen was made in a lab. Big pharmaceutical companies make vast fortunes by selling drugs to treat and manage illness; therefore, it is against their interests to cure or prevent disease.

Some computer antivirus programs, constantly interfere with and restrict what we can do on our PCs. Many of these can make computers so slow that they become virtually unusable. We buy and install these products, believing that they will protect our data, but they take over and make our computers useless. The insert for some of the swine flu vaccines actually warned “may cause flu-like symptoms”! The declaration of a pandemic, gives the WHO the power to direct the internal operation of every country's health service. The definition of what constitutes a pandemic has been recently downgraded, allowing the WHO to claim these emergency powers more regularly. Just as antivirus programmes can harm the productivity of your PC, vaccination programmes continue to destroy the fertility of millions of women throughout the world.

Search – vaccine fertility, to verify this horror.

The highly sophisticated stuxnet worm was deployed for industrial sabotage against the Iranians. It is so advanced, using never before exploited weaknesses in Windows, that experts believe it was deliberately developed as a cyber-weapon by those with inside information about Microsoft. Similarly the deadly E.coli outbreak in Europe was resistant to so many antibiotics that it was clearly developed in a lab. The immediate and unconscionable announcement that it came from Spain, did untold damage to their farmers. It appears to have been used to punish Spain for its refusal to use genetically modified seeds.

Just as computer viruses can be designed to lay dormant in your system waiting for a trigger such as the expiry of an antivirus subscription; biological viruses can lay dormant in your body until an age related change in hormone levels or other stimuli activate it. No better system for involuntary euthanasia could be contrived. If you believe that there is an overpopulation problem and agree with compulsory fertility/longevity reduction measures, please feel free to show courage in your convictions, lead by example and free the planet of the dreadful burden of your existence.

Surely they would get caught, you might say. Computer viruses can and do delete all trace of how they arrived. Pharmaceutical have repeatedly been caught. Bayer distributed millions of ampoules of FactorX, knowing it would give people HIV. Maurice Hillman - top Merck vaccine scientist, admitted that their products introduced the SV40 cancer virus, and AIDs. A particularly virulent vaccine given to babies in India cause so many immediate infant deaths that the parents arrested the doctor and nurses. Tetanus vaccination programmes have been well documented for causing infertility by spontaneous abortion. A known bad vaccine, sold on to Brazil, caused a meningitis epidemic. The industry reacted to this disaster by recommending staggered programmes, which make adverse effects less obvious. A new development, used in the recent Gardasil push, are individually wrapped doses. This may reduce risk of discovery because weaponized jabs can be hidden among the relatively innocuous ones.

Malicious computer viruses and pathogenic diseases do exist. But damage can be more effectively limited in computers by using well made operating systems and safe file sharing practices, and in ourselves by nutrition, exercise, hygiene and knowledge. Any organisation who has the technology necessary to activate a deadly disease already installed in your body or who possesses the antidote to an engineered pandemic, can hold all humanity hostage. Vaccine induced genocide was narrowly averted by a Czech Lab Technician. He discovered that Baxter Laboratories had delivered thousands of swine flu vaccinations all over Europe which contained live avian flu and seasonal flu. Had these been administered, a contagious deadly hybrid would have probably occurred, resulting in a genuine pandemic.

We all know that scams and rackets are used for extortion. The method is to cause a problem, orchestrate the media reaction and then sell the prepared solution.

Monopoly Money and Global Financial Fraud

When the calls from the debt collectors started, I was feeling really scared and had difficulty sleeping. My voice would often tremble when answering them, although this would only encourage them to call more often. However, after being chased by one company, another took on the same account, but the amount had by then almost doubled. When I asked for a breakdown of the account, they were unable to provide one, but offered me a deal to pay it off at a fraction of the original amount. I declined their offer and started to investigate further.

After a bit of research, I realised the debt collectors buy debts for less than 10c in the Euro, that's after the bank writes the debt off. I also found out that under the Bills of Exchange Act 1882, the debt collector is actually paying off our debt when they buy it. I also realised how debt collectors trick us into contracts with them, by asking us how much we could afford to pay. When you agree to one Euro a month, which obviously costs more to administrate, they now have a contract with you, where none existed. That's why they always record the phone calls.

I then came across an eBook by Mary Elizabeth Croft, *How I Clobbered every Cash Confiscatory Bureau*. She explained that **fractional reserve banking** is basically fraud, as the banks do not have the money they lend us. A bank only needs a small fraction of the money it actually "lends" us, but that's not lending – **it is creating money out of thin air**. If a bank holds €1,000, it can create seven or eight times that amount and charge interest on it.

Mary suggested sending the debt collectors letters with a list of questions, which if they could not answer, would render the debt void. I could not find templates for the letters to send these companies, so I created my own with my new found understanding.

Security Questions

Once armed with my new knowledge, my confidence returned and I started having fun with the phone calls. I would sometimes answer the phone with a list of "security" questions: "What is your full name? The name of your line manager? Direct phone numbers?" And, of course: "What is your mother's maiden name?" When answered satisfactorily, they would be informed that I do not deal with matters over the phone. I would also inform them that the conversation was being recorded for training and entertainment purposes. It was as much as I could do to stop myself giggling as the bemused caller lost his thread and started fumbling for words.

It wasn't long before I set up getoutofdebtfree.org to share these letters with others in a similar situation and within a year or so, the website started getting a bit of attention. In 2009, the headlines on the Guardian website read, "Debt collectors hit out at advice websites".

The trade body for debt collectors had got together and decided that there were a few sites they wanted removed from the internet. Traffic to my site suddenly skyrocketed, eventually overtaking the government's own debt advice site.

Letter Templates

The basic letters we provide on the site to send to banks and debt collectors basically ask them for the following information:

- 1. Validation of the debt**
(the actual accounting or proof that they lent us anything)
- 2. Verification of your claim against me**
(a sworn affidavit or a hand signed invoice in accordance with the Bills of Exchange Act (1882))
- 3. A copy of the contract signed by both parties and therefore binding both parties.**

Should they not provide this, after sending two letters, the third letter creates a tacit agreement with the following terms:

- 1. That the debt did not exist in the first place; OR**
- 2. It has already been paid in full; AND**
- 3. That any damages I suffer, you will be held culpable;**
- 4. That any negative remarks made to a credit reference agency will be removed;**
- 5. You will no longer pursue this matter any further.**
- 6. You agree to pay all fee schedules.**

The **fee schedule** included in the letters, charge the recipient three times what they are claiming from us for dishonouring our agreement, €1000 per hour or part thereof for our time, €1000 for any form of response; and for contact by phone or letter the fee is €100 per item, payable in advance. If they do dishonour the agreement and continue to contact us, then we send them the bill. If they don't pay the bill, we can pursue them through the small claims court.

Support and Encouragement

Getoutofdebtfree.org now offers support to thousands of people in seven countries and has a very lively and supportive community forum. It now covers not just **banks, credit cards and debt collectors**, but **solicitors, bailiffs and credit repair**. The forum also has sections on **fixed penalty notices, utilities and student loans** as well as a wide range of general topics and regular news items. We have recently added a chat room for members to contact each other instantly. We also provide a user guide in the form of an eBook and video tutorials to guide members through the process. To date, the site has saved members nearly £6½ million, with members adding their savings on a daily basis.

We do encourage people not to be greedy, otherwise they would be behaving no better than the fraudulent bankers and we are trying to set an example to them. However if you get into a situation where you simply cannot pay, either through loss of work or health problems, or of course, the fact that there is insufficient money in the system for everyone to pay off their debts, then it offers you a choice. Being continually harassed by debt collectors can be very frightening and as they rely on continual threats and intimidation, which can ruin people's lives, leading to depression and even suicide in some cases, the site offers hope and empowers you to look at the situation from a different perspective.

Its like a game of Monopoly!

After setting up the site, I started giving talks in local pubs where I compared the global financial system to the game of Monopoly. When I started looking at the similarities, I was amazed. Firstly, we have to remember it's just a game, so there's no point in getting too upset when we appear to be losing. In Monopoly, we need a token to play the game, like the battleship or the dog. I found out that when our name is capitalised or has a title added, like Mr, Mrs or Ms; that it refers to a fictitious entity or 'strawman', which isn't us, but more like our token to play the commerce game. Also the currency in Monopoly is just totally worthless paper, so how do our nation's currencies fundamentally differ from this? There are no reserves of precious metals backing them and they print as much as they need to keep the game going whenever they like. Also I found out that in the rules of Monopoly "the bank never goes broke." If the bank runs out of money, the banker may issue as much as needed by writing on any ordinary paper! After the trillions of taxpayers' money being used to

prop up these fraudulent institutions I realised that the global financial system was nothing more than a big game. Finally, like the game of Monopoly , it has to end sooner or later. When you have all the money going from those with the least to those with the most money, the game can't go on indefinitely...

Any child knows that if you put 10 marbles in a bag, you can only get 10 marbles out. No amount of searching will produce the 11th marble – it doesn't exist. But it's exactly what the banks do. Like musical chairs, when everyone is standing up, if a chair is removed, someone is going to end up on the floor every time. Banks create the money they need as necessary, with a few clicks of a computer keyboard, but then charge us interest. Two things have to happen as a result of this. The money supply has to be continually and exponentially inflated and individuals, companies – and, of course, countries – end up on the floor and default. That the economy will eventually collapse is a mathematical certainty. Like any ponzi scheme, it has to sooner or later.

Few people who question the current system are given access to the mainstream media, with a few exceptions. Professor Jem Bendell gave an excellent TED talk - to quote him- "This system of money creation - as debt with interest - means that increasing economic inequality - differences between rich and poor - is a mathematical certainty" and "All we're doing is delaying the ultimate crash - that's been pre-programmed by the stupid money system..."

Then there's Max Keiser, who worked on Wall Street and set up his own stock exchange, until he realised how fraudulent the system was and now works on uncovering the fraud within the system. His views are not aired on the UK mainstream media, but did manage to make it into the Guardian once, receiving the inevitable criticism from those who are not ready for the truth. He goes out regularly on Russia Today and refers to the central banks as '**financial terrorists**' and also goes into depth on the real reasons behind the problems in Europe.

Who Issues the Currency?

However, if we have to focus on one single issue, then I feel it must be 'who issues the currency?' To put it simply, why are we in debt, when the nation's governments can create debt free money, without interest? Why do we have to borrow money from central banks? Why are whole nations being bled dry to shield financial institutions from the consequences of their own bad behaviour. The Greek government is deliberately creating a national great depression to appease international financial interests and just when the fate of the Euro hangs in the balance, they decide to start printing money again! The idea is to 'stabilise' the euro, (much like you may stabilise a sinking ship) and forestall a new credit crunch thereby shoring up troubled banks by flooding the markets with hundreds of billions' worth of easy money. The second time in two months!

Money was never intended as a commodity, but as a means of accounting, so that we could exchange the fruits of our labour. How did we ever get into a situation where we cannot trade with each other because of the accounting system? It's like running out of pages in the ledger, causing all financial transactions to stop. When there are people who want to produce goods and people who want to consume them, where's the problem? What is an economic downturn, recession or depression exactly? Are they not created by those who seek to profit from and control us, stealing our labour and productivity?

Iceland's Solution

We are told that default is not an option, as this would mean an end to foreign investment. However, look at what happened in Iceland. After prolonged protests, the government finally resigned, a new constitution was drawn up and the situation immediately started improving – despite serious threats from the UK and the IMF. Their economy is now doing rather nicely, mainly due to the massive burden of debt being lifted from them. Why can't we be brave like them and, get rid of our banking-sponsored government and default? Problem solved.

The current financial system isn't IN crisis, it IS the crisis and should you criticise those who default, tell me how you are going to pay you share of the current national debt of €120 billion, when the money supply comes nowhere near that? Default isn't just an option, it is inevitable, especially when the ultimate crash occurs...

The mood is now changing, and people are finally waking up. The worldwide Occupy Movement and the huge demonstrations around the world are reflecting this. Now is the time. We have to be brave and make some difficult decisions, and take back our power from the corrupt institutions of government and banking, both as individuals and as nations.

Our future and the future of our children depends on it.
