Not when I knew that water fluoridation was linked to so many of the health problems we have in this country today. I had no choice but to become a super hero for the campaign."

My lineage is Irish. In my memory I can go back four generations to a time when people placed their trust in officialdom. My great grandmother for instance extolled the virtues of running water. For her a tap was a symbol of progress, a giant step for womankind with no more hauling of heaving buckets of water from the well. Living in the 60's I'm sure she was unaware that she was being subjected to a known poison without her consent. If she was told the truth and that this medication was being administered with the full knowledge of government and the medical board she would think the world had tilted into an unnatural orbit, that you were talking about another country, for in her mind something like that could never happen in Ireland. It already had.

I knew nothing about fluoride until I became ill. I certainly did not make the link between how I was feeling and the quality of water I was drinking. This was pointed out to me by Barbara Wren, founder of The College of Natural Nutrition in the UK, who told me that the water I was drinking was contributing to the depression and low energy I had suffered from for four years. Irish water is fluoridated and the fluoride in the chemical cocktail has a negative effect on the thyroid gland by reducing iodine levels. A healthy thyroid is essential for positive mental health and for energy production.

In my determination to recover, I immediately installed a reverse osmosis water filter so that all the water I drank or cooked with was fluoride free. I took supplements to detox my body from the deleterious effects of fluoride and increased my iodine levels. After four months I began to feel better, the brain fog had

vanished and my energy increased. After six months I felt my mood was more positive and after eight months I felt alive. This was my second chance and I was not going to stay silent. My grandmother told me the story that fluoride was good for my teeth but the story that I will pass onto my children and grandchildren is a different one, one that challenges those deeply entrenched beliefs that have somehow burrowed their way into myth.

Plato once argued that the myths of the state were "noble lies" designed to legitimate existing power arrangements. This is true when it comes to the myth that man made fluoride was good for teeth. This is the myth that has prevailed to distort the truth. It was accepted by an unsuspecting Irish public in the 60's whose psychological dependence on health care professionals stopped them from questioning the policy of water fluoridation.

The myth between fluoride and dental health is a myth, one that was cleverly created and marketed by the phosphate industry. Edward L Bernays "the father of public relations" was hired to promote the myth that fluoride was good for dental health. Before the Bernays campaign sodium fluoride was recognised in the minds of the public as the chief ingredient of bug and rat poison. Afterwards fluoride was hailed as a promoter of healthy teeth and bright smiles. Water fluoridation was approved by both the American Medical Association and the American Dental Association, despite it being declared earlier as a poison in one of their journals.

It's amazing what unlimited advertising funds could achieve at a time when governments began to bow to pressure from the industrial elite and could be swayed by warped science. Don't you think it's ominous that prior to 1945 fluoride was regarded as an environmental pollutant but since 1950 it was endorsed by the US public health service as a chemical for water fluoridation? One and one no longer make two. It's a little like Ted Bundy making a comeback as a social worker!

Fluoride is a deadly pollutant and from 1957 to 1968 was responsible for more damage claims than all other twenty major air pollutants combined. This is according to Fluoride expert Edward Groth of the US National Academy of Sciences. Fluoridation was an attempt by industry to camouflage the deadliest pollutant with government officials and advertisers beating the drums. Fluoride is the only chemical added to water that is used for mass medication. Unlike most medicines there are so side effects listed near your faucet.

The more one delves into the mythology of fluoride the more bizarre the story seems. What you are not told is that the fluoride that goes into our water is not naturally occurring fluoride nor is it pharmaceutical grade fluoride but it is a combination of sodium silicofluoride and hexafluorosilicic acid. These two chemicals are considered highly toxic by the EPA. They are actually classified as hazardous waste and when packaged for transportation must be labelled as a poison and handled by workers wearing industrial safety gear.

Phosphate is a mineral used in fertilisers. It is mined from natural rock deposits scattered across the world. The problem is that phosphate rock is often contaminated with fluoride. To remove the fluoride sulphuric acid is added to wet slurry of phosphate and water. This causes the fluoride to vaporise and creates toxic compounds such as hydrogen fluoride and silicetetrafluoride. These chemicals used to be directly released through the smoke stacks of phosphate mining operations but the nearby farms suffered devastating losses of both their crops and livestock.

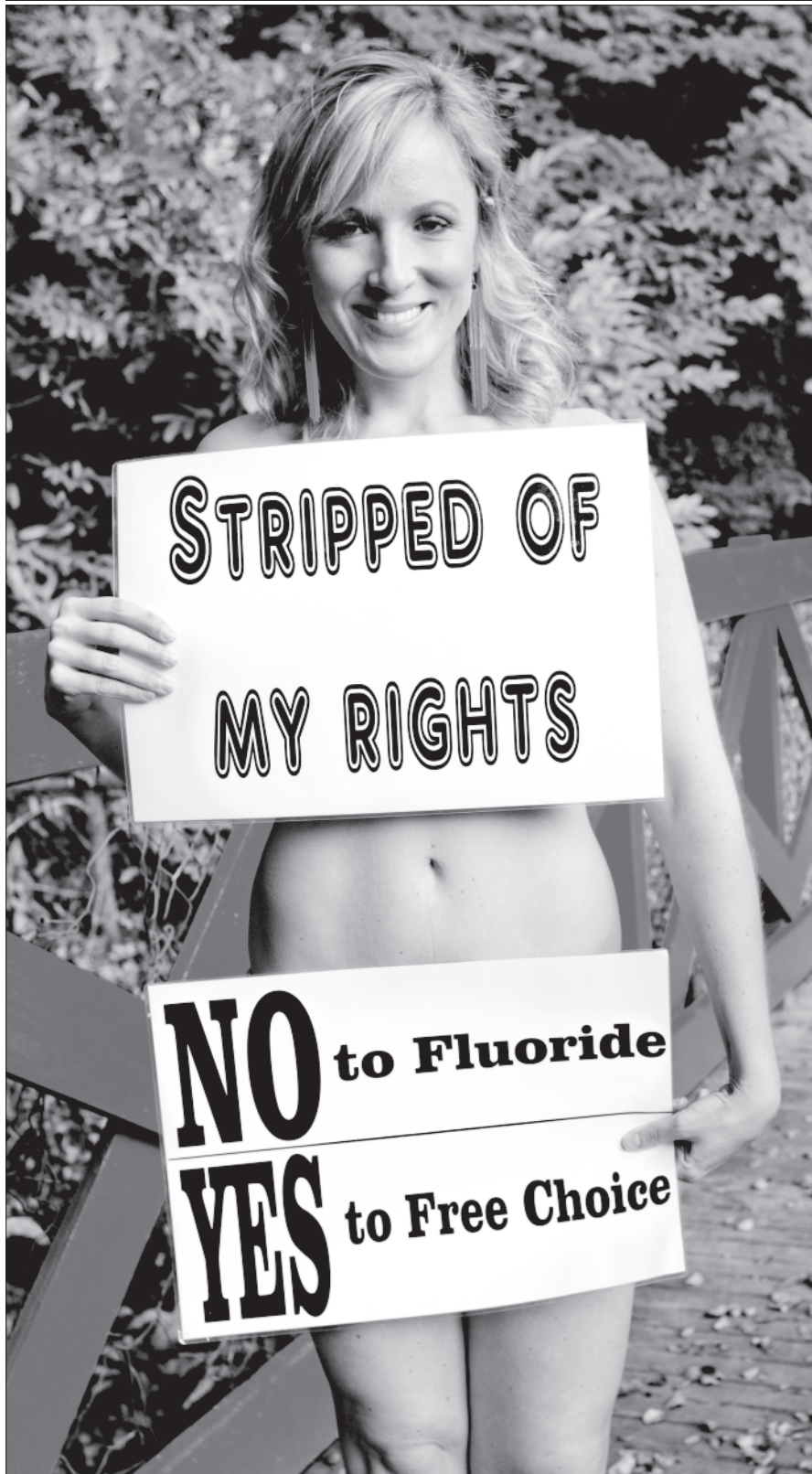
To prevent this from happening, the industry found a way to capture the toxic fumes by installing wet scrubbers. It is from these wet scrubbers that the toxic chemicals are collected and repackaged. Industry made millions from selling this waste

product to water companies and saved billions that would have been required to clean up this environmental pollutant. These industrialists lobbied the dental associations and gave them unlimited funding to persuade the unsuspecting public that fluoride was in fact good for their teeth. How do you make a rat look safe? Put him beside a shark. How do you make fluoride appear safe? Put it into the drinking water.

In 2006 the National Research Council of the US Academy of Sciences Committee on fluoride toxicology consisting of ten highly respected scientific and medical professionals unanimously concluded that "fluoride appears to have the potential to initiate or promote cancers". In 2012 The Russian Academy of Sciences concluded that "fluoride was established to reduce the body's anti oxidant defence systems, alter human genes, damage DNA and reduce DNA repair mechanisms leading to chromosome instability and cell death." They found that there is clear evidence to show that fluoride impairs protein synthesis, insulin secretion and glucose metabolism as well as suppress cognitive function and cause neurological dysfunctions.

We In Ireland have twice the global average of neurological disease. We are also the only country in the world where heart disease is on the incline. Fluoride hardens arteries. We have a considerable difference in the cancer rates between the North of Ireland that is not fluoridated and the South of Ireland that has been fluoridated for the past 50 years.

Although I have a water filter it is impossible to avoid the chemicals used in water fluoridation. We have seen tests that show that the chemicals used in water fluoridation are now in the food chain. When tap water is boiled these increases the potency of fluoride up to four times and this concentration is then infused into the foods prepared with that water. The countries who import our foods will be less inclined to do so once they realize that our food is contaminated with hydrofluoridic acid, especially the Dutch who banned water fluoridation in 1976. How long will it be before the rest of Europe discover what is happening and ban Irish food imports?

It is illegal to import an unlicensed medicine, and fluoride is regarded as a medicine in Europe. Not so in Ireland where the Irish Medical Board says that fluoride is a cosmetic but yet they say that anything that claims to prevent dental caries is a medicine! When their schizoid reasoning was challenged in a letter there was no further comment from the Irish Medical Board.

The Irish Medical Board and the HSE do admit that water fluoridation causes dental fluorosis, a condition that can range from mild to moderate to severe depending on the level of fluoride intoxication. This can cause the teeth to become mottled and brittle which can lead to extensive dental work in adulthood to offset the damage caused by fluoride. According to consumer law the seller is liable for the product that is sold. Under product liability the government are liable for a lot of dental bills as fluoride is the only substance that can cause dental fluorosis. They have never once mentioned this as a side effect of water fluoridation to the public. There are no warning signs on our faucets.

I began working on the campaign to ban water fluoridation last year. It has been challenging especially when I meet with people who are intractable in their stance on water fluoridation. We have had some success locally as the Kerry County Councillors voted unanimously to reject fluoridation. However they claim that by law they are mandated to continue with a practice many of them know to be harmful. These are our paid public representatives who are failing to protect the people they serve. Why are we paying them?

I work with a group of committed individuals on The Girl Against Fluoride public awareness campaign. The aim of the campaign is to educate the public of the dangers of water fluoridation and also to raise awareness before the court case next year. I am taking the Irish government to court for their failure to protect their citizens from the negative health impacts of water fluoridation.

I travel to various venues around Ireland which has proven to be very effective in educating the public on the dangers of water fluoridation. I attended the Rose of Tralee Festival where I posed as the Rose of Fluoride Free. I had the privilege of being at the Electric Picnic, which was magical, where I had an anti-fluoride stand in a bottle installation. I attended the Rude Health exhibition in Dublin where I was delighted to meet with author and cancer survivor Bernadette Bohan. She fully endorses the campaign and only drinks non fluoridated water. I attended the National Ploughing Championships in Wexford where I met with some fabulous farmers, many with their own well, an attractive prospect for any young lady.

The people I have spoken to are appalled at the HSE's continuing stance that fluoride in the water is a safe public health measure despite it being banned in over 98% of Europe. I wonder if people realise that we are being forced to drink a substance that was banned for its use as a wood preservative in 2006 in Europe. The chemical substance used for water fluoridation was banned as a *biocidal substance by the EU in 2006 under Directive 98/8/EC. Hexafluoridic acid can no longer be used as a wood preservative due to lack of environmental and toxicological data to demonstrate that it is safe for humans or the environment. Hexafluoridic acid is classified as a health, physicochemical and /or ecotoxicological hazard according to the National Occupational Health and Safety Commission (NOHSC) Approved Criteria for Classifying Hazardous Substances. Our bodies have to filter a banned biocide and the HSE still say it's good for our teeth?

It is time for the truth to be told to the people of this country. Why should people's health be compromised because of poor water quality? Our government were once asked to at least issue warnings to young mothers not to feed their babies formula made with tap water. This is because breast milk contains very low levels of fluoride as nature intended at 0.04 parts per million. A bottle fed baby is exposed to levels that are 2, 500 times that amount. Our government issued advice alright but all health officials said was that mothers should breast feed. The sacred cow of water fluoridation was not mentioned.

Water is fundamental for life and for health. If there is magic in the planet it is contained in water as it is life's matrix and matter. I have a dream that someday soon we will have access to crystal clean water from our taps, a time when our citizens are no longer drugged against their will. I am proud to work with a team who have brought such energy and enthusiasm to this campaign. I am delighted to work with fine men such as Steve Kerr and Terry Lawton whose commitment and integrity continue to inspire me. I am honoured to know Declan Waugh whose report Human Toxicity, Environmental Impact and legal implications of water fluoridation has given us the science we needed for this campaign. Declan's report is held in high esteem abroad. A Harvard university professor said that his work was an act of humanitarianism. I agree. Declan's report was responsible this year for four cities in Canada ceasing water fluoridation. Although this report was sent to every minister and to every council in Ireland it has been ignored and derided by the Expert Body on Fluorides and Health, a government body that is paid £425, 000 a year to meet twice!

My aim is to create a grass roots nationwide campaign where people will take direct action and take the power back from officials who no longer serve us. I want people to join The Girl Against Fluoride campaign as I believe that together we will create the change. Silence is consent so speak out against the archaic and dangerous practice of water fluoridation. It's not conspiracy, its chemistry.

Don't give away your rights in the
Children's Rights Referendum

Here are the 10 Reasons we believe you should vote NO in the Children's Rights Referendum.

- 1/ Your legal right under Article 42.5 of the Irish Constitution to decide "Best Interests" for your own child will be handed over to the State. Parents will be reduced to Caregivers under the UNCRC.
- 2/ Your child can be placed for adoption against your will. You will not need to be accused or convicted of any crime and the arbitrary decision can be made by one person. The entire process will take place in secret Family Courts and you will be gagged and prevented from speaking out.
- 3/ The State can decide for example to vaccinate every child in Ireland, and the parent, and even the child have no say in the matter. You do not need to be consulted or give permission. Joan Burton has already hinted that Child Benefit will be tied into vaccination records, this could be extended to school admission.
- 4/ The State can decide to give Birth Control to children of any age, even if they are below the Age of Consent. The State can bring children to other countries for abortions without parental consent and even if the child disagrees. (X case, C Case, D case)
- 5/ The UN and the EU can make any laws for children without consent of the Irish Government if it wishes. This allows unelected people in the EU and UN to write Irish Laws without prior notice. This removes what little Sovereignty Ireland has as a nation.
- 6/ The United Nations Convention on the Rights of the Child is no mere statement of altruism, it is a legally binding Human Rights Treaty which, if Article 42 is changed, will allow unelected people in the EU and UN to re-write Irish Law. Fully ratifying the UNCRC will now make every other treaty that we have ratified also apply to all Irish Children. The entire landscape of Irish Law may need to be rewritten.
- 7/ The UNCRC does not give Irish children any privileges they did not possess before. Parents have always vindicated the rights for their child. As children are not autonomous, the State can decide anything even if the child disagrees. Effectively, this also removes children's rights.
- 8/ The "Best Interest Principle" of the UN is nothing more than a slogan. Was it in the "Best Interests" of the 260 who died in Irish State "Care", or the 500 who went missing and many were later found to have been trafficked into prostitution and slavery? We believe if Ireland is to have a World-Class Child Protection System that "Best Interests" should be replaced with "to the Measured and Demonstrated Benefit of the Child" and it will need to be measured and demonstrated. Despite 760 children missing or dead in a decade, nobody has ever been held accountable. In the Baby P case 2 doctors were struck off and 4 social workers fired, in Ireland 260 dead, 500 missing and nobody was punished.
- 9/ The UNCRC only gives "Rights" to children but there is no obligation on the Government to comply. Children in developing nations whose Governments have ratified the UNCRC have the right to food and water and yet children are dying. Children are executed in some countries and the UNCRC does not protect them, only their "Rights". Many of the countries that have ratified the UNCRC allow for Child Soldiers, Child Forced Marriage, the Death Penalty for Children and even Female Genital Mutilation. The UNCRC does not protect children, their parents protect them.
- 10/ The question we are being asked here is "do you trust the Irish State, the UN and the EU to make decisions for your children when your parental rights have been eliminated?" If you are not 100% sure you must vote no.

As we are not funded as an organization, we are unable to send this pamphlet to every home in Ireland. Fortunately, some concerned citizens have stepped in and volunteered to try to distribute "10 Reasons" nationwide.

Ordinary citizens are so concerned that they will print off our pamphlet at their own expense and take to the streets to hand out leaflets and discuss the Referendum with other parents.

"The proposed referendum deletes Art 42.5, this article 42.5 is a robust guarantee of help and protection for children. The proposed referendum wording replaces it with Art 42A in which the State assumes parental authority over all children while reducing its duty to them. The loss of Art 42.5, would be particularly difficult for children with special needs.

Do we really think that a State that did not even know how many children had died or gone missing in its care, which has spent millions of euro fighting children and their parents in court to deny them services and which has dramatically cut funding to children and is about to cut Children's Allowance is actually offering us an amendment that would actually benefit children. The State has failed children. It is absurd to give the State more power over them.

Children are too important to get this wrong so I urge voters to Vote No.

Children depend on us the voters to protect them and their welfare in this referendum. To do this we must study the amendment, both what is deleted and what is added. When we do we will see that in this referendum we are being asked to delete an important protection for children in favour of provisions that betrays them. In this the State would isolate children and their rights so as to control them. While at the same time the State limits parents right to parent. We adults have a duty to our children to protect them from a grossly negligent State."

We are being told to vote Yes in the Children's Rights Referendum. Is it really a good thing for Children?

A Right, by it's very definition is something you possess. It cannot be taken away from you or amended without your consent. Under the Irish Bill of Rights - our Constitution - Rights cannot be changed except by a majority vote in a Referendum. Whenever the Government have a Referendum, it will in some way affect your rights. It's important to understand the issues involved so you can make an informed decision.

The United Nations Convention on the Rights of the Child is no mere statement of altruism, it is a legally binding Human Rights Treaty. It supercedes Irish Law and can be changed by unelected people in the UN. The whole landscape of Irish Law may need to be re-written to comply with the UNCRC and other treaties. Even Judges and Law Professors have stated that the effects of this Referendum will have on Irish Law are unknown. It may take years to sort out the implications.

The UNCRC is of the view that all children are autonomos and can decide for themselves, regardless of age, when the child is too young to decide, the State will make the decision for them, regardless of the wishes of the parents. The State currently decide "Best Interests" for more than 6,500 children in State "Care" with disastrous consequences for many of those children.

Irish Children at the age of 16 can make health decisions for themselves currently without parental consent or knowledge. If a 16 year old girl decides to avail of contraception, she doesn't need parental consent, also the Age of Sexual Consent is 16. Under the UNCRC, a child of any age can access contraception without parental consent or even knowledge. Again bear in mind that the Age of Sexual Consent is 16, a parent could be charged with allowing their child to have sex in their home.

Ireland also signed and ratified other UN and EU Treaties. By changing Article 42, many of the other Treaties will now apply to Irish Children also. Under the Convention on the Rights of Persons with Mental Disability, children of any age will be able to consent to Electroshock Therapy or even Psychosurgery (Lobotomy) without parental consent and regardless of age. As parents will no longer be able to make these decisions for their own children, the State will decide. If Ireland decided for example to legalize Euthanasia, the law would automatically apply to children.

The State can decide anything it wants in relation to your children and now you are powerless to intervene. Worse yet, the EU or the UN could decide to implement any law and even the Irish Government will be powerless to act, as the State will have also given up the right to decide Best Interests for Irish Children. The decisions for Irish Children will then be made by unelected officials in the UN and EU.

Parents will be reduced to Care-givers and will not have the right to determine Best Interests for their own child. Children also lose the right to determine their own Best Interests as this will now be determined by the State. The State could decide it is in the Best Interests of all children to be vaccinated and even the child has no say in the matter.

On the face of it, from the title it sounds wonderful, but is it really? On this page we have provided you with information to make an informed decision. Do the research for yourself and we think that you will agree that this is an



attack on Families and Children. Children will actually have less rights if this incideous legislation passes. Ireland will be giving up the sovereignty of our children to unelected people in the UN and EU

Irish children deserve a world-class Child Protection System, but the Irish State have always proven to be the worst possible parent. What is happening to children now in State "Care" is far worse than ever occurred in the old institutions. Wait for Ryan Report II, coming soon.

We are being fooled by the Government and by people with vested interests to sign away our parental rights to determine what is in the best interests of our children. If the Constitution is changed it will give license to the Government to do anything they want and you will have no say.

"My office has never examined a case involving a conflict between parents' rights and children's rights. And if there is one thing that has become confirmed by the eight years of this office's operation, it is that parents are by far the strongest and most tenacious advocates for children." - The Children's Ombudsman - Emily Logan.

The Irish Government are currently allowing 30% of all Irish Children to live in consistent poverty. They have allowed banks to make 6,000 families homeless, they have cut back services to Special Needs even in the good years. They have allowed children to die in hospitals because they would not fund treatments. They have denied children an Education, the right of all children "Enshrined" in the Irish Constitution. They have allowed the deaths of 260 children in "Care" of the State and allowed 500 to go missing in a

decade, many of them trafficked into child prostitution and nobody was held accountable for these failures. Children are dumped on the street at age 18 by the Child "Protection" System. Can you imagine a parent who loves their child doing that?

Now the Government are asking you to sign away your parental rights so that the State decides Best Interests.

The question we are being asked here is "Do you trust the Government?," worse yet. "Do you trust the Government with your children".

Please note that or group is not funded. Can I also make it clear that we have no Spokesperson or Leader, It has been wrongly reported and assumed that Kathy Sinnott is the leader of our panel. We are individuals who decided to put our resources together in the short time allowed to present our individual views. Anyone is welcome to join if they can contribute to the debate with a good understanding of the issues.

Our panel consists of individuals each of whom have a specialized knowledge in this debate, Kathy's interest is in the area of Special Needs children and how this will affect them and their parents. Kathy also has a unique understanding of the UNCRC and has written extensively on the topic.

I will leave you with a quote from Emily Logan, The Children's Ombudsman in an opinion piece in the Irish Times;

The Children's Rights Lie

If you love children, you'll vote yes. Why wouldn't you? If you are one of the less than 50% of the nation who actually votes, you wouldn't want to seem as if you didn't care about children would you? And you know something? That's exactly what the state is banking on.

So why is it all a lie? Well apart from the obvious “you should never trust an Irish government with anything” logic there are plenty of reasons to be wary. A little known fact about *Bunreacht na Heireann* is that in Ireland, the family unit is the head of the State. To put that simply, in Ireland there is no greater power in society than the family. Article 41.1 states:

“The State recognises the Family as the natural primary and fundamental unit group of Society, and as a moral institution possessing inalienable and imprescriptible rights, antecedent and superior to all positive law.

2° The State, therefore, guarantees to protect the Family in its constitution and authority, as the necessary basis of social order and as indispensable to the welfare of the Nation and the State.”

If you vote yes in November, you'll be surrendering the rights of the family unit, effectively making the constitution mere toilet paper. How?? Because if you remove the power of the family unit, you remove the head of the state. And who do you think will take that power? Oh come on, have a guess... ooh for you. That's right. The government. But it doesn't end there, there's more. Article 42.4 states:

“The State shall provide for free primary education and shall endeavour to supplement and give reasonable aid to private and corporate educational initiative, and, when the public good requires it, provide other educational facilities or institutions with due regard, however, for the rights of parents, especially in the matter of religious and moral formation.”

That's right, you guessed it. No more free primary education. OK ok, I know. Who the hell gets free primary education in this country? But it's the law. Funny thing is, this is completely absent from the proposed amendments. Oh and did you know?

Children already have rights in Ireland. The constitution is explicit in this. Article 42.5 states:

“In exceptional cases, where the parents for physical or moral reasons fail in their duty towards their children, the State as guardian of the common good, by appropriate means shall endeavour to supply the place of the parents, but always with due regard for the natural and imprescriptible rights of the child.”

Did you see that? It's right there.... *“the natural and imprescriptible rights of the child”*. So why are you being asked to vote for something that already exists? That wording in there is important too. “By appropriate means” is to be replaced with “by proportionate means” which will actually remove children's rights. I know, big words ... complicated stuff eh? It means that the state is no longer required to fully see out its role as “guardian of the common good” and will now only cater for the child as long as budgets allow. Interesting isn't it?

Forced Adoption

Now onto the changes regarding adoption. Why would we need this change? In short, we don't. But why does Enda Kenny want this change? I'll tell you. Currently in Ireland 90% of all children in state custody are with foster parents. A foster parent receives a lot of money from the state. €325 p/w for every single child 12 years or younger and €352 p/w for every single child over the age of 12. With current numbers stating that the state is currently taking care of 4500 children. That's a lot of money. And with the Troika, the IMF and bondholders to be thinking of, how on earth can Enda Kenny allow Joan Burton to continue that mad give away? So in steps that yolk, Francis Fitzgerald. "To guide you in you deliberations, I would suggest that you recall the Judgement of Solomon. When two women came before him, both claiming to be the mother of the same baby, Solomon recommended that the boy be cut in half. Whereupon one woman instantly relinquished her claim on the child, rather than have him killed. By her reaction, Solomon judged her to be the better mother, and gave her the child.

Solomon's judgement now falls to you, the jury. I urge you not to make your choice according to the fine words and promises of either party, but rather to compare their actions. “Wherefore by their fruits, ye shall know them”.

We have all heard of dreadful instances when the normal love and compassion of parents fails, and horrific cruelty and abuse follows. Laws already exist which allow the removal of children from desperate situations. When the system fails to protect such children it is not due to constitutional constraints.

Contrast the occasional failure of parents to secure the needs of their children, with the infamous collusion of the state with widespread, systematic child abuse.

The routine brutalisation of children in state schools.

• **The relentless abuse and exploitation of children under the care of church and state.**

• **The failure of the state to save innumerable children from torture, for the sexual gratification of church personnel.**

• **The 260 children who recently died while under the protection of the state.**

• **The 500 plus children who have “disappeared” while in state care. Some of whom are know to have been sold into slavery.**

Surely the most important lesson we can learn from the Ryan Report is that cover-ups go right to the top because hierarchical bureaucracies, always put the preservation of the institution before the protection of victims.

You may assume that the state will only intervene when parents are very bad; and since you are good parents, your children could never be taken. But in reality, just one expression of suspicion by a doctor, nurse, teacher or Garda, can lead to your children

being seized. Without any requirement for evidence, the fate of your family will then be decreed by an “official” in a secret family “court”, where you will not even be allowed to speak in your defence.

Every week, the state spends five thousand Euros of taxpayer's money on each child in care- financing a lucrative “industry”. Despite these enormous resources, the state often fails to meet the basic needs of these children; and remains unaccountable for such failures. Should a mother, who sells her own body to provide for her child, be decreed unfit; or does she need support?

Working unsuitable hours, poverty, alcohol and drugs are most often the root causes of parental neglect and abuse. These are issues that the state does have the resources and

duty to address. Rather than allowing them to supplant parents, shouldn't the state be confined to promoting the conditions that facilitate good parenting? Given the appalling track record of the state in preserving the well-being of our nation; would it be wise to appoint it “guardian of the common good” and sole arbiter of “the best interests” of our children?

I implore you to take your role as juror in this case most seriously. Research the relevant facts, apply your common sense, discuss the real issues with friends and family, and be sure to cast your vote conscientiously."

Making Money Out of Nothing!

be fought sooner or later is the People vs. the Banks.”

Nobel laureate John Kenneth Galbraith was an economics professor at Princeton, Harvard and California and at one time the US ambassador in India. In addition, he wrote many books. With regard to the general insight into money, he had the following to say:

“The study of money, above all other fields in economics, is one in which complexity is used to disguise truth or to evade truth, NOT TO REVEAL IT. THE PROCESS BY WHICH BANKS CREATE MONEY IS SO SIMPLE THE MIND IS REPELLED. With something so important, a deeper mystery seems only descent.”

In the media, we, the uninitiated, are often confronted by images of central bankers who steer markets by lowering or raising interest rates, as though they were witchdoctors. Their speeches are often so incomprehensible that it takes an expert to make heads or tails of what they say. We shouldn’t expect them to be any clearer, because that would make them obsolete and they would risk losing their job.

We, the uninitiated, tend to think financial and economic matters are boring, so we just switch channels. These gentlemen will do the thinking for us. As long as we get our pay check and are able to pay our bills, everything will be alright.

However, when we realize that controlling the world’s financial flows is the beginning of all REAL power, it wouldn’t hurt us to be a little more involved in these matters. Let us not forget what real power is: THE CREATION OF ECONOMIC GROWTH OR DEPRESSION. THE CREATION OF WAR, INFLATION AND THE ECONOMIC DOWNFALL OF ENTIRE NATIONS AND CULTURES.

These aren’t natural phenomena, nor is it the Hand of God. These are deliberately created events. Henry Ford, the American automobile manufacturer and member of the global elite, put it as follows:

“It is well enough that the people of the nation do not understand our banking and monetary system, for if they did, I believe there would be a revolution before tomorrow morning.”

In other words: “we are being lied to”. Over the years, the lie has become so universal and complex that we struggle to comprehend it. As a result, this is what the situation is: a relatively small group of people is in control of the planet, based on this illusion.

If we gain insight into this monetary system, we can create our own future, without war or famine.

“MONEY IS THE MOST IMPORTANT SUBJECT INTELLECTUAL PERSONS CAN INVESTIGATE AND REFLECT UPON. IT IS SO IMPORTANT THAT OUR PRESENT CIVILIZATION MAY COLLAPSE UNLESS IT BECOMES WIDELY UNDERSTOOD AND THE DEFECTS REMEDIED VERY SOON.”

The central issue at stake here is the following. Banks create money out of nothing. When we do this, we are considered frauds and counterfeiters, but our central banks have been authorised by law. When we realize that these banks are in turn controlled by the afore-mentioned small group of people, our leaders, the global elite, we can’t help but start to wonder what the value is of things like democracy.

What do banks have to say about ‘their’ money?

“Neither paper currency nor deposits have value as commodities. Intrinsically, a dollar bill is just a piece of paper, deposits merely book entries.”

The same people who published this also control our daily lives by determining interest and inflation rates!

Every day, we are bombarded by the media with stories that allegedly show that there is a shortage of money for this, that and the other: healthcare, education, normal housing, enough income for decent living, research and innovation in alternative energy, ‘normal’ biological agriculture, etc.

Enough space, enough labour, enough creativity, and enough brainpower, enough of everything. Just not enough money (and when interest rates go up, there’s even less money). All kinds of false reasoning are used: “wage increases equal inflation.”

The central question is: “How is money created?”

An example?

You buy a house or take out a mortgage on the excess value of your property. You want 200,000 Euros. The following happens. The bank’s computer adds these virtual numbers – because that is what they are – to your bank account, and then you have to bleed for the next 30 years, WITH INTEREST.

The bank attached a fictional number to your name and for 30 years you need to work to pay the money back. The bank didn’t build your house, nor did it pay for the materials. That was done by people like you and me. They too have to pay, because they also have a mortgage. And when you die, your kids will have to pay taxes on your estate. Often, they have to take out a mortgage of their own to do so .

Another example of how banks create money out of nothing (Europe):

You go to the bank to borrow 1,000 Euros. One year later, you have to pay 1,100 Euros back, including interest. The additional 100 Euros come from fellow citizens, for instance in the form of wages or profit sharing. In other words, the extra 100 Euros come from society.



This can only happen when the total amount of money in circulation increases. That increase – inflation – is created when the bank creates more money. In other words: “Interest payments are a direct way to create money.” All the money that exists comes from the bank.

This remarkable phenomenon has been described as follows by Mr. Robert Hemphill, Credit Manager of the Federal Reserve Bank in Atlanta:

“If all the bank loans were paid, there would not be a dollar in circulation. This is a staggering thought. We are completely dependent on the commercial banks. Someone has to borrow every dollar we have in circulation, cash, or credit. If the banks create ample synthetic money we are prosperous; if not, we starve. We are absolutely without a permanent money system. When one gets a complete grasp of the picture, the tragic absurdity of our hopeless situation is almost incredible - but there it is.”

Interest rates slow down economic growth, unless additional money is created. If that does not happen, it will lead to money shortage and therefore a recession/depression, because a shortage of money means we can’t settle our economic affairs.

After John Maynard Keynes, Milton Friedman is probably the most influential economist of the 21st century. He was a professor at various universities and president of the American Economic Association. In 1976, he was awarded the Nobel Prize for economics. In a radio interview in 1996, Friedman said:

“The Federal Reserve definitely caused the Great Depression by contracting the amount of money in circulation by one-third from 1929 to 1933.”

In a radio interview with Radio Australia on July 17, 1998 (transcript on the website Money, Markets & the Economy), Friedman adds insult to injury when he says that:



Innocent victims of the Great Depression.

“All of the central bankers kept saying that they were following easy money policies and that the economy was declining in spite of, and not because of their actions. In the United States, from 1929 to 1933, the quantity of money declined by a third. Similarly in Britain, it declined till 1931, when Britain went off the gold standard. At all times from 1929 to 1933 the Federal Reserve had the power and the ability to have prevented the decline in the quantity of money and to have increased the quantity of money AT ANY DESIRED RATE. When the Federal Reserve Act was passed in 1913, its major purpose was to prevent

This article opens with a letter from the world’s most important banker, Rothschild’s of London. The ‘John Sherman’ mentioned in the letter was a US congressman between 1860 and 1890.

Rothschild Brothers, Bankers, London, June 25th, 1863

Dear Sir:

A Mr. John Sherman has written us from a town in Ohio, U.S.A., as to the profits that may be made in the National Banking business under a recent act of your Congress, a copy of which act accompanied his letter. Apparently this act has been drawn upon the plan formulated here last summer by the British Bankers Association and by the Association RECOMMENDED TO OUR AMERICAN FRIENDS as one that if enacted into law, would prove highly profitable to the banking fraternity throughout the world.

Mr. Sherman declares that there has never been such an opportunity for capitalists to accumulate money, as that presented by this act, and that the old plan of State Banks is so unpopular, that the new scheme will, by contrast, be most favourably regarded, notwithstanding the fact that it gives the National Banks an almost absolute control of the National finance. ‘THE FEW WHO CAN UNDERSTAND THE SYSTEM,’ HE SAYS, ‘WILL EITHER BE SO INTERESTED IN ITS PROFITS, OR SO DEPENDENT ON ITS FAVOURS THAT THERE WILL BE NO OPPOSITION FROM THAT CLASS, WHILE ON THE OTHER HAND, THE GREAT BODY OF PEOPLE, MENTALLY INCAPABLE OF COMPREHENDING THE TREMENDOUS ADVANTAGES THAT CAPITAL DERIVES FROM THE SYSTEM, WILL BEAR ITS BURDENS WITHOUT COMPLAINT AND PERHAPS WITHOUT EVEN SUSPECTING THAT THE SYSTEM IS INIMICAL TO THEIR INTERESTS.’

Please advice fully as to this matter and also state whether or not you will be of assistance to us, if we conclude to establish a National Bank in the City of New York. If you are acquainted with Mr. Sherman we will be glad to know something of him. If we avail ourselves of the information he furnished, we will, of course, make DUE COMPENSATION (emphasis mine).

*Your respectful servants,
Rothschild Brothers
John Sherman played a crucial role in setting up the banking system at the time. The Rothschilds were very interested in the subject, because they were planning to set up a ‘National Bank’ in New York .*

The essence of the letter can be summarized in a few lines: MONEY IS A SHADOWY GAME, AND THE FEW PEOPLE WHO KNOW ITS RULES ARE DOING EVERYTHING TO MAKE SURE IT STAYS THAT WAY, AT ANY COST!

The letter refers to us as the large group of people lacking the mental capacity to understand this. We are expected to carry the burden without complaining and without having a clue that it is against our interests. Our understanding is too limited to grasp the significance.

This letter is also indicative of the arrogance with which we and our ancestors are viewed and treated by these people, all the more so because, when properly explained, even a child can grasp it. As a result, the hallowed institutes of education and democracy need to be reconsidered, because in their present form they are misleading and meaningless.

Impressive language, you might well say. However, the powers-that-be started out with very similar impressive language. Impressive words serve a purpose. To hide a simple truth! Ultimately, facing this central issue and taking action accordingly is unavoidable.

Lord Action (1834-1902), supreme judge in England around 1875, once said:

“The issue which has swept down the centuries and which will have to

‘banking panics’ as they were called, temporary crises that had occurred in the United States in 1907 and during earlier periods. What it did was to preside over the worst banking panic in the history of the United States. Not only did the quantity of money go down by a third, but about a third of the banks failed and in the spring of 1933, the Federal Reserve System, which had been set up to prevent banking panics, closed its doors itself and stopped operating. That’s a disgraceful performance...”

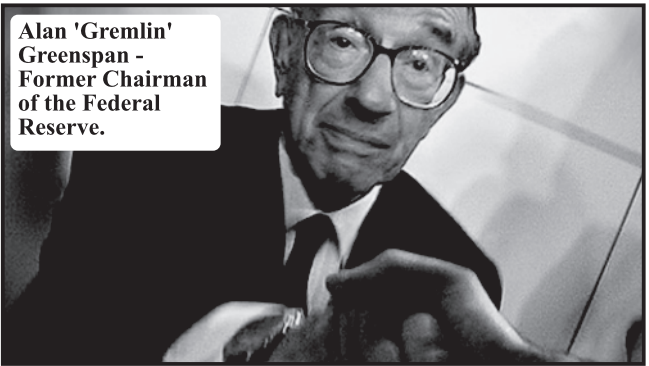
On November 8, 2002, the Chairman of the Federal Reserve, Ben Bernanke, during a speech in honour of Friedman’s 90th birthday, responded as follows:

“I would like to say to Milton: Regarding the Great Depression: You’re right, we did it. We’re very sorry. But thanks to you, we won’t do it again.”

What is the position of the American ‘government’ in this? Alan Greenspan (former head of the Federal Reserve) claims:

“Well, first of all, the Federal Reserve is AN INDEPENDENT AGENCY, and that means, basically, that there is no other agency of government which can overrule actions that we take, So long as that is in place and there is no evidence that the administration or the Congress or anybody else is requesting that we do things other than what we think is the appropriate thing, then what the relations are don’t, frankly, matter.”

In other words, THEY ARE NOT RESPONSIBLE TO ANYBODY.



The 1929 stock market crisis that heralded the Great Depression, didn’t just happen overnight. Money to speculate with shares has to be created. In 1960, Wall Street executive and advisor to Presidents Woodrow Wilson and Roosevelt, Mr. Bernard Baruch, published his memoirs Baruch, the public years, in which he wrote the following about the run-up to the stock market crash:

“Nothing did more to spur the boom in stocks than the decision made by the New York Federal Reserve Bank, in the spring of 1927, to cut the rediscount rate. Benjamin Strong, Governor of the bank, was chief advocate of this unwise measure, which was taken largely AT THE BEHEST OF MONTAGU NORMAN OF THE BANK OF ENGLAND.”

As a result of this decision, the amount of money in circulation grew tremendously:

“From this point on, the market got completely out-of-hand. At the time of the bank’s action I warned of its consequences. ”

Any rational human being could have seen how this would end, which means that London and New York bankers should have seen it coming. The motive? Lots of banks collapsed and from their ruins rose the largest corporate banks of the United States. In other words... concentration of power. As Alan Greenspan said it so eloquently: “This has nothing to do with the government.”

Democracy? Power to the people?

As you can understand, this will get us nowhere. And that is exactly the idea. We are in trouble because we are shackled to an institute that is authorized by law to write out dodgy checks! And when a brave and misguided soul (criminal!) takes it upon himself to storm the bank and takes the money at gunpoint, he finds, much to his dismay, NOTHING. Maybe a purring computer churning out virtual numbers.

What is money anyway?

How has it come to this? Let’s first determine what money actually IS.

Through the ages, civilizations have come and gone. Because any civilization involves a group of human beings, that civilization, as a foundation, will have to have factors that bind those human beings, and that are recognized as binding factors.

In essence, these binding factors are the same for every human being. Needs like food and a roof over our head. In addition, creativity to meet these needs, expressed in labour. The same creativity allows people to maximize their labour capacity, which means more spare time and prosperity. In this kind of situation, people depend on and are loyal to each other.

However, because the needs and the creativity/skills can be different for everyone, a common trading tool is needed, in order to be able to match them. A trading tool, an expression of the common trust. A tool that enables everyone to take part in society. A trading tool that enables people to match their needs and skills. This trading tool (nowadays we simply call it money) that can also be seen as a reflection of the value of the fruits of our labour (bread, furniture, houses, etc.).

Like the value of our labour, the value of this trading tool can be seen as a constant. There is no lack of labour. So there is no lack of bread and housing. The conditions for stability are present, because the two factors, labour and goods, are under our control.

The logical consequence of this should be that the common trading tool, money, also has a constant value. This is just common sense. The common trading tool, money, is the lifeblood of society. This is called ‘Economy’.

Our leaders realized ages ago that the person who would be able to control this flow (through the banking system) and manipulate it (through inflation and interest rates) HAS ABSOLUTE POWER, due to the simple fact that individual people are unable to understand this system. As long as that remains the case, the position of our leaders remains unchallenged.

What have our leaders done with this power so far? They have waged wars. Financed revolutions, destroyed entire cultures, etc. As a result, there has been an increasing concentration of power over the centuries. Our leaders call this the ‘civilized world’, the ‘free world’ or the ‘international community’.

The flow of Money

Banks can be compared to a dam with sluices. The bank owners – all members of our power elite – are a kind of lockkeeper. They can decide to open the sluices a little more and create or let through money (inflation) or to close the sluices and reduce the flow of money (interest). Thanks to the power of these lockkeepers, communities that depend on these money flows can either drown (Weimar Germany in 1923) or suffer tremendous thirst (Great Depression, USA in the 1930s).

Of course, the powers that be realize full well that they have the power to create major earthquakes in the social fabric of the community or nation that is being affected, or to simply tear that fabric to shreds.

In 1923, Germany lost all its possessions at a monumental pace, because they were being snapped up by foreigners for next to nothing. Those who were lucky enough to still have jobs needed a wheelbarrow to collect their wages. The result was famine: 1.5 million people starved to death. Ultimately, this is how our leaders paved the way for one of their star actors: Adolf Hitler.

Recent example in Zimbabwe

This too is a war against their own population. People lose everything; famine is just a matter of time. On the official Dutch news broadcast of Friday August 3, 2007, a Zimbabwean citizen was interviewed. When the reporter asked him about the enormous price increases, he responded: “Normally, prices go up when a new banknote is introduced.”

There you have it! People see ‘inflation’ as a force of nature. This is impossible, because the money that is needed to create the price increases will have to be created. Shopkeepers don’t raise their prices for the sheer fun of it, but to try and make a living. The government of Zimbabwe made their lives impossible by setting the police on anyone who dared increase their prices even further. There shops were closed immediately. Result? The country’s shopkeepers were (deliberately) completely destroyed. As far as our leaders are concerned, the President of Zimbabwe is doing an outstanding job. He can do as he pleases. When our leaders decide to get rid of someone, they stage a coup or start a war.

With regard to the Great Depression in the United States (1929), increases in interest rates played a major part, in other words letting even more money evaporate (by limiting the loan market). When interest rates are high, more money has to be repaid than was originally borrowed. Where do we get that money? From each other! Initiatives in the form of investments are also stifled. The result is mass unemployment. Not a bad idea at all when, as we will see, a world war is being planned in the foreseeable future. There will be enough soldiers, as well as workers to manufacture the bombs and equipment needed to conduct the war. Everyone is so miserable that they are rearing to be productive. It will allow them to pay their rent.

As you can see, anything is possible, and it’s possible because we allow our money sluices to be controlled by people we don’t know, who haven’t been elected and who we are unable to control. All we see are the financial oracles that are presented to us in the mainstream media, promising us solutions to the problems they themselves have created deliberately. And when it becomes clear that they are responsible, they claim that they have simply made ‘an error of judgement’. That the markets have behaved in an ‘unpredictable’ way. They make it look as though they are doing everything they can to get the crisis under control.

These lockkeepers, who can do anything they want with our society, with our ‘permission’ (for we are living in a democracy), have now united themselves in a central system known as the European Central Bank. Even as nations we have now become powerless. Our Finance Ministers are now mere errant boys. The ‘Oracle’ resides in Frankfurt.

No Need for a Referendum!

Do you remember the introduction of the euro? People in many European countries hadn’t been consulted. There was no need for a referendum and now you know why. People who are planning a coup usually don’t hold a referendum beforehand. What we did get was a barrage of moronic commercials of singing and cheering clay figures. We should be overjoyed with the euro (the ultimate in power concentration).

Our leaders see us as a bunch of idiots from whom they can take everything away and that they can then send into battle. It should be clear by now where our politicians stand in all this.

The fact that education is unable to shed light on this is also a worrying sign. We have been warned repeatedly by renowned economists, in some cases hundreds of years ago. However, their books are being ignored by our educational institutions and are gathering dust in our libraries.

How exactly is money created? As a banker, you need an excuse. The reason behind the increase of money is the fact that our leaders have to meet targets. When money is created, investments go up and more people are working. One of the excuses to create money is something we see around us every day: rising house prices and second and third mortgages, combined with low interest rates.

The Collapsing Housing Market

Why have house prices raised so much in recent years? The answer is simple. In the 1980s, advances in ICT meant that housewives needed to be persuaded to take part in the economy, rather than staying at home. This meant that the average income per household increased tremendously.

As a result, demand on the housing market increased accordingly. In turn, this meant that the value of existing houses rose as well, and that additional value could be mortgaged. This way, Dutch banks managed to create billions of Euros, in some case up to 40 billion per year, out of nothing. People started spending the extra money (on cars, etc.). This was called ‘economic growth’. Who were the victims? Our families. Because people are now UNABLE to buy a house, thanks to the deliberately created increase in house prices. Thanks to the ‘government’.

And what does our lockkeeper have to say about this growth of money? On a regular basis, messages from the ECB indicate that the growth is twice as high as was originally anticipated. Without so much as batting an eye, it is announced that the growth of money is at 11.5% and inflation at 2.5%. At best, analysts will indicate that certain factors have been excluded from the calculation. ‘Whatever,’ we think, before we switch channels.

In August of 2008, the American housing crisis began. Banks had issued mortgages without checking whether or not clients would be able to pay them back! Do you believe that? Banks are ruled according to a military-style hierarchy.

Banks couldn’t care less whether or not people are able to pay back their mortgages. They own the houses and the houses aren’t going anywhere. They can pull the plug whenever they feel like it. After the 2008 crash in

How Money REALLY Works!

he US, the investigative committee concluded: “Supervision has failed.”

How is that possible? Banks who lend money to people borrow that money from other banks, which get it from the Federal Reserve, the only institute in the US licensed to make money. Officially, the Federal Reserve, like the ECB, created billions of virtual dollars to postpone the crash.

Thanks to the crash in the United States, the whole world is in an economic crisis since 2009. Companies complain that they can’t operate because banks won’t lend them money . Governments talk about cutbacks and in many countries more and more people are going hungry.

What is the real cause of the crisis? This credit crisis was caused by a shortage of money. On September 11, 2008 (like in 1929), the powers that be withdrew billions of dollars from circulation. That is what caused the international financial crisis, and nothing else.

Wake up! The people that have the power to create money with the stroke of a pen also have the power to make it disappear just as easily. Those who have created a period of ‘easy money’ can use the same instrument to create a period of ‘shortage’.

Inflation

How does inflation work? In everyday life, inflation is seen as an intangible natural phenomenon. Our leaders are happy to let us believe that.

Suppose you were as rich as Uncle Scrooge. You have a warehouse filled with money. When you start spending it, its value is determined by banks. When they decide to increase inflation, the value of your money drops.

The fact that the ‘Big Boss’ in Frankfurt decided what the exchange rate between the Dutch guilder and the euro was in 2001 makes one thing clear. Being dependent on money is not a good option. In the end, money will give you neither independence nor security.

The artificially maintained confusion consists of the following. Whenever wages and prices increase, it’s called inflation. However, this is the result of the amount of money being created – out of nothing – by the bank, in the form of loans and low interest rates. You could call this theft.

The world-famous economist John Maynard Keynes, in his book *The Economic Consequences of the Peace*, said the following:



“By a continuing process of inflation, governments can confiscate, secretly and unobserved, an important part of the wealth of their citizens. By this method they not only confiscate, but they confiscate arbitrarily; and, while the process impoverishes many, it actually enriches some.”

‘Some’ here means the higher servants of our politicians. Keynes also said:

“There is no subtler, no surer means of overturning the existing basis of society than to debauch the currency. The process engages all the hidden forces of economic law on the side of destruction, and does it in a manner which not one man in a million is able to diagnose.”

In the case of disasters, such as the one in Zimbabwe, inflation is a very threatening thing. It touches the core of our existence. Our leaders use that fear. Whenever the dumb masses observe the pay rises of the higher servants of our leaders and has the temerity to demand better conditions via trade unions, this is immediately discouraged and swept from the table in an arrogant gesture with the announcement that will lead to irresponsibly high levels of inflation and that it will overheat the economy.

“We need to know our place and take our responsibility!”... according to the higher servants. The Director of the ECB, Trichet – head of a picking order, formalized by the introduction of the euro – calls this the Second Round Effect. When workers demand better conditions during pay negotiations due to an increase in the cost of living, this causes inflation and threatens economic stability. Then the verdict is given: **“We will make sure that these ‘second round effects’ do not materialize.”**

Financieel Dagblad of December 27, 2007:

“Chance of interest rate cuts ECB smaller”.

A clear message to local politicians, trade unions and employers in the Euro zone. In other words, “do as we say or else you will be punished (interest rate increase).”

Inflation is an excellent way to prevent us from getting rich. If we do manage to negotiate a pay rise, we are immediately punished by higher inflation (higher rents, energy costs, etc.).

Interest

Aren’t our higher servants faced with inflation? There is a known cure for that: INTEREST. Interest is the protection of the fortunes of the rich. People like us always need to borrow when we want to invest or buy a house. The higher that interest rates are, the more limited our options will be. The higher servants don’t need to borrow. If they do, they do so via a special construction. The more money they have, the more numerous their options will be (tax havens or offshore accounts).

People say that interest rates go up whenever inflation does. If you were to take a close look at the actual numbers, provided they are even available, you would see that this relationship is a very tenuous one. Since the actual amount of money in circulation is only known to the banks, there is ample scope for manipulation. Needless to say, the interest-inflation model is a brilliant invention: “labour is the engine of our economy”. The concept of inflation has been linked to labour. Whatever you may have gathered today through hard work, may have lost most of its value tomorrow.

Capital, the result of OUR labour, is in essence a static phenomenon. Without labour, nothing happens; you might as well bury it underground. But that’s where interest comes in. Capital grows on its own - you could call it a form of parasitism. Of course, those who own capital don’t work - they have us to do that for them. They just direct the money to wherever labour is cheapest. Thanks to interest, their position is safe, generation after generation.

The higher interest rates are the fewer opportunities people have of determining their own future. Growing middle classes? Kids in university? That will only make them independent and less eager to serve our leaders. Interest rates (and inflation) will delay and stagnate this process .

In the New York Times of June 12, 1921, Thomas A. Edison said:

“Interest is the invention of Satan.”

Interest is the engine behind the growing gap between the rich and the poor. The higher that interest rates are, the faster that gap will widen. This is how, via the International Monetary Fund (IMF) and the World Bank, the Third World is looted: **“Pay the interest you owe us with your natural resources”**.

The purpose of poverty? It’s easy to keep poor people ignorant; poor people are defenceless; poor people only think of their next meal. Poverty (like war) serves an economic purpose.

What about us? We feel guilty and give ‘development aid’. Because we fail to pay attention to the real cause – the monetary system – development naturally is an item on the government’s agenda.

Aristotle had the following to say about interest in *Politica*: “Interest is money off money, which makes it the most unnatural form of property acquisition”.

Interest creates wealth for those who have and scarcity for those who don’t have. For our leaders, it is a means for creating scarcity through interest rate reductions and wealth and riches through interest rate increases (‘Roaring Twenties’).

Shady Accounting

Here’s an example of how our leaders really deal with money. On March 20, 2006, The Guardian ran the following story:

“IRAQ WAS AWASH IN CASH. WE PLAYED FOOTBALL WITH BRICKS OF \$100 BILLS.”

Iraq’s assets had been transferred to the Federal Reserve Bank in New York. In the first year of the American occupation, under interim governor Paul Bremer, a total of 363 metric tons of \$100 notes were transported by plane from Baghdad. These transports took place twice a week. The largest amount - \$2.401.600.000 – was transported on June 22, 2004. This was the largest shipment of cash money in the history of the Federal Reserve. The total amount was about twenty billion dollars.

This deal was arranged by a shady accounting firm, North Star Consultants, Inc. According to one of Paul Bremer’s assistants, Stuart Bowen, this company was run from a private residence in San Diego. But it gets even better!

“They reported that CPA’s entire accounting system consisted of just one contractor maintaining Excel spreadsheets. That’s one person for 20 billion.”

In 2003, after the invasion, UN sanctions were lifted. This released the \$20 billion. It may be clear that what happened here was a matter of malicious intent. It fits our leaders’ strategy to put the people of Iraq in a state of total economic and social chaos. This is proof of that!

In higher circles, people knew that this money existed. It could have been used to kick start the Iraqi economy and give the people water and electricity. But that was never the plan. That’s why the money was dropped at the airport by a couple of planes. The Waxman Committee never established who was responsible. Paul Bremer’s interim government, which had ordered the transports, even went so far as to carry out the biggest transport merely days before power was handed back

to the Iraqis. The final transport worth \$16 billion took place on June 25, 2004.

To prevent an orderly distribution, the money was simply ‘dumped’. Not in a bank account, but from a C-130 plane on an Iraqi airport. Nobody can claim the Iraqis didn’t get their money. Global accounting giant KPMG was ordered to carry out an investigation, which they only managed to do to a certain extent, due to unwillingness on the part of the interim government. The Waxman Committee also interviewed Mr. Bremer. The answer?

“The auditors presume that the Coalition could achieve a standard of budgetary transparency and execution which even peaceful Western nations would have trouble meeting within a year, especially in the midst of war.”

Mr. Bremer (former US ambassador in The Hague) refuses to take any responsibility. His statement contradicts the speed with which the transports were carried out. Had the situation been as chaotic as he claims it to have been, he should at least have taken preventive measures to put a stop to these things.

This story tells us something about the mentality of the people we are dealing with. They see money as a weapon! In this case, Iraq was stripped of its assets in a very effective way. This massive influx of money drove the country deeper into chaos. Two birds with one stone .

In our mind, the question “what is money” is on a par with the question: “Is the earth round or flat?” It has to do with a primary insight. How do we experience money? For our leaders, it’s simple. Money is a means to an end. You create it by the kilogram and get your chums to do the accounting .

You attach a note to a fishing rod as an incentive. We will do their bidding, our kids have to eat. It will never occur to us that there are strings attached, or that the incentive is used to manipulate us.

The direction into which we have been manipulated thus far isn’t very promising. A global empire has been built, there is famine, there is war, there are diseases, there is pollution, etc.

The powers that be use money to play us off against each other. They see the world as a global arena. To motivate us, they create fear, hate and insecurity via their media. At the same time, their economic system creates ‘scarcity’, wars, etc.

Our world leaders and bankers use gold (or its derivative, money) to get us to do their bidding.

Everyone has heard about a thing called gold rush. Thousands of men ploughed the American desert, looking for what exactly? A better life? Can you eat gold, or live in it? You can’t ‘do’ anything with it. You can use it to get other people to do things. And this has unpredictable consequences.

One man’s profit is another man’s downfall. Darwinist laws apply: “the right of the strongest”. And the strongest is always the one who owns the most. Nowadays, this is called ‘competition’ or ‘free market’. During this process, possessions automatically increase. Any gold that’s being dug up – via the monetary system – automatically ends up in a bank vault.

People who have struck gold immediately exchange it for the common trading tool: ‘paper money’. These notes are introduced via the banks into society by our leaders. They simply collect the gold.



This is also what happens in the Third World. Gold mines in South Africa and Brazil are mined by the local people, who ‘sell’ it to our leaders for paper notes, ‘dollars’. The gold is then stored in vaults in Switzerland, London, etc.

Some time ago, some South-African miners of the Kimberly diamante mines were interviewed. The mine was exhausted; there was a big hole in the ground. The men were unemployed and the diamonds had been moved to Antwerp and London. The men had no pension or other form of financial security. Their wealth had simply vanished! They told that they had a choice between a life of alcoholism or crime.

The paper money system does two things. It robs a country of its wealth and then it destroys the local economy and society.

The gold that has been secured by our leaders can use the paper money in circulation to wield its power. Via the dollar, its tentacles reach the furthest corners of the planet. The way to subjugate the planet is not through brute force, then, but through paper money.

The very thing that should unite us – our common trading tool ‘money’ – is being used against us. And as long as we allow ourselves to be used (because of fear, stupidity or lack of confidence), this process will continue. With horrible consequences for us all. This has been planned; this is an agenda that spans centuries.

Captain Morgan

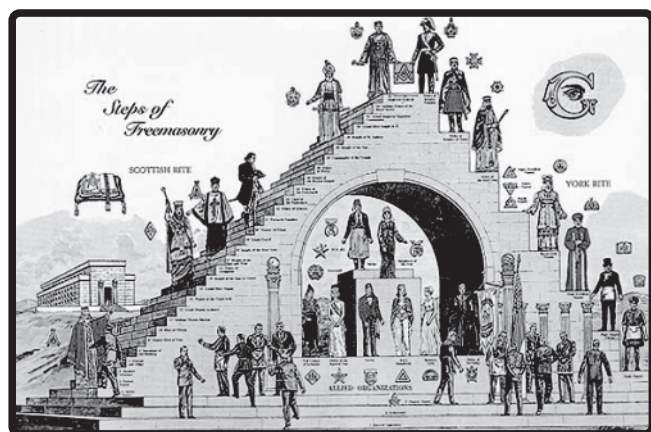
Throughout history the Masons have been subject to much controversy. You will all be familiar with Captain Morgan. Well his real name was William, and he was not a pirate (although it is believed he owned a brewery). In 1826, he started a movement against the Freemasons and threatened to publish a book exposing their secrets. He was kidnapped and subsequently disappeared. A brutalised body turned up some time later that was believed to be him. Following this, Thurlow Weed set up the first Anti-Masonic party. It ran a presidential candidate in 1828, but by 1835, was nearly defunct.

Many Hells Fire Clubs were organised by prominent Masons. It is claimed that these were like masonic orgies, much like the Kubrick film 'Eyes Wide Shut'.

Hierarchy

Freemasonry is divided into a hierarchical structure, in order to conceal knowledge. The first three degrees are as follows – *Entered Apprentice*, *Fellow Craft*, and *Master Mason*, all of which require the candidate to participate in an enacted drama and...

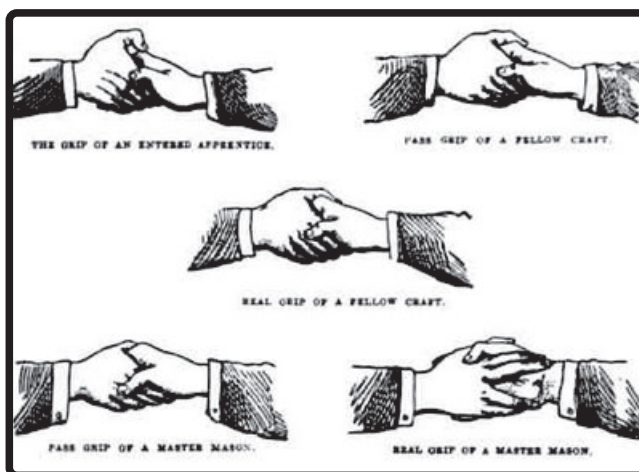
"are a system of initiation that allows men to become familiar with the august and ancient history and principles of Masonry at a comfortable pace. Proceeding from Entered Apprentice to Master Mason in the US can take as little as three months, while in England, the degrees are spaced apart by a year's interval."



After completing the three degrees of Symbolic or Craft Masonry, a Master Mason can proceed down one of two branches... **The Scottish Rite** or the **York Rite** [consisting of **Royal Arch Masons**, **Cryptic Masons**, and **Knights Templar**]. The Scottish Rite, the more popular, includes the degrees from the 4° and should be called additional degrees, rather than higher degrees. The Lodge has its own Constitution and is completely subject to its own jurisdiction.

Mystery

If it is merely political and economic control that the Masons are after, why is it that still after all this time there is so much mystery that still surrounds them? The **secret handshakes**, the **rituals**, the **symbols**. There is something below the surface, beyond the realm of financial gain.



The origins of the handshakes seem to be in the days of operative masonry, from when it was about concealing the secrets of their trade, so as to continue to have a monopoly of this information. The rituals however raise more questions than they answer....

Alice Bailey, whose husband Foster was a notable Freemason, claims that Freemasonry is the Babylonian Mystery Schools in their purest form. It should be no surprise to hear then that many Freemasons claim to trace their origins back to Nimrod, with the undertaking to build the infamous Tower of Babel. It was Nimrod, and then later also Nebuchadnezzar who first attempted to unify the world under the first World Order of the Babylonian Empire. It is from the Babylonian Empire that much of what we know today as the "mystery religions", the occult, etc appear to have originated and spread throughout the world.

In order to conceal knowledge, Albert Pike, what is known as the Masonic "Bible", *Morals and Dogma of the Ancient and Accepted Order of Freemasonry* states that lower level initiates are deliberately deceived in what they are involved in:

"Masonry, like all the Religions, all the Mysteries, Hermeticism and Alchemy, conceals its secrets from all except the Adepts and Sages, or the Elect, and uses false explanations and misinterpretations of its symbols to mislead those who deserve only to be misled ...""The Blue Degrees are but the outer court or portico of the Temple. Part of the symbols are displayed there to the Initiate, but he is intentionally misled by false interpretations. It is not intended that he shall understand them; but it is intended that he shall imagine he understands them. Their true explication is reserved for the Adepts, the Princes of Masonry." (pp. 104, 105 & 819)

That is to say, that most Freemasons have no idea as to what it is they are involved in. Pike's book is said to only be given to the Master Masons, however at some point it was leaked and has now become a matter of public record. It is estimated that for every hundred Masons, ten will read it, three will finish it and only one will understand it. Concealing knowledge is a tactic that is currently being practised by the New World Order in attempting to achieve their goals, most notable through the Rothschild's and Rockefeller's owning the vast majority of media outlets such as Reuter's and Associated Press, Fox

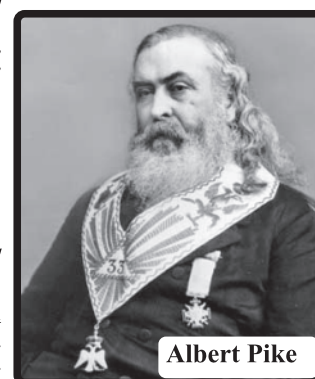


News, News of the World, BBC, and the editors of major news outlets attending Bilderberg and Trilateral Commission meetings and promising not to report of any of the proceeding.

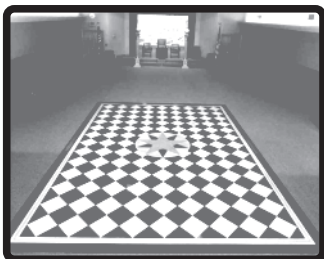
Black and White Floor

The 33rd Degree Eagle



The double headed eagle alludes to the nature of man. The head that looks to the east is symbolic of man's spiritual vision and the head that looks west refers to his material visions' (James 1:8 – a double minded man is unstable in all his ways).

This divine eagle with two heads facing away from each other is linked into the meaning of the black and white floor in all masonic lodges.

The All-Seeing Eye

This symbol is used with minor variations – in Nazism, on dollar bills, New Age, the Orange Order and in many occult orders.

The All-Seeing Eye is the emblem of Osiris the Creator, whose 'power was symbolised by an eye over a Sceptre. The Sun was termed by the Greeks the Eye of Jupiter, and the Eye of the world; and his (Osiris)' is the All-Seeing Eye in our lodges.' – Albert Pike, *Morals & Dogma*: pages 15-16



Sometimes this symbol is known as 'The Eye of Horus'. In mythology, Horus was born out of the incestuous relationship between Osiris and his sister Isis. As the Babylonian Empire spread South, the so-called Gods of Babylon, Nimrod, Semiramis & Tammuz became known as Horus, Osiris & Isis. The Eye of Horus is the eye of Nimrod, who ruled from a pyramid overlooking Babylon, he claimed to be watching over the whole empire.

What is The Connection with the New World Order?

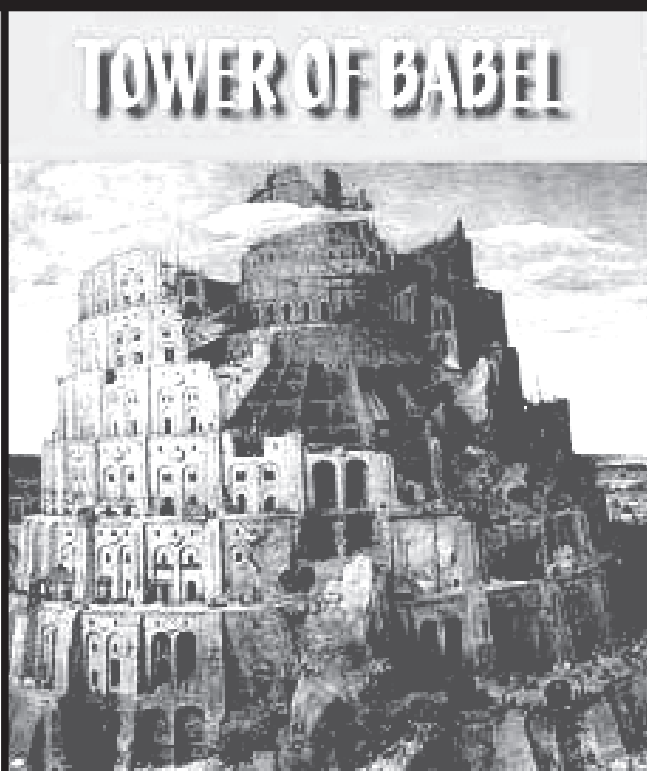
This is all religion you might say, what does it have to do with the New World Order? Personally, it brings to mind the words of David Spangler, Director of Planetary Initiative, United Nations –

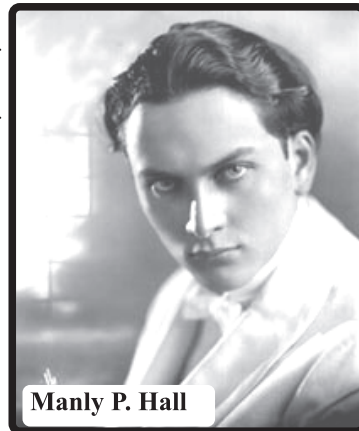
The tower of Babel was the beginning of the first World Empire, it is said that to stop this, God confounded the tongues of the masons and they spread abroad the Earth. Since then it seems their descendants have been trying to unify the world as one Empire again, so it can be ruled by one man. Many tongues, One Voice, One World Order.



So it will be a consensus, and a universal one at that, to accept this New World Order. Some would maintain that the concept of universality is in fact something that should be aimed for, something that is good, ultimately with it comes the loss of individuality, both personally and nationally, therefore the loss of national boundaries, sovereignty, identity, and heritage. It is the erosion of these things that will bring about the concept of being citizens of Earth and lead us towards a One World Government, i.e. the further consolidation of power into the hands of the few.

Hall himself writes:

The age of boundaries is closing, and we are approaching a nobler era when nations shall be no more; when the lines of race and caste shall be wiped out; when the whole earth shall be under one order; one government, one administrative body." -Manly P Hall "Lectures on Ancient Philosophy," published by the Philosophical Research Society Inc, Los Angeles (1970)

This concept of the elect to rule the Earth is nothing new, and was laid out in Plato's Republic around 350BC. It was also Plato that first wrote of Atlantis, and it is still unknown as to whether this was an allegorical or literal place. However, we are at a point in time where this world order seems more possible than ever. The world seems smaller than it ever has, and with the failure of national governments and banking systems most people are crying out for something better. It should be the idea of this New Atlantis that is most startling! While again this is not a new idea – Francis Bacon heralded America to be the New Atlantis and looked at how that has turned out! 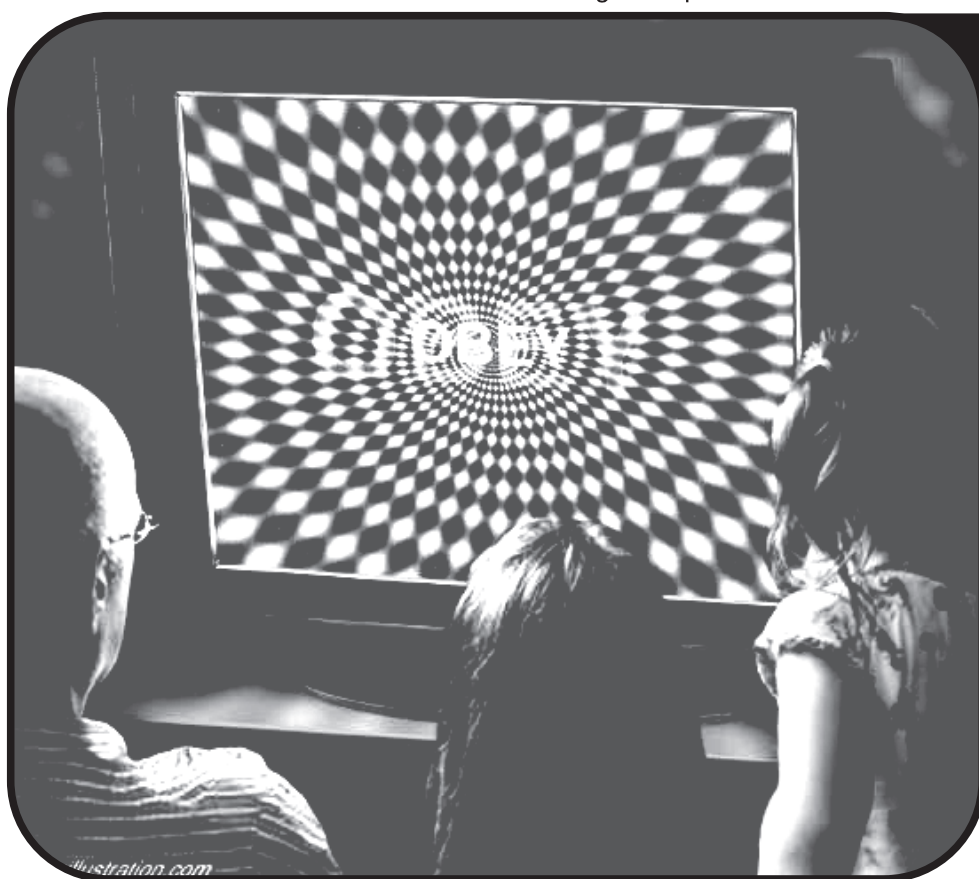
Freemasonry on one vehicle of the New World Order

Some years ago, while living in London, I passed through the Russel Square area of the city one evening. It was dark and my route took me past one of the university halls of residence that made up a good portion of the buildings in this particular locale. The lights were on, there were no blinds to obscure the activity of the students inside. It was a large old building with many rooms and on each floor there seemed to be about three or four common rooms where students would gather to socialise. Every single one of the common rooms, about twelve in all, had that tell-tale eerie cold blue glow of the television set. The TV's were placed high up in the corner of each room, dominating the space and commanding the attention of every head I could see silhouetted in the windows. What struck me at the time was the fact that all the TV's were tuned into the same channel. "Brainwashing," I said to myself "that's what's going on here". I already believed at the time that TV was a force for [sub] cultural indoctrination and social engineering but the sight I saw that evening was a uniquely graphic illustration of just how pervasive and captivating TV can be.

Little did I know at the time though how true that sentiment is, both in terms of the physical and mental effect TV has on the human brain. Not only is TV a threat to intellectual development if placed in the wrong hands, even in so called "safe hands" TV provides no mental, physical or spiritual advantage... in fact quite the opposite is true. Now, I'm not adverse to information or entertainment in the visual sphere - its a very useful medium, but if one wants to view or transmit information or entertainment it is best delivered by a projection system onto a screen or wall as opposed to directly beamed into the eye from a TV screen. I'll explain why in a moment.

Certainly I think most right thinking people are agreed that physical effects aside, the content of the majority of TV programming today (I emphasise the word programming, a process that involves a passive receptor of information) is designed to instil a social worldview and value system that is self-centric and is in fact the opposite of what a healthy and enduring society requires. Individualism at any cost rules the day and it is more and more evident that empathy for one's fellow citizen and a sense of personal responsibility are rapidly vanishing along with the morality that all healthy civilisations have known to be necessary for survival.

No Higher Authority

Only recently a car I was travelling in was bumped from behind by a driver who was, I would guess, in his mid to late thirties, looked quite respectable and drove a new and expensive car. Rather than stop and offer his details for the damage done he feigned an apology and when our vehicle pulled off to park safely he took his opportunity to flee the scene, no doubt congratulating himself on avoiding a messy process involving insurance agencies etc. People today are only made to feel guilt when caught and exposed for their crimes. They have no higher authority to fear and the current direction of societal attitudes puts paid to that particular view often espoused that it is possible to remain moral and upstanding without religion or a guiding moral principal if you prefer. The crime figures, road rage and general attitude of fellow citizens would tend to indicate otherwise. I believe TV has much blame to shoulder for this.

People spend a lot of their spare time in front of the television. I don't think it's an exaggeration to state that TV is a major source of many people's opinions and views on pretty much everything. Given the amount of time people spend watching television it makes perfect sense that if you want to shape public opinion the TV is the medium par excellence by which to disseminate your information. It stands to reason then that if you agree that a movement exists, and I think a lot of people do, whose aim is to re-make the world in man's image, albeit a skewed and perverse one, then it makes sense for such an organisation to consolidate control of the TV airwaves and turn it into a propaganda video-drome.

Anti-Christian Sentiments

Some might say that the proof is in the pudding, that TV is so biased toward the crude, libertine, amoral lifestyle and that the portrayal of the Christian religion, the very force that created our society, is so negative, misinformed and hostile that surely such a conspiracy exists. Now to extrapolate this thought is an article unto itself but the facts are there and the conspiracy is out in the open. To give just two examples, we have the admission by the BBC following a leaking of an internal memo wherein it was admitted that they are anti-Christ in their outlook. After complaints that BBC programming repeatedly errs on the side of sensitivity to Islam & other minorities (religious or otherwise) & bias against Christianity (especially Roman Catholicism), the British Broadcasting Corporation has admitted its guilt. A summit meeting of BBC officials culminated in admissions that "the BBC is not impartial or neutral," as BBC political editor Andrew Marr put it. The closed-door summit's conclusions were leaked to the British newspaper The Mail on Sunday.

Government Control

Evidence also exists that governments control news output and content. On January 14, 1983 President Reagan of the USA signed into effect directive 77 which gave the CIA and government full power to determine and control the content of news that the American public receives, news which can now be uploaded and or modified in minutes with modern technology. Goebbels would be proud. Think about it. It only takes a decision made by one chief editor to determine the news received by millions and in the US it is said that upwards of 90% of all media formats including newspapers and magazines are controlled by 3 or 4 corporations, a number which is going down as more and more news agencies are bought up and amalgamated. All an agency has to do to make sure the news delivered suits a particular agenda is to put a very small number of people into the right positions.

The way TV affects the Brain

The physical way in which TV affects the brain makes it a perfect vehicle for propaganda. It's important to note that your eyes grow directly, stem-like, from the brain. They really are the window to the soul and the perfect conduit to access the brain's inner sanctums.

The human brain works at 4 basic frequencies. These are Beta, Alpha, Theta and Delta.

Beta waves are produced when one is thinking and using one's higher faculties and Delta is associated with sleep and/or deep trance like states. The radiant light and flicker rates of TV cause the brain to drop down to a level of activity somewhere between Alpha and Theta - essentially a sleepy dreamlike state of mind where the higher critical functions are turned off. Even if you're reading text on a television screen the brain registers

low levels of Alpha wave activity. Theta brainwaves engage inner and intuitive subconscious. You will find theta in places where you hold memories, sensations and emotions. Any information therefore imbibed from the TV by-passes our logical, critically thinking sieve and goes straight into those sub areas of the mind associated with more emotive response. TV then appeals more to the emotions than the mind and of course how many of us engage in lively informed debate anymore? Very few. The more common reaction to big questions is usually an emotive response followed by a quick change in subject. TV viewing is a somatic experience which means it is "of the body, not of the mind". I'm reminded of Huxley's book, "Brave New World" where the drug of choice was called *soma* and enabled people to escape un-palatable intellectual life problems.

Psychologist Thomas Mulholland found that after just 30 seconds of watching television the brain begins to produce alpha waves, which indicates torpid (almost comatose) rates of activity. Alpha brain waves are associated with unfocused, overly receptive states of consciousness. A high occurrence of alpha wave activity does not occur normally when the eyes are open. In fact, Mulholland's research implies that watching television is neurologically analogous to staring at a blank wall. It's worth noting that the goal of hypnotists is to induce slow brain wave states. Alpha waves are present during the 'light hypnotic' state used by hypnotherapists for suggestion therapy.

The critical side of your brain is the left. As you read this you are making judgements, passing opinions and coming to conclusions which take the form of beta brain wave activity. These are the waves activated when you begin to use that left hand side, the centre of logical human communication and analysis.

Researchers have found that once the television set is switched on, that left hand side and all its faculties tends to switch off. Instead the image from television go straight to the right brain. The switch from beta to alpha waves shows this. Alpha brain waves are the ones we associate with meditation and sleep. By no means does this mean that we are not taking the information in - we are taking it all in, we are just not able to critically evaluate it as we would with information coming from other sources.

Video Games too!

Video Games have been shown to lower brain activity to below that of the Delta frequency!

The TV screen flicker rate alone is known to induce mesmerized states in people. This flicker rate is the rate at which the screen image is updated, generally about 50 or 60 times a second. DARPA is a US military funded research programme. One of their endeavours concerned developing TV flicker rates that could be played whenever a mesmerized state was required in a given section of the population.

Endorphins are released by overexposure to light. The radiant light from televisions causes a release of endorphins. Researcher Herbert Krugman showed that while viewers are watching television, the right hemisphere is twice as active as the left, a neurological anomaly. The crossover from left to right releases a surge of the body's natural opiates: endorphins, which include beta-endorphins and enkephalins. Endorphins are structurally identical to opium and its derivatives (morphine, codeine, heroin, etc.). Activities that release endorphins (also called opioid peptides) are usually habit-forming (we rarely call them addictive). These include cracking knuckles and strenuous exercise. External opiates act on the same receptor sites (opioid receptors) as endorphins, so there is little difference between the two.

Empirical Evidence

Even casual television viewers experience such opiate-withdrawal symptoms if they stop watching TV for a prolonged period of time. An article from South Africa's Eastern Province Herald (October 1975) described two experiments in which people from various socio-economic milieus were asked to stop watching television. In one experiment, several families volunteered to turn off their TV's for just one month. The poorest family gave in after one week, and the others suffered from depression, saying they felt as though they had "lost a friend." In the other experiment, 182 West Germans agreed to kick their television viewing habit for a year, with the added bonus of payment. None could resist the urge longer than six months, and over time all of the participants showed the symptoms of opiate-withdrawal: increased anxiety, frustration, and depression.

Herbert Krugman's research proved that watching television numbs the left brain and leaves the right brain to perform all cognitive duties. This has some harrowing implications for the effects of television on brain development and health. For one, the left hemisphere is the critical region for organizing, analyzing, and judging incoming data. The right brain treats incoming data uncritically, and it does not decode or divide information into its component parts.

Researches into the effects of TV have warned that children under two years of age shouldn't watch any at all due to the negative impact on various areas of a child's development which include skills of observation, speech, hearing, depth perception, reading ability, inducing attention deficit type behaviour, a lack of motor skills due to immobile viewing habits and so on. TV is a wholly inappropriate and ineffectual teaching tool. It's pointless having debates lamenting the demise of intellectual ability and endeavour when intellects have never even had a chance to naturally and properly grow due to the numbing effects of television on children particularly.

Reading and Radio have Positive effect on Brain

Conversely its worth noting that radio has the opposite effect and actually develops a higher rate of concentration, the audio forcing people to be stimulated to visualise what they hear. Reading of course further extends the ability to concentrate and critically examine information over longer periods.

Even the style of TV production these days is geared toward an amphetamine-like addiction people have with regard to information reception. The cadence of scene changes, that is the rate and beat at which images are changing on the screen is very fast and further inclines the mind under development to be unable to concentrate for long periods on long pieces of textual information. Average rates of attention span are down from a few decades ago to mere minutes where once it was more than one hour for deep critical thinking.

Studies have linked quality of life to high vocabulary rates which heavy TV consumption impacts negatively. If you have good communication skills you are better able to express the world you live in and how you define it and if this is a yardstick to judge by then for many of our countries' young folk the world must be very banal indeed. A poor vocabulary means you have a myopic existence, you have a tunnel-like perception of this great planet and your quality of life is adversely effected. Just listening to pop stars in particular, the idols of the young, can make one cringe with embarrassment at the vacuous and inarticulate clap-trap they come out with.

We live in a world today where people's personalities are formed by unreal things: TV, the music industry, video games, movies, the effects of drugs (be that of the recreational or psychotropic variety). Virtual reality dominates the interests of a lot of people out there, even young adults and people of my own age group in their 30's. All conversation is about this or that TV show, the latest new video game on the latest new console or who's top of the Premiership. It's a sad state of affairs.

All Part of the New World Order.

All these negative effects on society are known, they are in fact engineered and planned for. A New World Order is coming into view. Not so long ago in India, the then British Chancellor Gordon Brown, in a speech mentioned this "New Global Order" that is being brought into existence. This New Order will be the stuff of nightmare as envisaged by Orwell. In fact I don't think even Orwell had the vision to picture the dystopian technocratic dictatorship in store for humanity. Huxley was somewhat closer to the mark in his novel, "Brave New World".

The TV is our soma, it keeps us mesmerized and dulled while our freedoms are revoked and laws introduced to make criminals of us all so the New World Order can get on with the business of creating a prison planet with a prison based economic system, much like modern China.

Get rid of your TV's today. Exchange them for projection systems if you're not yet ready to give up the video drome. We need to reclaim our personalities from the agencies and organisations that use TV to claim our minds, create our consumerist loyalties and keep us from truth, reality and a full-spectrum human life. We need to reclaim for ourselves and instil in future generations a sense of wonder at the real world and its panoply of real life heroes and people genuinely worth admiring.

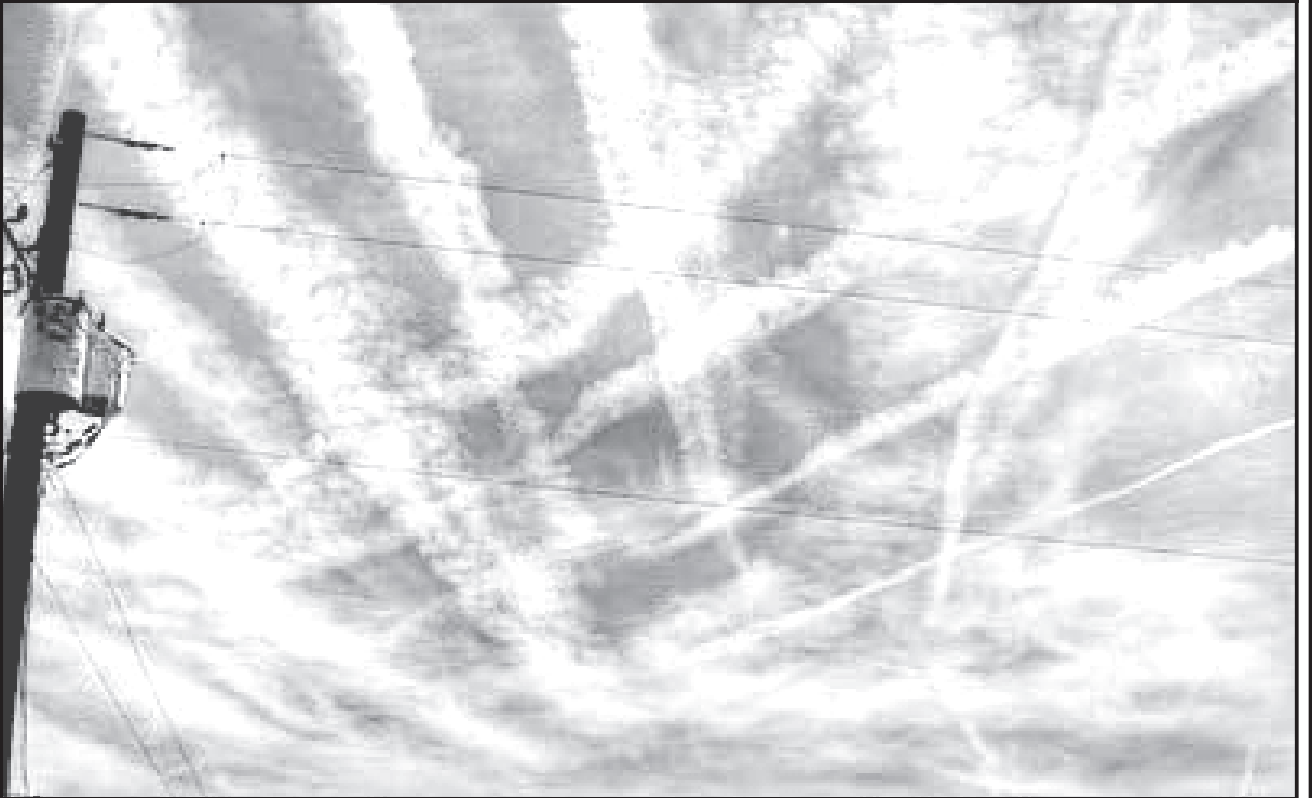

Eventually relocating to his native Donegal, it wasn't long before he got restless again and formed another 2-piece (this time playing keyboards) with Ballindrait man Pat McGinty on vocals & guitar. The pair, calling themselves Double Trouble, gigged in many NW pubs in Donegal, Derry & Tyrone.

Since returning to Ireland, he has also had numerous opportunities to pursue his life-long interest in acting. Starting first as a non-speaking extra in 2 separate films about Bloody Sunday, he has participated in many local drama productions from the pens of playwrights Irene Melaugh, Stan McGowan, John Craig, James Woods & Mary Connors. These shows were performed in local venues, including the Millenium Forum & An Grianan, often to standing ovations. He has appeared in the title role of Jim McClenaghan & Carl Campbell's award-winning debut play "Dealing With Dougie" in the Waterside Theatre. Always a man with a BIG show in mind, some of his proudest stage moments have been with Buncrana-based Greasepaint Productions offerings of "Oliver!", "The Sound Of The Musicals" & "The Wizard Of Oz", under the direction of Donall Henderson.

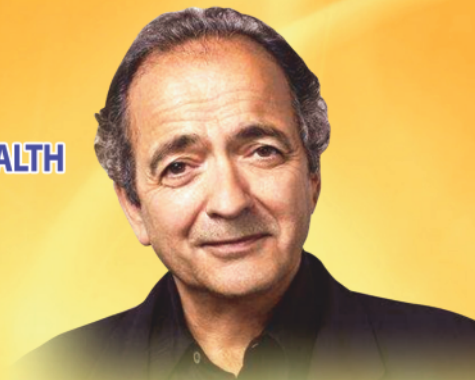
